Lancelot Bland and Richard Bland leased portions of Lots 17, 18 and 21 of Bailey's Barony as shown on Dr. Mosse's 1783 Survey. When Richard married Elizabeth Fenden in March 1769 he placed 1600 pounds currency and six slaves in trust for Elizabeth with John Cheney and Benjamin Parmenter as Trustees. Richard sold 600 acre Grass Lawn Plantation to William Pope, Sr. who willed it to his son, Richard R. Pope. Richard Bland's will was proved on 10 May 1776. Lancelot Bland's will of 15 December 1777 left 2/3 of his estate to Elizabeth Read, daughter of his brother George Bland, and the remainder to his brother Richard's two children, Richard and Elizabeth Bland.

Richard Bland was summoned for non-payment of rent in 1810; no further information. In 1828 he placed property in trust to guarantee payment of rent on a house in Augusta. The description of his estate (see note for Claudia Bland below) shows he owned land in SC, but not in GA.

And to the said Demetrius A. has been assigned and set off four negro slaves, Philis, Sarah, James, and Margaret, valued at one thousand and fifty dollars and he is to pay to the said Claudia A. the sum of fifty dollars.

To the said Claudia A. and Demetrius A. as tenants in Common is assigned and set off all the household and kitchen fur niture valued at fifty dollars and to the said Caroline R. M. and said Charles Theodore as tenants in Common is assigned and set off a negro slave named Venus, valued at fifty dollars.

And the parties severally covenant and agree with each other to stand to and abide by the division of the said property as above mentioned, and to pay such sums of money to the said Claudia A. as is herein before required.

And the said parties respectively release any and all manner of right, title, claim and demand in and to any of the property before mentioned except that portion assigned and set off to them respectively. And the said parties respectively do hereby release and discharge each other from all manner of causes of action, growing out of, relat ing to or connected with the said property, or any part thereof, on the estate of the said Richard Bland before the date of these presents. And the said parties further covenant and agree with each other respectively that the Tract of Land in Beaufort District, South Carolina shall be sold by some agent hereafter to be appointed by them, and the proceeds divided equally among the parties.

Shreveport newspaper - "From our Files 70 years ago"

May 30, 1896 -- The franchise, roadbed, cars, and entire equipment of the Electric Belt Line Street Railway will be sold at sheriff's sale a week from today. The sale is made to pay judgment of \$2,500 against the company for an accident that caused the death of Charlie Bland.

Charles Bland, a streetcar electrician and lineman, was killed on the job in 1895. His parents, D. A. Bland and wife, sued the company, Shreveport Belt Railway Company, for negligence. There were apparently two court appearances: in the first a judge found Charles negligent; in the second a jury found the company negligent. The company appealed the jury decision; the Louisiana Supreme Court ruled for the plaintiffs on June 6, 1896. No. 12178 Supreme Court of the State of Louisiana D. A. Bland and wife vs. Shreveport Belt Railway Co. The documents from both court appearances and the Supreme Court decision are available at the Caddo Parish Court House in Shreveport, LA.

The court decision describes the events in detail. Here is an excerpt.

"The superintendent also offered to climb the pole and himself do the work required. The lineman being more active and nimble went up after the soundness of the pole had been tested. Reaching the point at which the guy-wire was attached to the pole he clipped the wire with his pliers; immediately after the pole commenced to give way with the young man and fell on him. He died about seven hours afterward, from the effects of the fall."

Dr. Charles Alberto Bland was born in Charlotte on March 18, 1872. His father, Dr. Mortimer Alberto Bland, was a prominent citizen of the town. His mother was Jane Hammond, a native of Anson County. Charles A. Bland

attended the schools of Captain Barrier and Professor Carter in Charlotte and then enrolled at the Pantops Academy near Charlottesville, Virginia and also the Citadel in Charleston. He graduated from the Baltimore College of Dental Surgery in 1892 (his father's alma mater) and went on to do postgraduate work at the Haskell school in Chicago. According to city directories, Charles Bland was living in Charlotte at the Central Hotel in 1891-92 and by 1893 was in partnership with his father at their dental office at 21 N. Tryon Street. The partnership lasted until about 1908 when Charles left the practice, possibly because of his increasing political and business activities. In 1907 he was elected to the Board of Alderman, and in 1908 or 1909 he became president of the Elizabeth Realty Company.

Charles must have known Lucy McAden well when he was growing up, since she was born in Charlotte on September 16, 1874 and was also educated in Charlotte and in Baltimore. At any rate, Charles gave Lucy a ring four or five years before their marriage on June 12, 1901. The wedding was held in First Presbyterian Church where Lucy had been baptized. It was a lavish social occasion and made the front page of the Charlotte News: "the high social position of this couple making this marriage one in which society throughout the state is interested."

The Bland-McAden House possesses local historical significance as a well-preserved example of the rapid growth of Charlotte's suburban neighborhoods after 1920. This new trend of settlement arose in response to Charlotte's emerging role as a leading commercial, industrial, and banking center during the late nineteenth and early twentieth centuries. The Bland-McAden House was erected near the southern end of Charlotte's prestigious Myers Park neighborhood between 1920 and 1922. During this period many of Charlotte's elite and middle class citizens were lured out of the center city to the suburban countryside.

The Bland-McAden House also possesses local historical significance for its association with Dr. Charles Alberto Bland (1872-1947), and his wife, Lucy McAden Bland (1874-1929). Charles Bland was a prominent figure in early twentieth century Charlotte and mayor of the city from 1911 to 1915. He had a long association with Charlotte, influencing its growth and development through his civic roles as member of the Board of Health, Board of Aldermen, mayor, second vice president of the Chamber of Commerce, and businessman. He affected the growth of suburbs in Charlotte as an official of the Elizabeth Realty Company and had a significant impact upon industrial development in the community through his involvement with the Elba Manufacturing Company. Finally, Dr. Bland influenced commercial development through his association with the People's Bank and Trust Company. Lucy McAden Bland was the youngest daughter of Rufus Yancey McAden, an important politician and businessman from the region, best remembered as the owner of the town and mills of McAdenville in neighboring Gaston County, North Carolina.
