Dear Dr. Peeples:

As a descendant of Jean Girardeau, through his youngest son, Isaac, I, also, am a member of the Huguenot Society of South Carolina. Recently, while rereading my copy of TRANSACTIONS #83 for 1978, I came across a reference on p. 64, under "The Memoirs of Benjamin Spicer Stafford," Chapter II, that was of particular interest to me.

The name "James Sweat" was the one given by my Greatgreat-grandfather, Thomas Eden, and his wife, Honora, to their first son (fourth child). Please see Exhibits A and B. When I saw that name, I realized that "James" was not a family name, but was pobably, that of their pastor, the Rev. James Sweat (1764-1823).

Since 1980, I have searched for The parents of Thomas Eden. The Baptist Church microfilm in Beaufort had nothing. The same was true of the S.C. State Archives in Columbia, the Georgia St. Archives in Atlanta, County Court records in Charleston, and our Bay Area Calif. State and Mormon Genealogical Libraries.

But, the newspaper microfilm file of the Ga. Historical Society in Savannah had many references to Thomas Eden. (Exhibit C is from there). However, there was nothing to indicate the identity of his parents. The Census Records for 1800 and 1810, (The only thing not destroyed by the Union Occupation Forces in Beaufort) indicate that Thomas Eden and a Mary Eden were heads of household and slaveholders at that time. It is only a guess that one of them may have been his parent (my ancestor's).

Actually, I think Mary the most likely, since my ancestor seemed intent on perpetuating that name.

You certainly must be an expert on the history of the Beaufort District. For that reason, I hope that you may be able to suggest someplace where I may look for an answer to my problem. If you. by some fortunate circumstance, should happen to possess any pertinent material which you might be willing to duplicate for me. I should be very happy to pay whatever charges there may be .







## Stranger In A Strange Land

From Beaufort, South Carolina, To Galveston Island, Republic of Texas

the life of James Pope Cole (1814-1886) is chronicled against his family's origin in the seaislands of South Carolina and his academic preparation at South Carolina College for a legal career in Galveston, Republic of Texas.

In 1839 he arrived on Galveston Island and was granted permission to practice in all the

By 1842, however, the increasing threat of a Mexican invasion caused the young lawyer to become a founding member of the "Galveston Fusiliers," 2nd Battalion, 4th Regiment, Texas Militia. Cole wrote the Constitution for the Company and rose to the rank of "Captain." The "Minutes" of this Company are copied

Judge J. P. Cole's legal career in Galveston (from his arrival in 1839 until his death in 1886) is well-documented by the historian Charles W. Hayes in his book, Galveston: History of the Island and the City, which is the basis for the chapter, "A Season of Leadership."

Letters from Judge Cole to Gail Borden, Jr., whom Cole succeeded as Secretary of the City Company, add another valuable facet to the biographical study of Judge Cole.

The "Minutes" for First Baptist Church, Galveston, written by Judge Cole for nearly a quarter of a century, including his "Monograph" detailing the split in the church which caused a majority of the active members to leave the church, reveal a further dimension of his character.

"A Season of Parting" is devoted entirely to quoted letters to Judge Cole from various family members and his letters to them which chronicle the final days of his wife Mary Jane Graham Cole.

The book's content clearly illustrates the contribution that a single individual made to the Republic of Texas, to his community, and to his church, thus widening the readership beyond Judge Cole's descendents and the circle of those persons interested in the early days of Galveston.

A quotation from Milton's Paradise Lost, a book mentioned by Judge Cole as reading to his daughter Susan Jane, is perhaps an appropriate summation of his biography:

"Servant of God, well done!
Well hast thou fought
the better fight"
