Dear Robert

Your letter of 24 July was a delight. Thank you. I do not think I ever saw so much interesting information on a single sheet.

(At least, I used to have a boss who made everything he wrote or typed ridiculously small: but that was cheating and also it made the text illegible. Besides, he was the finance director so it wasn't that interesting even after you'd worked out what it was)

I will take a long time to work through everything you tell me and to tie it in to everything I think I know, but already I have noted some of my reactions as I worked through your letter. As you mention somewhere, nicknames are endemic and endearing (I trust) for loved ones. But they do make it hard one or two centuries later to figure just who was who. As you probably realise, my starting point for most of my South Carolina data is my grandfather's article on The Brisbanes published in 1913. But there are a great many related names all over the place, and I am not at all sure I always guestimate correctly where I have a nickname for someone I already have under another name and where I have identified someone new.

Anyway, you have certainly enhanced my information on my Brisbane ancestors as well as on the links to the Lawtons and allied clans. I am not sure I can tell you as much that will be new to you, since presumably you will already have sighted my grand father's researches. I will enclose a little ancestry on myself back to my Brisbane great grand mother. This may appear egocentric, but I often find myself wondering what happened to the descendants of people long dead whom I nonetheless feel I have gotten to know quite well. If you have the same curiosity, then the attached may address a little of it. Incidentally Eduardo Haviland Hillman (EHH) had only one child – I sometimes suspect the event came as a surprise to him. His only son also only had one son, who is writing this letter. I have three children aged 7, 4 and 2 (Robert, Alexandra and Michael born respectively in Holland, Germany and Germany) but it is too soon to know whether that will 'secure the succession' for the longer term.

Self evidently if this is outside your own scope or interest, you are more than welcome to trash it unread. I simply feel that you gave me a good deal of new information or confirmation and I figured a quid pro quo might be in order. I may also venture below a couple of supplementary questions to your own letter, so you see I am motivated to try and provide you with interesting information in return. Also self evidently, if you do take the opportunity to look through my data attached, and if you notice anything that differs from your own information, I would be >grateful to know of it.

As I think you realise, I am only a first half cousin to WHB (four times removed if the computer is to be believed. I am of the generation that forgot how to count using fingers: my children, of course, will probably never have to learn that method in the first place).

The common ancestor is the James Brisbane who was banished for backing (or at least, refusing to fight against) the wrong side in the war with the British.

WHB descends from his third wife Margaret? and Adam Fowler Brisbane 1783 - 1830 who is in some quarters recorded as having been born in Charles Town despite his father having been banished, which I find slightly implausible.

Do you know if that birth location has ever been confirmed to primary sources, or was it simply an assumption by someone at some stage?

I descend from his second wife whom I have always known as Sally Stanyarne, via John Stanyarne Brisbane 1773-1850 (dates approximate)

Thanks for correcting me on Anna Cordelia Brisbane. I had wondered. My source for Cornelia was, of course, EHH: but it is not a name I have come across in any other context whereas Cordelia is a character and a catalyst in King Lear, one of the Shakespeare plays that I studied at school but for which I nonetheless retain affection. I used to think Cordelia was one of the good guys, but these days I'm not quite so sure. I guess this is because Shakespeare was a genius.

You mention Esther Mosse McKenzie, being one of Dr Mosse's seven daughters. My information is a little vague on this branch. Is this Dr George Mosse ?1742 – 1808 born in Ireland? And does that mean that Esther's mother was Dorothy Phoebe Norton 1751 – 1808?

I also noticed (or rather my computer bleeped at me) that if Joseph Thomas Robert was born in 1807, the son of Phoche Miranda McKenzie 1797—1854, then Mum was only ten-when she gave birth.—Not-impossible, of course, but it did raise a '?'. (Don't bother to take an age researching this one on my account: but it's possible you already had the same thought many years ago and came to some conclusions at that time, in which case I'd be interested to know what the conclusions were.) It mother was James John Robert's first wife Charlette Conclusions were.)

I am entertained by your comments on the Baptist faith of those folks in Lawtonville, though I am not sure I necessarily follow every nuance of your thoughts. I think one of my Brisbane ancestors was lauded for founding a new Baptist congregation, though reading between the lines it looks as if the former congregation simply had a fight and one faction split out. I guess that sort of thing happens wherever you have people who feel strongly about matters, though whether the origins of fight in question were theological or to do with material goods and human pride ... well, doubtless it was a little of each. I suspect you know much more of these matters than I do, but I have the feeling that in England the Baptists flourished in the new conurbations in those early days of accelerating commercial growth that fed the energy (and the population explosion) that triggered much industrial development and much emigration, and when the industrial towns here started to mushroom. The state church (our answer to your Anglicans, of course) retained a preference for its traditional heartland in the well fed country shires (a bit of a cliché, but many clichés are based on true observation!).

Then as now, I rather fancy that most people tended to inherit the denomination of their parents and not to spend too much time agonizing over theological anomalies. I think that in the US people probably think about these matters more intensively (and possibly more precisely – though here I am less confident) than here in England; but certainly here the Church of England prides itself on being a broad church, to the extent that committed deep thinkers periodically trigger a 'shock horror reaction' in our ghastly 'yellow press', based on allegations along the line that this or that bishop no longer believes in God or some perceived fundamental tenet of The Faith.

If Captain William Lawton who parachuted in from the outer ether in 1730 has not been identified in the old country by well paid professionals, I am unlikely to fare better. However, if you do have any clues as to where he came from (England or Scotland? Or Wales?! And which region or county?), I can keep an eye open. For England and Wales the records are centralised from 1837, but before that you really need to know where to look before having any hope of finding what you seek. Back to about 1700 the parish records are generally pretty complete and legible, but before that even if you look in the right place it becomes increasingly likely that the baptismal records will have been lost (even assuming you can read them). For Scotland, a lot of

data is now available 'on-line' although many of my Scots ancestors (mother's side: not so interesting to you, I think.) concerning whom I am confident as a result of family and published sources, still do not make it to the retained registries as transcribed onto the website' of the Scottish registry. Obviously the situation is complicated where you have different denominations. I do not know the dates for Scotland, but in England the requirement to register births, marriages and deaths was a legal requirements under civil law only from the 1830s. Effective sanctions (fines) against non compliance were introduced only in the 1870s, and I suspect that the guys who emigrated tended, by definition, to be the freer spirits and those least likely to comply with registration requirements. Nevertheless, the 'on-line' data for Scotland is constantly being expanded (they allege) so if you think that the Lawtons might, like the Brisbanes, have emigrated from Scotland please do let me know and I can make a note to check out the national records periodically.

I was not able to tie in Narcissa Melissa Lawton Lawton. Who, please was her father? And I wonder what her parents were thinking of when they picked those names. (But that is a thought one often has).

I have another favour to ask, if you're still there .... I have a concern that in my data for the children of Benjamin Themistocles Dion Lawton 1782 – 1846 I may have included some people more than once (ie with a nickname and with a given name). If I attach a little report showing my version of the children (all eleven) for this gentleman, I wonder if you would mind checking whether or not, compared to your own data, I have duplicated people. It's a big favour to ask, but I am hoping (of course) that for this family you may already have much of the information in your head.

Thank you for the address of the Rev Dr Wallace Alcorn, which I should like to follow up. I hope you will not mind if I quote your name when I write to him. As you probably understand already (and I think I already hinted in this letter) I seethe with curiosity about what happened to all those Brisbanes and the families with whom they married after the diaspora that followed the Civil War. Till about two months ago my knowledge came to a grinding halt shortly after my grand father got married and switched his energies (I presume) to family life, and to keeping up with his wife whom I suspect of having been a bit of a tornado type. Also, of course, once he made his home in England it would have become a whole lot harder to keep in touch with stateside developments. Only now am I beginning to learn that the information is all there if only you know where to look. I only discovered the 'web' seven months ago, and I fear am still preaching its merits with the convert's fervour.

I always write too much, and this time I have attached a lot of reports. Please do not feel under any obligation to read them quickly or at all if you have other priorities. You have already supported my researches more than I had anticipated. You may also wish to apologise to your postman if he is complaining of hernia.

Of course, it is possible you take an opposite view and would be interested to receive a more comprehensive forty page report concerning what I reckon to know about the Brisbanes in SC and their descendants. Well, let me know if that's an interest. But I don't think I will send it speculatively. I suspect that you may already have almost all this information from other sources.

The other thing which I can let you have if you write that you would be interested but do not already have it, is a childhood memoire written by Mary Catherine (Brisbane) Hickox 1832 – 1913. It is a real gem of a piece, including plenty of genealogical tips and also deliciously feminine anecdotes, which bring some of those guys alive on the paper. She is very direct, too, as intelligent ladies tend to be when they get older. I have the impression that she found WHB's abolitionist principals very commendable, but she does not forbear to draw attention to the financial hardship for him and his family which was his reward for those high ideals. Another age: another book of rules.

As mentioned above, I always write too much. I think I will print and sign this before reading your letter again, or I will probably come with another six pages. Thank you again for your own delightful letter.

# Notes for HARRIET RUTH BRISBANE:

The following text appeared in the Charleston News & Courier on July 17, 1918, according to a written note by the subject's son in law, Eduardo Haviland Hillman, who also recorded the page number (8) ands the column on the page (2).

I think Eduardo must also have supplied notes for the text, much of which closely echoes some published comments of his in a 1913 article in The South Carolina Historical and Genealogical Magazine.

Eduardo seems to have held his mother in law in high regard. It was he (rather than his wife, Harriet's own daughter) who registered her death, having been with her when she died.

# PASSES AWAY IN ENGLAND

----\*----

Death of Mrs. Harriet Ruth Brisbane Tracy [Harriet Ruth Brisbane 1834 - 1918]

There passed away at Isleworth, County Middlesex, in England, on May 30 last [30 May 1918] in her eighty-fourth year, a member of a very old and distinguished American family, Harriet Ruth Brisbane Tracy. She was the daughter of William Brisbane Esq. [William Brisbane 1809 - 1860] and Julia Hall Lowndes [Julia Hall Lowndes 1811 - 1847], both members of families eminent in the history of the South. Mrs Tracy's great-grandfather, the Hon Rawlins Lowndes [Rawlins Lowndes 1720/1 - 1800], was president of the province of South Carolina in 1778 and later a member of the South Carolina Assembly. William Jones Lowndes [William Jones Lowndes 1782 - 1822], his son, and Mrs Tracy's great uncle, was educated in England as a boy, and when visiting that country later in life, as a distinguished statesman, it was said of him to the then Duke of Argyle, "I have been spending a most agreeable hour with a young American gentleman, who is the tallest, wisest and best-bred young man I have ever met." "It must have been Mr. Lowndes of South Carolina," replied the Duke. "He is such a man. I know him, and know no other like him, return and make his acquaintance.

Mrs. Tracy was an exceptionally gifted woman herself, having evinced from early youth a decided inventive genius, and between 1889 and 1893 no less than eleven patents for mechanical inventions were granted to her, by the United States patent office. Some of these were exhibited at the World's Fair in Chicago in 1893, for which she was presented with several silver and bronze medals, and a diploma from the World's Columbian Commission for her models of passenger elevators. Mrs. Tracy was also gifted as a writer of verse and prose, and often contributed to magazine and other periodicals.

In 1860 she married at Litchfield, Conn., Cadwallader Colden Tracy Esq. Of New York, who survives her at the age of eighty-nine, grandson of the Hon. Uriah Tracy, Senator from Connecticut, during Washington's administration and a personal friend of the president. Mr Tracy is also a descendant of Cadwallader Colden, Lieutenant Governor of the Province of New York from 1761 until his death in 1776.

Mrs Tracy was indirectly a victim of the war, her house in London having been damaged in the March raid and despite wonderful fortitude and self-control, the shock and exposure to cold hastened her end. She was an intensely loyal American and at the memorial service held at Isleworth on June 1 her body was surrounded by her beloved soldiers and sailors of the United States army and navy to whom her house was ever open, and the coffin was covered by them with the American flag, so dear to her heart.

Although, since her marriage, Mrs Tracy had lived away from the home of her youth, first in the North and later in Europe, she never lost her interest for her beloved South. Towards the end her mind

Page 6 of 18 seemed filled with sweet memories of her youth and almost her last words were of Charleston and its people. Mrs Tracy leaves four daughters, Mrs E Haviland Hillman [Mary Colden Willet Tracy Hillman 1873 - 1953], Miss Julia Lowndes [Tracy] [Julia Lowndes Tracy b 1865] and Miss Adele Brisbane Tracy [Adeline Brisbane Tracy b1869], who reside in England, and Mrs Frederic W. Corse [Caroline Ruth Colden Tracy Corse b 1871] of New York.

Notes for CADWALLADER COLDEN TRACY:

In approximately 1912 he was reported as living in Lausanne, Valais, CH.

Like all the Tracys in this dataset, he is frustratingly hard to 'tie down' in terms of dates, places and relationships. My only source for his year of death is a hand written note by his son in law.

Notes for MARY COLDEN WILLETT TRACY:

She came to Europe as a young woman and had a career an an opera singer. The family retains an effusive letter from Sir Henry Wood commending a performance in a minor Wagner part in approximately 1905.

She appears to have been accompanied / followed to Europe by at least one of her un married sisters. Her son, Charles T H Hillman (1915 - 1985) who spoke little of his childhood, nonetheless recalled being driven by 'Aunt Adele ' in the Boulogne (northern France) area. The car had been converted, with the steering wheel on the opposite side from that of the original design. The observant youth noticed that by pressing hard on the floor on the passenger side he was able to speed the car, so presumably the floor was flimsy and the throttle linkage near the surface.

Notes for EDUARDO HAVILAND HILLMAN:

He was described as a professional genealogist in 1908 and in 1913 published a couple of informative articles in the South Carolina Historical and Genealogical Magazine concerning the Brisbane family.

Notes for Charles Tracy Haviland Hillman:

A newspaper report of a Royal Academy (London) exhibition reports favourably on 'Mr Derwent Wood's bust of Master Charles Haviland Hillman...a work of the highest quality alike in its sculptural attributes and sympathetic, almost prophetic, insight into the character of boyhood'.

CTH Hillman (1915 - 1985) was throughout his life regarded as unusually good looking.

Marriage Notes for CHARLES HILLMAN and MARY DUFF: There were various rather gushing newspaper reports.

There was not a lot of good news available. Two months earlier Great Britain had declared war on Germany in response to Germany's invasion of Poland. However, although military preparations already under way continued, Britain was not in any position to take the war to the enemy. This was the period, therefore, of the 'phoney war' as people in England waited to find out what being at war with Germany involved, while Germany consolidated her occupation of Mittel Europa and planned for a second implementation of the Schliefen Plan which would involve rapid invasion of France via the Low Countries.

# PASSES AWAY IN ENGLAND

\_\_\_\_\*\_\_\_\*

Death of Mrs. Harriet Ruth Brisbane Tracy [Harriet Ruth Brisbane 1834 - 1918]

There passed away at Isleworth, County Middlesex, in England, on May 30 last [30 May 1918] in her eighty-fourth year, a member of a very old and distinguished American family, Harriet Ruth Brisbane Tracy. She was the daughter of William Brisbane Esq. [William Brisbane 1809 - 1860] and Julia Hall Lowndes [Julia Hall Lowndes 1811 - 1847], both members of families eminent in the history of the South. Mrs Tracy's great-grandfather, the Hon Rawlins Lowndes [Rawlins Lowndes 1720/1 - 1800], was president of the province of South Carolina in 1778 and later a member of the South Carolina Assembly. William Jones Lowndes [William Jones Lowndes 1782 - 1822], his son, and Mrs Tracy's great uncle, was educated in England as a boy, and when visiting that country later in life, as a distinguished statesman, it was said of him to the then Duke of Argyle, "I have been spending a most agreeable hour with a young American gentleman, who is the tallest, wisest and best-bred young man I have ever met." "It must have been Mr. Lowndes of South Carolina," replied the Duke. "He is such a man. I know him, and know no other like him, return and make his acquaintance.

Mrs. Tracy was an exceptionally gifted woman herself, having evinced from early youth a decided inventive genius, and between 1889 and 1893 no less than eleven patents for mechanical inventions were granted to her, by the United States patent office. Some of these were exhibited at the World's Fair in Chicago in 1893, for which she was presented with several silver and bronze medals, and a diploma from the World's Columbian Commission for her models of passenger elevators. Mrs. Tracy was also gifted as a writer of verse and prose, and often contributed to magazine and other periodicals.

In 1860 she married at Litchfield, Conn., Cadwallader Colden Tracy Esq. Of New York, who survives her at the age of eighty-nine, grandson of the Hon. Uriah Tracy, Senator from Connecticut, during Washington's administration and a personal friend of the president. Mr Tracy is also a descendant of Cadwallader Colden, Lieutenant Governor of the Province of New York from 1761 until his death in 1776.

Mrs Tracy was indirectly a victim of the war, her house in London having been damaged in the March raid and despite wonderful fortitude and self-control, the shock and exposure to cold hastened her end. She was an intensely loyal American and at the memorial service held at Isleworth on June 1 her body was surrounded by her beloved soldiers and sailors of the United States army and navy to whom her house was ever open, and the coffin was covered by them with the American flag, so dear to her heart.

Although, since her marriage, Mrs Tracy had lived away from the home of her youth, first in the North and later in Europe, she never lost her interest for her beloved South. Towards the end her mind

seemed filled with sweet memories of her youth and almost her last words were of Charleston and its people. Mrs Tracy leaves four daughters, Mrs E Haviland Hillman [Mary Colden Willet Tracy Hillman 1873 - 1953], Miss Julia Lowndes [Tracy] [Julia Lowndes Tracy b 1865] and Miss Adele Brisbane Tracy [Adeline Brisbane Tracy b1869], who reside in England, and Mrs Frederic W. Corse [Caroline Ruth Colden Tracy Corse b 1871] of New York.

Extract from "Sea Island Diary, A History of St. Helena Island", Edith M. Dabbs;1983.

"In the fall, 3 land commissioners - [one being] Dr William Henry Brisbane - were sent to implement the government's order to sell all private real estate on which taxes had not been paid. Dr. Brisbane was a direct descendant of the first John Chaplin on St Helena Island. He was a physician, an author, and a Baptist minister. Never having become reconciled to the slave society in which he grew up, he had first written a book proving, as a minister and Bible scholar, that slavery was justified by the Scriptures. Then, not having convinced himself, he wrote a second book proving the evil of a slave system. Well before the Civil War, he moved to Wisconsin, taking his slaves with him beyond the Mason-Dixon Line where he set them all free. Then, in October of 1862, the US Gov sent him as a tax assessor to Beaufort & St Helena Island, which, only months before, his kinsman, the current John Chaplain, with eight sons of his 22 children, had been defending at Bay Point.

"Dr Brisbane appreciated the area & believed it a superior place to promote settlement of a port city having both resort & industrial attractions. He designed a plan for a 'City of Port Royal', which he located to cover the Land's End area of St Helena. But somehow the town he envisioned never got started and Dr Brisbane himself was never again welcomed at Beaufort as a native son.

"...notices sent out all former slaves invited to celebration on New Year's Day of 1863 ... Emancipation Day ... President's proclamation would be read aloud publicly for the first time ... The 1st SC Volunteers arrived... 8th Maine Volumteer Band played --... Dr Brisbane, a native Southerner with his roots on St Helena, read the President's proclamation for the first time to the thousands of ex-slaves gathered to hear it..."

Mary Catherine Brisbane Hickox also refers to his abolitionist principals in her childhood memoires.
