Stribling- Taliaferro- Kincheloe research . Done summer & fall 1965

This study is undertaken in an endeavor to ascertain the ancestry of Elizabeth Stribling, whose middle name was Taliaferro. According to her own statement, Elizabeth Taliaferro Stribling was born in 1754. She wed (as his second wife) Lt. Col. Jc. Farr of Union Dist. S.C. on 4 Oct. 1770. She d. in Union Dist. S.C. prior to 17 Oct. 1844, when her son Titus C. Farr applied for letters of adm. on her estate.

At this time, we assume, for lack of proof to the contrary, that Elizabeth T. Stribling Farr was b. in Va. The Union CC.S.C. records show in Deed Bk.S-12, a deed dated 27 Nov. 1843, that Elizabeth's mother was nee Kincheloe (Spelled Kinchellow in the deed) as follows :

Elizabeth T. Farr of Union Dist. S.C. , a gift to "My son, Titus Green Farr of the same state & county, all my right & interest in the estate of my grandfather ----- Kinchelow in the state of Va. , also my dower interest in the estate of my deceased husband, wa. Farr , & all my personal possessions. "

(As will be seen on the ensuing pages the father of Elizabeth Taliaferro Stribling Farr was Thomas Stribling & her mother was Ann Kincheloe.

Thomas Stribling " of Pendleton Dist. " will in Anderson Co. S.C. (Old Pendleton Dist.) WPA typed Wills at S.C. State Archives, Columbia, S.C. signed 24 Sept. 1818, pr. 7 June 1819, Names : wife, -3 negroes, viz: Rachel, Alse, Cato, & my house & moveable property for her life.

It is not known at this time whether the Thomas Stribling of Union Dist. is the testator or his son.

The lady who prepared this needed a new typewriter -

Elizabeth Taliaferro Farr, application for Rev. pension File 4-2194, Nat. Archives, made application 12 Jan. 1839 for a widow's pension based on the services of her deceased husband, Lt. Col. Wm. Farr. Her application was made Union Co. S.C. before John J. Pratt, Judge of Ct. of Ordianry. She gives her age as 75 yrs., but does not give her birthdate. She d. Col. Wm. Farr 4 Oct. 1779. His birthdate not given. Death 2 Mar. 1794. The pension was allowed & the sum of \$576.67 per yr. was allowed the widow. Her death date does not show on the file. Union Co. S.C. records show that the widow Elizabeth Talivo(Taliaferro) Farr d. before 17 Oct. 1844.

Warren Taliaferro of Pendleton Dist(from WPA typed wills Anderson Co. S.C.) signed 6 Oct. 1815, proved 4 Dec. 1815; names in his will:

were of the daus. of Joan Taliaferro wed Clayton Stribling, Jr. above. He is also known as Clayton Perry Stribling. It is my thought that this Clayton Stribling (Sr.) the testator here is the bro. of Elizabeth Taliaferro Stribling Farr.

Kinchloe Family
Mary Mag. Vol. 22, Series 1, p. 186, Taken from Baltimore Sun. Dec. 29, 1907
"The first of the name Kinchloe was probably John Kinchloe (Kincheloe) of Prince Georges Co. Va. who m. Margaret Foote, dau. of Geo. Foote. This John Kinchloe d. before 26 Sept. 1764 His children were : John Jr. who m. Margaret Foote, a cousin, & probably others
John Kinchloe, Jr. had : Elijah, Geo., & James who m. Elizabeth Hardwick.
da. " , probably another son of John Kinchloe 1st, the emigrant, was b. 26 May 1736, d. Nelson Co. Ky, 1797. He m. Polly White.

There was a great deal more on the branches of the family which moved to Ky., but I found nothing in this to enlighten us on the ancestry of Ann (Kinchloe) Stribling - Mrs. Crowder.

Taliaferro Family

From Mary Mag. Vol. 22, Series 1, p. 266

Talifer was the name of the Norman knight who came to England with the conqueror.

Robert Taliaferro, the first of that name to Va., was a man of consequence. He had large land grant in Gloucester Co. Va. & on Rappahannock River, including 6,300 a. which he owned jointly with Col. Lawrence Smith. He m. Sarah, dau. of Rev. Chas. Grynes. She was great aunt of the Hon. John Grynes who was Receiver General of Va.

In 1673 - Robert Taliaferro Jr, son of Robert the First, (above) had a grant of land adjoining Henry Corbin on the Rappahannock River due him (Robert T. Jr.) " as grand son of Mr. Grynes " In 1688 John & Francis Taliaferro, gave bond to Mrs. Sarah Taliaferro, widow of Robert Taliaferro, dec'd.

Francis Taliaferro of Gloucester Co. Va. made a deed to his bro. John, son of Robert T. of Rappahannock Co. Va. / 28 Sept. 1682, showing that the first Robert T. was dead by that date & probably sometime before. On the same date Francis, also made deed to his bro. Richard T.

Robert Taliaferro gave bond 1 June 1767 for the estate of Robert T. dec'd. He m. Sarah Catlett, dau. of John Catlett & Elizabeth Underwood. Elizabeth Underwood was one of the step-daughters of Col. John Upton of Isle of Wight Co. Va. She m. 1st Capt. Francis Slaughter of Rappahannock Co. Va., & 2nd. Col. John Catlett, & 3rd, Rev. Amory Buller.

Francis T. son of Robert Taliaferro 1st, m. Elizabeth Catlett, dau. of John Catlett, & sister to Sarah Catlett, who m. Robert Taliaferro, 2nd.

Francis T. d. ca. 1710. He was living in Gloucester Co. Va. 1682. In 1690-1700 he was Justice of Peace of Essex Co. Va. In 1701 Francis & Elizabeth T. sold 416 a. of land in Essex Co. Va., being half of a tract granted in 1660 to Col. John Catlett & by his will given to his daus. Sarah & Elizabeth & this tract was the share laid off for Elizabeth, now wife of Francis Taliaferro.

Elizabeth & Francis (who d. 1710) Taliaferro had the following children :

1. Francis, a son, mentioned in the will of his uncle Wm. Catlett
2. John Taliaferro of "The Mount" who wed Agatha -----
3. Robert " who d. 1725, mentioned in his will his sister, Eliza, wife of Thomas Stribling.

6. Elizabeth " m. Thomas Stribling. They had : Wm., Francis & Taliaferro Stribling,

Battles : Cowpens, Blackstocks on Tyger River, Hammond's Store on Little River, Ramsours' Mills, Battles in Indian Country (Cherokee) in the High Wasas, now a part of Tenn. There were statements by Maj. McJunkin re' Col. Farr, but no special new data. Maj. gave his own service as a private in the Militia of S.C. 1776, that he was promoted to a Capt. in 1777 & to Maj. 1789, which commission he held till the close of the Rev. War.

Deposition of Maj. Young & Christopher Brandon- same as of Maj. McJunkin, except the fact that Lt. Col. Farr marched to Rowan Co. N.C. during his service in Rev.

By Mrs. Crowder : Col. Farr is buried back of the present Cone Mill which is situated in Union S.C., just over the Chester Co. line & abt. 1/4 to 1/2 mile from Broad River. His grave is said to have been "on the SCALFE place." I think the land at the time of Col. Farr's death belonged to him & was a part of his plantation. He was a man of considerable wealth & had extensive land holdings.

The site was found recently & the only marker was a DAR marker with no dates, only "Lt. Col. Wm. Farr/ South Carolina Militia/ Revolutionary War." This marker was lying on the ground. It is hoped that the marker will be reset.

There is no marker to Elizabeth T. (Stribling) Farr, but it is presumed that she is buried there beside her warrior husband to whom she was wed when she was 15 yrs. of age.

Richard Farr Sr. was at New River as early as 1734 when he was a juror was involved in a suit & was commissioned to lay out roads on the east side of New River (Onslow Deed A. 3). He d. 8 Nov. 1758 leaving a widow Hannah & 4 sons: Richard Jr, Titus Green (who m. Mary Ann & had John Richard & Elizabeth who m. A Wrenn, & Hannah); James & Wm. The youngest son, Wm., was a witness in Onslow as early as 1763. In 1768 (H 73; I 6) Wm. Farr "formerly of Onslow Co., but now of Mecklenburg Co." sold to a merchant part (390 a.) of the Richard Farr grant (640a) of 8 Mar. 1736; & in another deed the same yr. Wm. & wife, Eleanor of Mecklenburg sold to John Williams 400 a. adjoining John Howard on Crafford's (Traas) Creek. In 1768 he sold 240a. at Hopes Creek & Schoolhouse Branch "left by will to me by my father." It is evident that this Wm. Farr of New River at sometime between 1762-68 removed to Mecklenburg Co. at which time included the present Union Co. & settled parts of both if the Carolinas to the west. This included the Waxhaws. It is quite evident that this Wm. of Onslow & Mecklenburg one of a substantial number of former Onslow Co. residents who by time of the Revolution had moved into the backlands. No Farr by the name of Wm. has been found in the later records of Onslow Co.

This Wm. Farr doubtless was Lt. Col. Wm. Farr who made his will 31 July 1792, Union Co. S.C. (Will Bk. A. p. 1618 & given in "Pharrs & Farris with Other Descendants" by Henry Newton Pharr, 1955, p. 567. Lt. Col. Farr left a widow, Elizabeth Taliaferro (evidently his wife, Eleanor had d.) & sons: Wm. Black Farr, Thomas, John Pulaski, Titus Green & several daus. Wm. Black Farr was exr. of his father's will. He must have been named for Wm. Balck (q.v.) bro. of the clerk of the court in Onslow. Another son Titus Green Farr, was doubtless named for his uncle at New River. Titus Green Farr, who made his will 15 Mar. 1762 (Onslow Co. Cit. p. 712) leaving a widow, Mary Ann (found later Mary Ann Clendanel by a subsequent marriage) who d. abt. 1775 (copy of will in the will (ibid p. 703) her sons, John & Richard Farr & dau. Elizabeth Wrenn. This Richard Farr was probably the Richard Farr who sold in 1784 to James Wrenn (q.v) 130 a. on Half Moon Swamp at New River (Onslow Deeds N. p. 9 & 10). Richard according to his mother's will, had a son, George, perhaps the father of Geo. L. Farr b. ca. 1810 who had a son, Jackson Farr, b. ca. 1842 (dates computed from 1850 census) then living in lower southwest district of Onslow Co. (This is all the data given on the Farr family here.)

Consent by Mrs. Crowder : Here is the line of Elizabeth Taliaferro (Stribling) Farr, I feel certain. These articles in Va. Mag. & Wm. & Mary, etc, are fine & serve a purpose, but so often they are not complete & I think this is such a case. Elizabeth Taliaferro & her husband, Thomas Stribling, who d. 1819 in Pendleton Dist. S.C. There is no other way out of it.

Colonial Dates Eligibility

Col. John Catlett of Essex Co. Va. , will dated 1714 mentions the following heirs : Elizabeth & Sarah Taliaferro, Margaret & Rebecca Catlett, John & Thomas Catlett. The context of the will shows Elizabeth Taliaferro as a daughter.

Colonial Va. Register- Standard, p. 89-90: John Catlett is listed as a member of House of Burgesses from Essex 1693, & again 1695

This will be eligibility on the service of Col. John Catlett when we find the proof of of the missing link , Thomas Stribling--- which I feel sure exists somewhere. I think doubtless Robert Taliaferro 1 & also his son, Francis who wed Elizabeth Catlett, have service which would give eligibility if we can find the record. (My ancestor, Daniel Dobbins was a member of the House of Burgesses 1680, but Standard does not record him- Mrs. Crowder.)

Lt. Col. Wm. Farr, Rev. Pension file W-21094, Nat. Archives, Wash. D.C. His widow applied for pension 12 Jan. 1839 according to Act of Congress passed 4 July 1836. Her name was Elizabeth T. Farr, & her age given as 75 yrs., so she was b. ca. 1764. Farr's service attested by Maj. Joseph McJunkin of Union Dist. S.C. etc. Col. Farr enlisted sometime in yr. 1776. Commissioned a Capt. in Spartan Regt. commanded by Col. John Thomas, etc.
