Dear Jane,

Thank you for the opportunity to contribute some COPE Family info for the next edition of <u>Priester-Peeples: Lives and Ledgends.</u> I was disappointed to have missed the earlier deadline and delighted to learn you had extended it. Here are the transcripts I have made or collected.

I began working on the COPE family at the suggestion of my distant kinsman, the Rev. Dr. Robert E. H. Peeples of Hilton Head Island. Dr. Peeples was aware of a Mole-Cope relationship and thought further investigation might shed some light on our shadowy Mole line. I have, therefore, been interested in Copes only as they connected with the Mole and Platts families, and, to do more with them, I will need to get further information from Wyman Jay Priester and Gerald B. Cope, Sr. I would, however, like to "do" the Cope section for the second edition if you are looking for contributors.

I am sending you what I have, mis-spellings, typos, errors, and all. Taking time to fix all that is wrong is probably a bit premature. If you think what I have is of interest, I'll go to Barnwell to fill in the holes, gather more data, and correct what I now have. I will also search the Census which I have not done systematically.

Before anything is printed, what I submit should be read again by Dr. Peeples, Wyman Jay Priester, Mr. Cope, and his son Judge Cope of Miami. They all have such good eyes for screening out camels I'm trying to swallow.

I also have some Priester information. A Nicholas Priester¹, William Priester, Sr.², Nicholas F. Priester³ (1871-1927) chart made by Mildred Wedincamp of Jesup is attached, and, if you want it, I can send references which appear to support her chart. Do you want my George and Andrew Priester notes?

I look forward to hearing from you when next you get back to the COPE family. Until then,

George W. Brant, John Fred Brant, and William Brant were sons of John Frederick Brant and his wife Hannah Cope, above (see Barnwell Deed Book AA, pp. 76-82). Other children of John Frederick and Hannah Cope Brant were Richard Brant, Susannah Brant Jenny, and Henry Brant who predeceased John Frederick Brant, leaving "my grandaughter Anna Brant." Anna Brant m. Hezekiah Bishop, brother to George William Bishop who m. Mary Platts, above, daughter of David and Margaret Cope Platts. Anna Brant Bishop's mother was Catherine Platts, sister to John, David, and George Platts (and [Martin] Platts who died before 1816), Christine Platts Howard, Elizabeth Platts All Ulmer, Hannah Platts Cone, Margaret Platts Harter Warren, Nancy Platts Hiers, Miley Platts Kinard. Catherine Platts Brant m. (2) Washington K. Weekley. I believe that Chatherine Platts Brant Weekley was also the mother of Dr. John Martin Weekley (1837-1932).

[Susannah Mole is known to have married John Platts (extant markers and Bible record) and Rebecca Mole is known to have married John A. Lightsey (Bible record); therefore, this plat suggests that Susannah and Rebecca Mole, Frederick Mole, and Levice (who was married first to George Platts and later to George Priester) were siblings and this 191 acres was an undivided portion of their father's estate.]

NB: Not included in the above are several deeds and plats dated after 1841 whereby George Priester acquired land or was shown as owner of land formerly belonging to George Platts. I also have George and Andrew Priester as neigbors to John Platts' land in Beaufort County in 1823; Andrew Priester as a witness to a deed in 1827; and Andrew Priester owning land on Jackson Branch in 1841.
