Jan. 6, 1676, Rymer van der Coelen acknowledged a conveyance for the half of a plantation and marsh called the "Hay Makers hoeck" unto Peter de Witt, Jan Barentsen and Cornelis Jansen, which was ordered to be recorded (*Ibid.*, p. 41).

* June 6, 1677, upon the petition of Hendrick Williams, Marten Geritz, Peter de Witt and Peter Maeslander for a warrant and liberty for each to take up 300 acres of land, the Court grants the petition (*Ibid.*, p. 94).

July 24, 1677, Peter de Witt was a juror (*Ibid.*, p. 104).

Nov. 9, 1677, Peter de Witt mentioned in the list of taxable persons in New Castle County (*Ibid.*, p. 160).

Nov. 4 and 5, 1678-9, upon the petition of Peter de Witt, Cornelis Jansen, Peter Maeslander, Elsie, the widow of Ole Toursen, Jan Barentsen Hendrick Jansen, etc., all inhabitants of Swanwick, desiring a grant from the Court to take up in common certain land to the end that no person else might take up the same and hinder the petitioners from fetching wood and timber as well as outdrift for their cattle, the Court answered that they would not grant land so near as to prejudice the town but it is thought best that the land should lie in Common as heretofore as well for the petitioners as the whole town (*Ibid.*, p. 291).

* June 3 and 4, 1679, in the suit of The Executors of the Estate of Dirk Albertsen, dec'd, vs. Hendrick Evertsen, action of debt, the def't. having admitted the debt, Peter de Witt promised to pay the debt in the fall (*Ibid.*, p. 329).

Dec. 3, 1679, in the suit of Hans Peterson vs. Pelle Hendricks, the case being about marsh and hay ground, Gysbert Dircksen, Hendrick Williams and Peter de Witt are appointed to hear the difference and debates of both parties and to make a return to Court at the next Court day (*Ibid.*, p. 355).

* Feb. 3, 1679-80, Peter de Witt produced and account against Rich. Highinbottom in the sum of 145 guilders (*Ibid.*, p. 374).

* April 6, 1680, Peter de Witt purchased at public sale certain land for 1425 guilders (*Ibid.*, p. 410).

Oct. 5, 1680, the suit of Peter de Witt vs. Morris Liston, for failure to deliver tobacco in good condition, was continued (*Ibid.*, p. 429).

Mch. 1 and 2, 1680-81, a verdict for defendant was rendered in previous suit (*Ibid.*, p. 451).

Nov. 1 and 2, 1681, Ephriam Herman, the Surveyor, made return of a survey laid out for Jan Stalcop, Peter de Witt, Mary Blöcq, Hans Peters, Pelle Hendricks and other persons, who have a share in a water mill standing in the Schilpats Creek, a certain tract of land for the use of said mill called Schilpats-mill-land, situated on the west side of Delaware River and at the head of a creek called Schilpats Creek, which proceeds out of Christiana Creek, laid out for 78 acres of fast land surveyed Oct. 23, 1680 (*Ibid.*, p. 508).
