A GRIMBALL PLANTATION JOURNAL

Edited and Annotated by
THE REVEREND DR. ROBERT E. H. PEEPLES

In January 1701 Thomas Grimball,¹ planter of Edisto Island, South Carolina, began his family record in a 3 x 5 inch plantation journal which, after his 26 October 1721 death, was continued by his son, Paul Grimball² (1703-1750). The journal's record was intermittently continued by Paul Grimball's widow, Mrs Mary (Stone) Grimball³ (c.1720-1804), daughter of John Stone⁴ and his wife Susannah⁵ (1703-1780), daughter of French Huguenot immigrant Jean Carrière⁶ (c.1670-1724).

Paul Grimball's widow married (2) c.1751 Captain William Lawton, planter of Edisto Island, and (3) on 15 January 1759 Samuel Fickling.⁸ She apparently took the journal to Prince William's Parish where she settled prior to the Revolutionary War. After the 31 October 1780 death of her son John Grimball⁹ in Robertville, St. Peter's Parish, and her own death in 1804, the journal was preserved by her son Joseph Lawton¹⁰ (1753-1815), planter of Mulberry Grove Plantation, St. Peter's Parish, and his son, Col. Alexander James Lawton¹¹ (1790-1876) who left the journal in the possession of his son, Gen Alexander Robert Lawton¹² (1818-1896), Commissary General of the Confederate States of America.

¹ Thomas Grimball, progenitor of the Grimball family of South Carolina, son of the immigrant Paul and Mary Grimball of Edisto Island, married (1) Joyce who died 25 Jan. 1701; married (2 Elizabeth, who died 5 Aug. 1715, daughter of William Adams; married (3) 10 Nov. 1715 Anna who died 23 Aug. 1719; married (4) 8 Aug. 1720 Sarah, widow of Rev. William Pert. After his 26 Oct 1721 death, his widow married (3) 1724 Samuel Scriven and (4) Dr. George Smith (1674-1753) second son of Landgrave Thomas Smith (1648-1694), Governor of Carolina 1693-1694.

² Paul Grimball (1703-1750), second son bearing the name of Paul of Thomas Grimball, and his second wife, Elizabeth Adams, planter of Edisto Island, married (1) 4 Nov. 1725 Mary Barnwell (25 June 1709-14 June 1738), third daughter of Col. John and Anne (Berners) Barnwell, by whom he had eight children; married (2) 29 Nov. 1738 Mary Stone (c. 1720-1804), daughter of John and Susannah (Carrière) Stone, by whom he had six children. His will of 24 Nov. 1746, proved 25 Jan. 1750, had a 9 Jan. 1749 codicil directing that his son John and daughter Ann, born since his 24 Nov. 1746 will

share equally with his other children.

³ Mary Stone (c.1720-1804) has for many decades been erroneously identified as Mary Sams thought to have been a daughter of William Sams and Susannah Harrison although no evidence had been found to support such identification. The error apparently grew from the fact that Paul Grimball (1703-1750) referred in his 24 Nov. 1746 will to "my brother-in-law Robert Sams suggesting the erroneous conclusion that his widow was a sister of the said Robert Sams, when in fact he could correctly so describe Sams only because Sams had married c. 1727/8 as his second wife Bridget Barnwell (c.1711-1741), sister of Paul Grimball's first wife, Mary Barnwell (1709-1738) This journal clearly proves repeatedly that Paul Grimball's second wife was Mary Stone. As Mary Grimball of St. John's Parish, Colleton Co., she deeded property to her son Thomas Grimball on 12 Aug. 1751 shortly before her marriage to William Lawton, planter of Edisto Island. On 7 April 1738 the estate of her son Thomas Grimball deceased was shown by Mary Lawton. (Charleston Probate Court Book 1756-1758, p. 351.)

Upon the death of General Lawton's granddaughter, Miss Sarah Alexander Cunningham¹³ (1887-1976) of Savannah, the journal was discovered by Thomas O Lawton, Jr., 14 among her papers which had been deposited in the Georgia

Because of the journal's importance in correcting and clarifying the history Historical Society. of the Grimball, Robert, Lawton, Willingham, Winborn, Townsend and other Carolina families, the Georgia Historical Society has kindly given permission for its publication here. Of particular significance is a detached leaf inserted in the journal, which reads:

4 John Stone married c. 1719 Susannah Carriere (1703-1780) by whom he had a daughter, Mary Stone (c.1720-1804); he was deceased by March 1724/5 when Susannah Stone "widow of John Stone was appointed Administratrix of the Estate of her father, John Carriere. He should not be confused with John Stone who married 14 Nov. 1729 in St. Phillip's Parish Susannah Marshe Marshal) and made his will 25 June 1756, proved 27 Feb. 1761.

Susannah Carrière (1703-29 Sep. 1780), daughter of John and Elizabeth Carrière, married (1) 1719 John Stone who died before March 1725, leaving her with their daughter, Mary Stone c1720-1804); she married (2) c.1740 Thomas Winborn, planter of Wadmalaw Island, whose 14 Apr. 1753 will was proved 23 Jan. 1756, by whom she had a daughter Susannah Winborn, born 1742, who married Daniel Townsend. The Jan. 1778 will of Susannah (Carriere Stone) Winborn, widow of Wadmalaw Island, St. John's Parish, Colleton Co., proved 23 Dec. 1780, left half her moveable estate to her grandchildren Daniel, Thomas, John, Abigail and Sarah Townsend; the other half to her daughter Mary (Stone Grimball Lawton) Fickling for life, then to her heirs; fifty pound bequests each to her granddaughters Susannah Pike, Ann Ulmes and Mary Little; 7 sh/6 d bequests each to Thomas Little and Samual Fickling. Her 15 Sep. 1779 codicil directed that the half of her estate lent for the use of Mary Fickling in my will" be "divided between Mary Fickling's three children:

John Grimball, Joseph Lawton and Ann Robert.

⁶ Jean Carrière (c.1670-1723/4), born in Normandy, France, son of Jean Carrière, No. 112 on the 1696 Liste des habitants de Santee seeking naturalization as English citizens, apparently arrived at Charles Town 30 April 1680 aboard H.M.S. Richmond as a servant boy of Captain Jacob Guerard who received a 560-acre warrant 18 Feb. 1681 "for arrival of self, wife and six servants," including John Carier." He married c.1697 Elizabeth, the birth of their son John Carriere on 18 Nov. 1712 and his 28 Dec. 1712 baptism being recorded in the Register of the Parish of St. Thomas and St. Denis, as was the 18 Feb. 1714 marriage of their eldest daughter, Elizabeth Carriere, born c. 1698, to Jacob Burdell. The 23 March 1723/4 will of John Carriere, Colleton Co. cooper, proved 28 Jan. 1724/5, named his daughters Elizabeth Burdell, Susannah Stone, Deborah, Martha and Joanna Carriere and his court of the Control of the Co Carriere and his son John Carriere. Executors named were David Ferguson and Samuel Jones, both of whom renounced said duty on 19 Feb. 1724/5, whereupon his daughter Susannah Stone, widow of John Stone, was appointed Administratrix of his estate which was duly shown by her 15 Apr. 1725 and appraised at 207 pounds/15 shillings.

"My dear & loving wife was delivered of her fourth daughter Catherine 10 September 1733.

"God was pleased to take away my dear child Providence 30 November 1734.

Entries in the handwriting of Mary Stone Grimball:

"The Lord was pleased to take my deare & loving husband to himself 16 January 1750 about six o'clock at night.

"I was delivered of my third son, named Thomas Grimball 21 February 1750 about 7 o'clock in the morning it being a Thursday and the same year that his father died.

"My dear son Thomas Grimball departed this life 21 September 1757 on Wednesday about six o'clock in the afternoon.

"Ephraim Mikell was married to Providence Grimball 7 October 1759 between 9 & 10 o'clock Sunday morning.

"Mary Mikell, daughter of Ephraim & Providence Mikell, was born 10. August 1761 Thursday morning between 2 & 3 o'clock. "Samuel Fickling was married to Mary (Stone Grimball) Lawton January 15, 1759, it being Tuesday between 2 & 3 o'clock in the afternoon.
"Samuel Fickling, son of Samuel & Mary Fickling, was born March 20,

1761, it being Good Friday morning between 8 & 9 o'clock.

"My dear child departed this life July 14, 1766, it being on Monday

about 10 o'clock. It is my child Samuel.

"Providence Mikell, daughter of Mary Fickling, was brought to bed on March 1st, 1764 of a daughter named Ann, and that child departed this life on March the 7th 1764.

"My dear child Providence Mikell departed this life on March 15, 1764.

"The Lord was pleased by death to take away my deare son John Grimball on October 31, 1780.

The final entry was made by an unidentified writer:

"On Thursday, the 3rd November 1791 the Rev. Moses Hadley, late of New York, a follower of the eminent John Calvin, to wit, a Baptist minister, was joined in Nuptial or Matrimonial Bond with Ann Robert, a daughter of Mr. Peter Robert & Mrs. Ann (Grimball) Robert and on Saturday, the 18th August 1792 the said Rev. Moses Hadley & Ann his wife, was blessed of the Lord with a promising daughter whom they have (in memorial of Mrs. Mary Fickling, the aged, worthy & honorable grandmother of the said Ann Hadley) called Mary." 15

15 Mary Hadley, born 18 Aug. 1792, daughter of Rev. Moses and Ann (Robert) Hadley, received from her great-grandmother, Mrs. Mary Stone Grimball Lawton Fickling, a deed of gift on 3 Oct. 1803, as the Hadley family joined a group of 97 relatives and friends who emigrated from Robertville, St. Peter's Parish, Beaufort District, S. C., via the Tennessee, Ohio and Mississippi Rivers to found Woodville, Wilkinson Co., Mississippi in 1804, under the leadership of Captain Peter Robert who later moved on to Rapides Parish, Louisiana, where he died in 1825. Mary Hadley married John Ogden of Mississippi Territory.
