# THE GENEALOGY OF GIDEON HAGOOD (1775-1827)

- Francis Hogwood (Hawkwood), an Englishman of Scottish descent, came to Virginia in about 1650. He married Elizabeth Creed, daughter of Ralph and Grace Creed. He changed his name from Hawkwood to Hogwood.
- 2. Their son George Hagood, Sr., married Anne (maiden name unknown). Notice that the name is now Hagood.
- 3. Their son Francis Hagood married Sarah (maiden name unknown). Probably moved from Virginia to North Carolina.
- 4. Their son William Hagood married Sarah Johnson of Virginia. He died in 1812 and she died in 1826. They came to Ninety Six District of South Carolina in about 1775.
- 5. Their son Gideon Hagood married Harriet Peckham Yonge on March 17, 1796. She was the daughter of Francis Yonge, Sr. and Susannah (Johnson) Yonge.

## THE GENEALOGY OF HARRIET PECKHAM (YONGE) HAGOOD (1778-1820)

- Philip le Yonge, born about 1295, of Ludlow, Salop, England, m. Cecilia Ipstones.
- 2. Geoffrey (Galfridus) Yonge, b. c1320, m. Margeret St. Pierre, daughter of John de St. Pierre and his wife Margeret Trussel.
- 3. Thomas Yonge, b. c1345, m. Beatrice Caynton, daughter and heiress of Richard Caynton of Caynton and granddaughter of Sir William Caynton. Through this marriage the Yonge family acquired Kenton (Caynton) Manor.
- 4. Richard Yonge, b. c1375, m. Agnes Randolf (or Resall).
- 5. Sir Philip Yonge, b. c1405, m. Agnes Bannerton (or Bonarten) daughter of William Bonarten (or Bannerton) de Kinton. Sir Philip Yonge was killed on September 23, 1459, during the battle of Blore (Blower's) Heath during the War of the Roses.
- 6. Sir William Yonge, b. c1440, m. Margeret Eyton, b. c1443, daughter of Nicholas Eyton de Eyton, Knight and Sheriff of Shropshire 1439-1440 and his wife Katherine, daughter of John Talbot, Earl of Salop.
- 7. Sir Francis Yonge, b. c1478 m. Anne Charleton, daughter of Richard Charleton, Esq. of Appley Castle, Salop, Lord of Powrys (1450-1522) and his wife Elizabeth Mainwaring. Elizabeth Mainwaring was descended from William the Conqueror and King Malcolm of Scotland. This according to "Ancestral Peregrinations, Part 2", page 58, by Richard B. McConnell
- 8. John Yonge, b. c 1508, d. c 1551, m. Maud Bill (or Bull). John was the ninth son and did not inherit Canyton Manor but it did pass to his oldest son William.
- 9. William Yonge, b. c 1525, m. Anne Sneyd, daughter of Sir William Sneyd and his wife Alice Barrow, daughter of Robert Barrow of Fluckersbrook, Chesire. He acquired Caynton Manor where he had been living living as tenant at will by permission of his Uncle Thomas Yonge. William was High Sheriff of Salop in 1548.
- 10. William Yonge. b. 12-12-1559. d. 2-10-1598, m. Susanna Corbet, b. c1560, daughter of Robert Corbet, Esq. of Stanwardine Hall, Salop, and his wife Jane Kynaston (Kingston), and granddaughter of Roger Corbet and Anne Windsor. Susan Corbet, according to "Ancestral Peregrinations, Part 2", page 51 by Richard McConnell (June, 1967), was descended from King Edward I of England and Eleanor of Castile, daughter of King Fernando III of Castile.

- 11. William Yonge, b. 2-20 1594, d. 3-11-1647, m. Elizabeth Gough, b 1596, daughter of Roger Cough de Wigorn and his wife Margery, daughter of William Acton of Elmsbury, Worchestershire. Elizabeth Cough was also descended from Edward I of England and Eleanor of Castille. (Same source)
- 12. Philip Yonge, b. 6-01-1620, will dated 5-13-1676, married Margeret Mackworth, b. c1625, d. c1707, oldest daughter of Sir Henry Mackworth, Baronet, of Normanton, Rutland, and Mary Hopton. Mary Hopton was sister and co-heir of Sir Ralph Hopton (afterward Lord Hopton), the renowned Royalist general. Philip Yonge on the other hand was a Roundhead and supporter of Oliver Cromwell.
- 13. Mackworth Yonge, b. c1658, d. c1730, married Margeret (maiden name unknown). Caynton Hall had passed to his half brother William, b. c1647, son of Ann Archer, first wife of Philip Yonge. Philip Yonge's 1704 will lavishly provided for the children of his second wife, Margeret Mackworth, and left a pittance for William and his children. William, as the oldest, did inherit Caynton Hall. William's son Francis 1682-1748, immigrated to South Carolina before 1716, becoming Surveyor General of South Carolina, a member of the Council of the Lords Proprietors, member of King's Council, Agent in Great Britain of the Province of South Carolina and Chief Justice of South Carolina. He later returned to England, leaving his son Henry land including Orange Island near Charleston, now known as Yonge's Island.
- 14. Robert Yonge, b. 5-30-1699, d. about 1751, m. Hannah Eve, widow of Abraham Eve, in 1723. Robert Yonge immigrated to South Carolina, and became Register of Deeds of South Carolina on June 1, 1721, having been recommended by His Majesty's Council to Governor Francis Nicholson. He was made Justice of the Peace for Berkeley County on June 7, 1734, and was appointed Associate Judge of South Carolina in 1740. Hannah Eve was heir to Toogoodoo Plantation. Through this marriage, Robert Yonge acquired the status of Landholder and Planter and with it a degree of affluence and social acceptance in the Colony. After Hannah's death Robert married Elizabeth Elliot Butler, widow of a Mr. D' Arques. Robert is buried at Toogoodoo Plantation in Colleton County.
- 15. Francis Yonge, b. 1730, d. about 1780. married as his second wife, Sussanah Peckham Johnson, on 4-21-1768. His first wife was Sarah Clifford whom he married on 12-07-1752. Francis Yonge was heir to Toogoodoo Plantation.

Francis Yonge, Sr. was mentioned at least twice in "The S. C. Gazette and Country Journal".

- 1. Colleton County, April 7, 1766----The subscriber will sell either his Plainsfield Plantation, containing upwards of 2500 acres or Toobadoo (Toogoodoo???) Plantation, containing nearly 200 acres of land. Also one other tract of 636 acres, pleasantly situated upon Wadmelah River, adjoining lands of Mr. Thomas Smith, sen., and the estate of Archibald Stono, sen. Any person inclinable to purchase may apply to Francis Yonge.
- Charleston, April 21, 1766.. The fine English Horse DRIVER covers this season at Francis Yonge's Plainfield Plantation at Stono.

We do not know what happened to the plantations of Francis Yonge, Sr. In his will he left the land to his son, Francis Yonge, Jr., his son by his first wife.

# THE FAMILY OF GIDEON HAGOOD AND HARRIET PECKHAM YONGE

Gideon Hagood was born about 1776 probably in the Ninety Six District of South Carolina, but possibly in Virginia as his father, William Hagood and mother, Sarah Johnson Hagood moved to South Carolina in about 1775. He seems to have been in Charleston in the mid 1790's. His brother Johnson Hagood was practicing law there about that time. Gideon married Harriet Peckham Yonge at the Circular Congregational Church in Charleston, C., on March 17, 1796. She was born on April 9, 1778, the daughter of Francis Yonge, Sr. (1730-1780) and Sussanah Peckham Johnson who were married on April 21, 1768. Francis Yonge, Sr. was the son of Robert Yonge, born 1699 in England and Hannah Eve, the widow of Abraham Eve. Through this marriage the family became heirs to Toogoodoo Plantation. Robert Yonge was commissioned Registrar of Deeds of South Carolina on June 1, 1721. He was commissioned as Justice of the Peace for Berkeley County on June 7, 1734 and Associate Judge of South Carolina in 1740. The Yonge family has been traced in England to one Philip le Yonge who lived during the 13th century.

Gideon Hagood (full name Thomas Gideon Hagood) was a planter in Barnwell County, S. C. His plantation appears to have been named Mt. Ararat since newspaper articles mention a daughter dying there in 1807 and his wife dying there in 1820 and a daughter marrying there in 1818. He seems to have been a major in the state militia as he was referred to with that rank in Charleston newspapers. He was Barnwell County Ordinary (Probate Judge) from 1799-1806. It has been stated that his female descendants are eligible for The Daughters of 1812 because he was an office holder during a certain period of history. He entered the Baptist ministry in 1811 and was for a number of years Pastor of the Mt. Hope Church in Barnwell District. No record of this church can be found so it must have been in existance under that name for a relatively short time. There is a Negro church of the same name in the area that may have it's origins in the old Mt. Hope church.

The 1800 census shows the family consisting of 4 males
16 to 26 years old, one female less than 10 years old, one female
16-26 years old and one female more than 45 years old. The female
over 45 was probably the mother in law, Susannah Yonge, since she
was a widow. Some of the other males may have been the sons of
Susannah Yonge or possibly at least one son of Gideon and Harriet
Hagood. Gideon owned 15 slaves in 1800.
Equity records from Barnwell County state that on March 16, 1796,

Equity records from Barnwell County state that on March 16, 1796, the eve of his marriage to Harriet Yonge, he entered into an agreement conveying the estate that she received from her father, Francis Yonge, Sr., to her mother, Susannah Yonge and George Reid as her trustees. This took effect upon their marriage. The

estate was to be used by Harriet during her lifetime, then to be enjoyed by her husband if he survived her, then to her surviving children. Her inheritance included 300 pounds sterling from her father's will, 50 pounds sterling from the estate of her sister, Sarah Hope Yonge, who died in 1783, 70 pounds sterling from the estate of her deceased brother Mackworth Yonge who died in 1784 and 200 pounds sterling willed to her by her deceased brother William Yonge. Shortly after the marriage they moved to Barnwell District where the trustees bought for them lands and slaves. Gideon made a deed on Feb. 2, 1809, acknowledging said purchase which included 796 pounds for the purchase of twelve slaves and 250 pounds for the purchase of 608 acres of land from Edward Wimberly on the Lower Three Runs and 45 1/2 acres adjoining. The deed conveyed the slaves and property to the trustees in accordance with the marriage contract. It is apparent that the family of Harriet Yonge protected her estate from any possible exploitation and ruin by her husband, who was a relatively poor man at the time of their marriage. Gideon then apparently owned little outright, with almost everything in the hands of the trustees of the estate. He undoubtedly gained some income from his position as Ordinary and later as a Minister of the Gospel. Susannah Yonge died in about 1818 and Harriet died in 1820. Gideon remarried and died in 1827. On March 6, 1833, the estate, excluding the land, was sold at auction. The land first bought by the trustees was improved and well stocked with livestock but while well adapted to farming, proved unhealthy. Gideon bought a small adjoining tract and built a summer residence for the family. Susannah Yonge lived with the family until her death and became the purchaser of one undivided moiety, except the summer residence tract and joined in the expense of stocking the plantation.

After the death of his wife in 1820 Gideon married Mrs. Mary Brown at Mt. Pleasant in Hancock County, Ga., on February 2, 1823. They were married by the Rev. Jesse Mercer for whom Mercer University was named. Mt. Pleasant was apparently the home of Gideon Hagood in Hancock County. It may have been the name of a plantation or the name of a community. Mary Rabun had previously married William Bigger and William F. Brown (12-16-1819). After Gideon's death she married Edmund Shackleford (01-11-1829) and John Bishop (06-20-1833). She did not have issue by any of these marriages. She was the sister of the late Governor Rabun of Georgia. Gideon died in Hancock County on June 27, 1827. He left a will which included 32 slaves at his estate in South Carolina and 48 slaves in Georgia. The 48 slaves in Georgia came to him as a consequence of his marriage to Mary Rabun Brown and reverted to her after his death. His will is in the records of Barnwell County, S. C. and Hancock County, Ga. The following notice concerning the sale of the estate appeared in the Saturday, February 16, 1833, issue of "The Georgian" in Savannah:

SOUTH CAROLINA, BARNWELL DISTRICT) IN CHANCER

UNDER DECREES IN THE CASES, EXPARTE ELLIOT ESTIS AND WIFE, AND OTHERS--A. PATTERSON, EXCOR OF GIDEON HAGOOD, DECEASED,, VZ. ELLIOT ESTIS, AND OTHERS.

WILL BE SOLD ON THE PREMISES ON THE 6TH DAY OF MARCH NEXT: ALL THAT SETTLED PLANTATION, CONTAINING 653 1/2 ACRES, MORE OR LESS, LYING IN THE DISTRICT AFORESAID, ON THE LOWER THREE RUNS, BOUNDED ON LANDS LATELY OF THE ESTATE OF ELIJAH GILLETE. AARON SMITH, MIJACAH CALHOUN AND CHARLES R. STONE, AND BEING THE TRUST ESTATE OF THE LATE REV. GIDEON HAGOOD. ON THE PREMISES ARE A TOLERABLE DWELLING HOUSE, GIN HOUSE, NEGRO HOUSES AND OTHER BUILDINGS. THERE ARE ABOUT 209 ACRES CLEARED IN GOOD CONDITION FOR PLANTING THE PRESENT YEAR.. THE WOODLAND IS HEAVILY TIMBERED WITH OAK AND HICKORY. THE QUALITY IS EQUAL TO THE BEST UPLAND IN THE DISTRICT AND NO PLANTATION IN THE SAME SECTION OF THE COUNTRY HAS AFFORDED OR IS CAPABLE OF PRODUCING BETTER CROPS. IT IS NEAR THE SAVANNAH RIVER AND CONVENIENT TO TWO PUBLIC LANDINGS. IT IS CONFIDENTLY BELIEVED THAT A PLANTER WITH MODERATE CAPITAL WOULD NOT MAKE A MORE ADVANTAGEOUS INVESTMENT.

CONDITIONS, -- THE EXPENSES OF THE SALE, CASH; THE BALANCE PAYABLE IN ONE, TWO AND THREE YEARS WITH INTEREST, SECURED BY BOND, MORTGAGE AND PERSONAL SECURITY -- THE PURCHASER TO PAY FOR THE NECESSARY PAPERS.

His will was contested by his son in law, James McPherson, husband of his oldest daugther Elvira Ann. He had excluded her from his will because she was of "independent circumstances". It is not clear that this had anything to do with the suit. The estate was being held for payment of debt and the suit seems to have been to release the estate to the heirs. Gideon had entered into a marriage contract with his wife Harriet before their marriage stating that any children of the marriage would inherit the estate. The court held that the Hagood estate belonged to the trust estate of Harriet Yonge Hagood and through her her children who were allowed to apply for partition of the estate.

These notices appeared in newspapers concerning the deaths of Harriet P. Hagood and Gideon Hagood.

DIED AT MT. ARARAT IN BARNWELL DISTRICT ON THE 27TH ULT IN THE 43RD YEAR OF HER AGE, AFTER A SEVERE ILLNESS OF 3 MONTHS, MRS. HARRIET P. HAGOOD, THE AMIABLE CONSORT OF REV. GIDEON HAGOOD. FEW PERSONS EVER SUFFERED MORE THAN SHE DID DURING HER ILLNESS; YET SHE WAS NEVER HEARD TO MURMER, BUT BORE HER AFFLICTIONS WITH PATIENCE AND RESIGNATION TO THE DIVINE WILL. HER EARLY DEATH HAS DEPRIVED HER HUSBAND OF A MOST AFFECTIONATE WIFE, SIX CHILDREN OF A TENDER MOTHER, THE NEIGHBORHOOD OF A GOOD NEIGHBOR AND THE POOR AND NEEDY OF A CONSTANT BENEFACTOR. SHE HAS BEEN A PIOUS AND ZEALOUS MEMBER OF THE BAPTIST CHURCH FOR SEVENTEEN YEARS. SHE LIVED AND DIED THE DEATH OF THE RIGHTEOUS; APPEARED CONFIDENT OF HER APPROACHING END, AND PRAYED FOR THE HOUR OF HER RELEASE. SHE RETAINED HER SENSES UNTIL A FEW MINUTES BEFORE HER DEPARTURE, AND AFTER TAKING AN AFFECTIONATE FAREWELL OF HER AFFLICTED HUSBAND AND CHILDREN, SHE FELL ASLEEP IN THE ARMS OF HER SAVIOUR. SHE SELECTED THE FOLLOWING HYMN TO BE SUNG AT HER FUNERAL.

"TIS FINISHED! THE CONFLICT IS PASSED, THE HEAVEN BORN SPIRIT IS FLED; HER WISH IS ACCOMPLISHED AT LAST, AND NOW SHE'S ENTOMBED WITH THE DEAD.

THE MONTHS OF AFFLICTION ARE O'ER, THE DAYS AND THE NIGHTS OF DISTRESS; WE SEE HER IN ANGUISH NO MORE--SHE GAINED HER HAPPY RELEASE.

NO SICKNESS, OR SORROW, OR PAIN, SHALL EVER DISQUIET HER NOW, FOR DEATH TO HER SPIRIT WAS GAIN, SINCE CHRIST WAS HER LIFE WHEN BELOW.

HER SOUL HAS NOW TAKEN IT'S FLIGHT, TO MANSIONS OF GLORY ABOVE, TO MINGLE WITH ANGELS OF LIGHT, AND DWELL IN THE KINGDOM OF LOVE.

THE VICTORY NOW IS OBTAIN'D,
SHE'S GONE HER DEAR SAVIOUR TO SEE,
HER WISHES SHE FULLY HAS GAIN'D-SHE'S NOW WHERE SHE LONGED TO BE.
THE COFFIN, THE SHROUD, AND THE GRAVE,
TO HER WERE NO OBJECTS OF DREAD;
ON HIM WHO IS MIGHTY TO SAVE,
HER SOUL WAS WITH CONFIDENCE STAY'D.

THEN LET US FORBEAR TO COMPLAIN, THAT SHE IS NOW GONE FROM OUR SIGHT; WE SOON SHALL SEE HER AGAIN, WITH NEW AND REDOUBLED DELIGHT.

(THE PRECEDING FROM "THE COLUMBIAN MUSEUM AND DAILY GAZETTE", SAVANNAH, GEORGIA, NOVEMBER 25, 1820). DEATH OCCURED ON OCTOBER 27.

DIED SUDDENLY ON 22 JUNE LAST, AT HIS RESIDENCE, MT. PLEASANT, NEAR POWELTON, GA., IN THE 51ST YEAR OF HIS AGE, THE REV. GIDEON HAGOOD. THE DECEASED ENTERED THE MINISTRY IN 1811 AND WAS FOR MANY YEARS THE PASTOR OF MT. HOPE CHURCH, BARNWELL DISTRICT, IN THIS STATE. IN LIFE HE WAS KIND & AFFECTIONATE AND HIS LOSS WILL BE SEVERELY FELT BY A WIDOW AND SIX CHILDREN. (FROM THE "CHARLESTON CITY GAZETTE", MONDAY JULY 16, 1827.).

Following are the children of Gideon and Harriet Yonge Hagood as we know it at this time. The book Meet Your Grandfather by General Johnson Hagood incorrectly identifies Harriet Amanda Hagood as two persons, Harriet and Amanda. Susan Julia Hagood is also erroneously listed as two persons, Susan and Julia. The children listed below all appear in the will of Gideon Hagood. They also appear in the will of Susannah Yonge, the Mother in Law of Gideon Hagood, except for Emma McPherson Hagood.

Elvira Ann Hagood, baptized at Circular Congregational Church in Charleston on Wednesday, December 6, 1797. She married James McPherson in Barnwell District on March 26, 1818.
He was born in 1793, attended College of Charleston in 1809. He was the son of General John McPherson who lost his life in the sinking of the ship "Rose in Bloom" on August 24,1806. His mother was Susannah Miles. They were descendants of Capt. James McPherson and his wife Rachel Miles. Capt. McPherson aided Ogelthorpe in the settling of Georgia. James McPherson died on March 22, 1829, and is buried at Stoney Creek Cemetery near Yemessee, S. C. His tombstone reads "Sacred to the memory of James McPherson, only son of General John McPherson, who departed this life 22 March 1829, 35 yrs. 7 mos."

Elvira Ann inherited Armenia Plantation on the Savannah River in Barnwell District and most of Laurium Plantation near Pocataligo in Beaufort District from the estate of James McPherson. An 1830 agreement between her and her mother in law, Susan Miles McPherson, settled the estate of her late husband. In the agreement, witnessed by Nathaniel H. Rhodes, Susan McPherson obtained possession of Cotton Hall Plantation adjacent to the Laurium Plantation. Nathaniel Henry Rhodes was great nephew to Susan McPherson and brother in law to Elvira Ann.

After James McPherson's death, Elvira Ann was married to the Reverend Elliot Estes of Virginia at Armenia Plantation on December 16, 1830, by the Rev. William B. Johnson. Elliot Estes was born in Caroline County, Virginia, on June 23, 1795, and died in Barnwell District on June 9, 1849. They lived at Orange Grove Plantation. Reverend Estes preached at Beech Branch, Smyrna, Mt. Arnon and Springtown. His portrait was painted in London by Roon who painted only men of the cloth. Elvira Ann and Elliot are buried at Concord Cemetery in Allendale County, S. C. Her tombstone has this inscription:

FROM THE TOMBSTONE OF ELVIRA ANN ESTES

THE REMAINS OF MRS. ELVIRA ANN ESTES
RELICT OF REV. ELLIOTT ESTES
ARE HERE DEPOSITED.
SHE WAS BORN SEPTEMBER, 1797,
AND DIED MARCH 5, 1862,
AGED 62 YEARS, 5 MONTHS AND 16 DAYS.
SHE WAS A ZEALOUS MEMBER OF THE BAPTIST CHURCH
AND LIVED A PIOUS AND USEFUL LIFE.
WAS A TRUE AND SINCERE FRIEND EVER READY
TO DO FOR OTHERS WHICH WAS HER GREATEST PLEASURE.
WINNING THE LOVE AND ESTEEM OF ALL AS A PARENT
THE MOST SACRIFICING AND DEVOTED.
SHE LIVED THE LIFE OF THE RIGHTEOUS
AND HER LAST END WAS LIKE HIS.

MY MOTHER IS GONE HER WORK IS DONE AND SHE IS FULLY BLEST. SHE FOUGHT THE FIGHT, THE VICTORY WON AND ENTERED INTO REST.

BLESSED ARE THE DEAD WHICH DIE IN THE LORD, HE BEING DEAD YET SPEAKETH.

She was the daughter of Thomas Willingham and Phoebe Lawton Willingham. He was a planter and a Baptist minister. His real estate in 1860 was reported as worth \$35,000 and his personal estate worth \$107,500. He was a Confederate officer and lost all of his property and over 200 slaves after the War Between the States. He served as pastor of the Pipe Creek (later Lawtonville) Baptist church in 1882-84. He and his wife are buried in the Corcord Baptist Church cemetery in Allendale County, S. C.

Children of Andrew B. Estes and Anna Willingham were:

- (1) Elliot, born 08-28-1853, death date unknown, married on 11-16-1875 to Julia Helena Ross. Moved to Macon, Ga.
- (2) Thomas Willingham, born 05-18-1855, death date unknown, married Mary Steinmetz. Was living in Philadelphia, Pa., in 1893
- (3) Phoebe Sarah, born 12-14-1856, death date unknown, married C. W. Hickman. Was living in Hampton, Va., in 1893.

  born 01-21 1859, died March 13, 1918,

  Blackshear, Ga. in 1879. He was mayor of Blackshear in
  1890, 1897, 1906 and 1907. He served in the Georgia House

They had a son George Willingham, who lived in Macon, Ga., and was at one time an attorney in Atlanta.

- 2. Adeline Eliza Hagood who died at Mt. Ararat, Barnwell District, in 1807 at the age of 3 years and 5 months. It is not clear that this is the second child of Gideon and Harriet Hagood since the birth dates of the others are not known.
- 3. Yonge Johnson Hagood changed his name to Francis Yonge Hagood. There is no official legal record of this name change. He is however referred to as Francis Yonge Hagood in a document in the Court of Equity records of Barnwell County, S. C. There is mention in the Annals of Georgia of the marriage of Francis Yonge Hagood, son of Gideon Hagood and Harriet P. Hagood, in Effingham County, Georgia, on February 28, 1828, to Mary Morel, daughter of Benjamin Morel and Sussanah Gindrat Morel. There appeared in the "Daily Georgian" in Savannah on May 16, 1833, a notice from the Effingham County Superior Court concerning a bill of divorce filed by Mary G. Hagood against Francis Y. Hagood. Nothing is known of any children Francis and Mary Hagood may have had or anything else about them at this time.
- 4. Harriet Amanda Hagood married John W. Rabun of Hancock County, Ga., in Hancock County on or near January 1, 1828. They were married by the Rev. Jonathan Davis.

  He was the only son of the late Governor Rabun of Georgia (who died in office in 1819) and Mary Battle.

  Harriet died in Hancock County on October 30, 1834, at the age of 25 years. She was a member of the Baptist Church at Powelton in Hancock County and may be buried there.

  An account of her death in "The Southern Recorder" says she was the second daughter of Gideon Hagood.

  He apparently married twice after the death of Harriet

Amanda. The 1860 census of Chatham County, Georgia, lists him as a merchant with real estate worth \$5000.00. Among the members of his household is Julia M. Rabun, This is his daughter by 21 years old born in Georgia. Harriet Amanda Hagood Rabun. Her full name was Julia Maria Rabun. The 1860 census identifies John W. Rabun as a merchant and cotton factor in Savannah. Julia is not living with him in 1860. He died in Savannah on August 7, 1866, at the age of 58 years and is buried in Laurel Grove cemetery there. Julia appears in the 1860 census of Barnwell District, S. C., as the 30 year old wife of Isaac M. Wood, 48 years old, planter, with real estate worth \$27,715 and personal property worth \$60,535. Members of his household were:

- 2 T. S. Wood, Female, 22 years old.
- 3. J. A. Wood, Female, 17 years old, attending school.

The children Rabon (Rabun??) and H. D. are apparently the children of Julia and Isaac. The others must be his children by a previous marriage.

The census index has Thomas G. Hagood listed as Hagwood. The original writing led to this mistake. Thomas Rhodes, son of Thomas Hagood's sister, Susan Julia Hagood Rhodes, was living with him. The C. W. Beard is the child of Martha E. Rhodes by her first marriage.

Thomas G. Hagood appears in the 1870 census of Colleton County, S. C., as follows:

Thomas G. Hagood, 60 yrs., farmer Margaret Hagood, 50 years, wife Clarence, 20 yrs.

The age of Margaret in the 1860 and the 1870 census is the same which is obviously a mistake.


Nothing else is known at this time about Thomas Gideon Hagood and his descendants.

- 6. Susan Julia Hagood married Nathaniel Henry Rhodes. Their children were Thomas, Nathaniel, Virginia, Julius and Emma. Their descendants can be found in <u>The Thomas Rhodes Family of South Carolina</u> by Alice Rhodes Rogers, published in 1991. Thomas Rhodes' grandmother, Mary (Cater) Rhodes Lawton, was first cousin to James McPherson, first husband of Elvira Ann (Hagood) McPherson Estes.
- 7. Emma McPherson Hagood, mentioned as a child of Gideon and Harriet Hagood in the will of Gideon Hagood, is not mentioned in the 1817 will of Susannah Yonge, Harriet's mother. She must have been born between 1817 and her mother's death in 1820. The middle name McPherson might ordinarily imply that she had been married to a Mr. McPherson. She would have been too young at the time of her father's will to have been married. Nothing else is known about her at this time. She seems to have survived at least until 1832 according to other records.

Eliza, the lovely daughter of Ralph Izard, Jr., was painted twice by Malbone during his December 1801–May 1802 visit to Charleston. Her mother is identified in the account book for December, 1801, as paying \$275, probably for three or four portraits. During this time Eliza was being courted by Thomas Pinckney who was most eager for her to be painted by Malbone. They married in December, 1803.

A good example of the "fair becoming still fairer," the miniature of Eliza verges on a romantic interpretation, in the manner of Cosway. The hair softly piled high, the faraway, dreamy gaze and the cloudy background all relate to the style of the English master whom Malbone is known to have admired. However, through the brushstroke and coloring, Malbone has given the sitter substance and credibility.

The identity of the sitter is not certain. She bears a resemblance to Eliza Izard in dress, hairstyle and facial features, and the provenance of the miniatures is the same. It may be one of the three or four miniatures Mrs. Izard paid for in 1801. The identity of Louisa Charlotte is traditional, but probably incorrect; in 1801 Louisa Charlotte would have been less than eight years old. It may in fact be another Izard daughter, possibly Mary (1780? – 1858?) or Patience (1786? –

1860). Tolman includes the work in his book as an "unknown young lady."

Placed almost in profile, the sitter becomes a little remote. Details in the background, such as the tree, serve to balance the composition.

McPherson served as lieutenant colonel of the 20th Regiment before being promoted to Brigadier General of the 5th Brigade. He lost his life during the shipwreck of the Rose in Bloom. A marble memorial carved by the


Flemish artist John Devaere commemorating the tragedy was rejected by the Scots Presbyterian Church for which it had been intended because of the immodesty of the figures, one of whom was Elizabeth McPherson. The monument is now installed at the Gibbes Art Gallery.

McPherson, wearing his uniform, is shown as a solid individual. Usually dated to 1801, the miniature may have been painted before Malbone's trip to London, after which time the portraits are lighter and more idealized.
