

Explanation

Family members are listed in numbered sequence from David Howell of Glamorganshire, Wales, to Isabel Howell. These numbers, just to the left of the vertical line, may be thought of as "I.D." numbers. Often another number will appear to the far left of a person's I.D. number. This indicates where that person's name will to be found elsewhere in the listing. Example: when a child becomes head of his/her own family. When Isabel became a Brown, the sequence is altered somewhat because the Brown genealogy, done earlier, is simply appended to the present Howell genealogy. The names are all in proper descendancy, but their I.D. numbers are those of the Brown record. I have not tried to make them conform to the Howell record.

Heads of families with their Roman numerals are in large bold CAPITALS. The Roman numerals indicate the generational descent from David of Wales.

Children of a family are listed by Arabic numbers to the right of the vertical line, their names usually printed in small CAPITALS.

Grandchildren's names are indented in plain or italicized print. Usually no I.D. numbers.

Great grandchildren's names are further indented and are in small standard or italicized print, no I.D. numbers.

Abbreviations, when used, are usually self explanatory: b, born or birth; ch, child or children; d, died or deceased; m, married or marriage; dr or dau, daughter; bap, baptized; chr, christened; sp, (sine prole) without issue; unm, unmarried; w, widow or widower; abt or c, approximate date. Towns, counties, and states are abbreviated in the customary manner, the names of months are often spelled out or abbreviated; this is to avoid the uncertainty inherent in numbering the months. Example: 4-3-95 could mean April third to one person and March fourth to another. To avoid confusion of centuries, four digit numbers are used to designate the year.

Superscripts refer to the source of facts recorded. I have listed these sources, more for my own convenience of organization than for the benefit of readers. These references fill about six notebooks from which items can be retrieved for anyone interested in such detail.

It has been reported that Anna Treat, wife of John W. Howell, was descended from William the Conqueror. This is a collateral listing of twenty-nine generations which I have not included. My record, beginning with David of Wales, is relatively recent by comparison. All the data are substantiated by documents or gleaned from personal knowledge of living descendants. The few assumptions or speculations are so noted.

(II) WILLIAM HOWELL, born in M. T. on November 29, 1790^{2,14,5}; Worked as a collier¹⁵ in the mines of Glamorganshire. On Sept 14, 1812, he married Ann Evans^{4,5} who was born in 179217. They became members of the Wesleyan Methodist Church in Wales. Migrated with their two children, Margaret and David, to America in 1816 where they joined the M.E. Church in Fayette County, PA. The family moved from Pennsylvania to Bridgeport, Belmont County, Ohio in 18312; William and Anne with Benjamin (and perhaps other children) moved to Bureau County, IL in about 186016. Bureau county was the site of several highly productive coal mines. It is not known, whether or not William engaged in mining there. At his death he owned a farm of 105 acres with timber lot3 which was sold by his heirs to Benjamin F. Howell (son and heir) for \$5,275.3 In addition, about \$2000 of his estate was divided among the five surviving children. (Jacob had died in 1862.) William and Anne both died near the town of Dover, Bureau County, IL2; she on December 9, 18712, he on May 1, 18743 at the home of his son Benjamin F. Howell, with whom he was living at the time of his death¹⁸. His

obituary² reports that they had nine children; record search finds names of only six, though census of 1850 lists three not documented elsewhere. Five children survived them.

1. MARGARET HOWELL, baptised in Merthyr Tydfil. on December 5, 1813⁶. Came to America with parents in 1816, settled with them near Uniontown, Lafayette County, PA, and later moved with them to Bridgeport, Belmont County, OH. Married George Berry in 1830; he died in 1853. Margaret died in Bridgeport, OH, on January 16, 1885. Two brothers, one sister, and four sons survived her².

2. DAVID EVANS HOWELL, born in Merthyr Tydfil, Glamorganshire, South Wales, christened on January 21, 1816¹⁵ In that same year he and his sister Margaret were brought by their parents to America².

- 15 8. BENJAMIN HOWELL, born July 2, 1835, in Ohio³⁸. Perhaps named for his Welsh uncle Benjamin. In 1850 in Bridgeport, OH, he was in the household of David and Susannah Howell, designated as "clerk". He was then only 15, probably employed by his older (merchant) brother David¹². Benjamin arrived in Bureau County, Illinois, in December 1861. On Dcember 24, 1862, he married Mary E. Mobler,³⁸ a native of Illinois whose parents were natives of Pennsylvania. He was a successful farmer in the town of Berlin: served as president of his grange, visited Chicago Exposition with his wife in 1874, was awarded Bureau County Fair Premiums for his horses in 1873/74, visited Whiting, Kansas, in 1879¹⁸, and owned a 160 acre farm in Jackson County, Kansas. He was a member of the local chapter of I.O.O.F.40 William Howell died in Benjamin's home where he had been living during his last illness3. Benjamin died intestate⁴⁰ at his Bureau County home on July 29, 1880, leaving his wife and four children:

[§] Included in Wm Howell household in 1850 Belmont County census, but not yet proven to be family related; possible borders, household help, hired hands, etc.

- 9. JACOB HOWELL, born abt 1830¹⁷, in PA, probably in their Fayette County home, just before they moved to Ohio. He was 19 in 1850, occupation: miner. He married Sophia ______. Jacob, Sr, died May 20, 1862, ten days before the birth of their only child, Jacob F. (Jacob, Jr.). The inheritance due Jacob was held by his father William to benefit Jacob F. until he attained age 21. William died before that time, and the inheritance was assigned (by William's will) to the care of Jacob's brother David E. Howell³ but managed by John Warfield, executor of both estates. A watch belonging to Jacob Sr. was held by brother Benjamin F. Howell until Jacob, Jr. attained majority^{3a}.
- 17 (III) DAVID EVANS HOWELL, born in Merthyr Tydfil, Glamorganshire, South Wales; christened on January 21, 1816¹⁵. In that same year he and his older sister Margaret were brought by their parents to America. The family settled first in Fayette County near Uniontown, PA, a region rich in coal and iron. They moved to Bridgeport, Belmont County, OH in 1831³ when David was about 16. He was first engaged in the wagon and carriage business, and later became a grocer²⁹. Early in 1839 or before, when he was about 23, he married SUSAN MARDIS who was born in Natchez, Mississippi, in 1822²². In 1840, David, Susan, and Melvina lived in Kirkwood Town, Pease Township, Belmont County, OH. 12 He served as justice of the peace of Pease township in 1860 and 1880²³ and was postmaster at Bridgeport for eight or nine years²⁹. was a preacher in the West Bridgeport Methodist Episcopal Church²⁴. When his parents, and perhaps brothers and sisters, moved to Illinois in 1860, David remained in Bridgeport with his ever increasing family of children. He was 69 years, 9 months, and 15 days old when he died of consumption on Oct. 15, 1885, his

occupation recorded as "minister" 25. He died in Bridgeport where he had lived for forty-five years 29. He was buried in Belmont County, OH; his tombstone inscription and famly record list him as Rev. David E. Howell. His wife Susan died in 1911.

It is not known what events brought David and Susan together, she from Natchez, MS, and he in Bridgeport, OH. Their first child, Melvina, was born Dec 8, 1939²¹, in Bridgeport, Ohio. They had 12 more children, 13 in all³⁰.

- 1.8 MELVINA A. HOWELL b. Dec 8, 1839; married William Smith Warfield on June 7, 1859. He was then living in Bridgeport, listed as "clerk". Melvina died May 30, 1907. (See extensive Warfield genealogy¹¹).
- 2. ROBERT T. HOWELL, b Nov 22, 1841. After receiving a practical education in the Bridgeport common schools he joined his father in the D. E. Howell & Son. hardware business. After six years he sold his interest to his father and went into the produce business, engaging in this for some fifteen years, after which he entered the insurance and real estate business. Robert also served as justice of the peace of Pease township.

 On May 7, 1867, he married Rebecca L. Worthington, a daughter of Rev. N. C. Worthington, a Methodist minister of Bridgeport. Robert served during the Civil War as a member of Company A, 107th Ohio voluntary infantry²⁹. He died in 1913²⁰ Five children: 12: 29: 30

- (IV) DAVID EDMOND "ED" HOWELL Born in Bridgeport, Ohio, on November 15, 1858. Moved to Quincy, Illinois, to join William S. Warfield in the wholesale produce business, known then as the Warfield Grocer Company. In Quincy he met his future wife Margaret Lynds, daughter of Daniel E. Lynds and Isabel (Young) Lynds. (see LYNDS genealogy). Daniel was a native of Nova Scotia and was engaged in the wholesale drug business in Quincy. David Edmond Howell and Margaret Lynds were married in Quincy on December 9, 1884²⁸. When the Wholesale Grocer business expanded, it became known as the Warfield Pratt Howell Company of Iowa with offices in Des Moines, Cedar Rapids, and Sioux City. For several years David managed the Sioux City branch, and then moved with his family in the 1890's to Cedar Rapids to take charge of the Cedar Rapids Office. David and Margaret lived together until she bcame ill. Her illness made it impossible for her to travel to Quincy, IL, in 1899 to attend the funeral of her father Daniel E. Lynds³². Her continued disability required constant nursing care after about 1910. She was living in an apartment in Chicago with a nurse in 1920³³, and died there in 1940³⁴. The nature of her illness is not known, but a mental disturbance is suspected. David remained supportive throughout her illness, but lived in Cedar Rapids with his daughter's family, and died there in 1935. David and Margaret had one child:

- Graduated from University of Illinois, College of Architecture. Studied in New York City for several years and came to Cedar Rapids, Iowa, about 1909. He married Isabel Howell of Cedar Rapids on September 7, 1914. William Jay and his brother Frederick intended to practice architecture together, but when Frederick died in 1911, William Jay established his office alone in Cedar Rapids. He continued his practice interrupted only by his army service during World War I, and became one of the best known architects in Iowa. He designed, principally, school and municipal buildings, among them Franklin High School, the Municipal Court House building, and Coe College buildings, all in Cedar Rapids; the Cornell College Chapel in Mt. Vernon, Iowa, and school buildings elsewhere in the state. He was active in Boy Scouts of America, serving as scoutmaster for a number of years. He died on February 4, 1970 in his 92d year. Children:

- (H VI; B X) DAVID HOWELL BROWN, born March 22, 1916, in Cedar Rapids, Iowa. Graduated from Washington High School, Cedar Rapids; attended Cornell University, Ithaca, N.Y. elected to Tau Beta Pi, the honorary engineering society, in his Junior year, and graduated in 1938. He was on the track team at Cornell, and continued his earlier love for music with his violin, playing in the University musical groups. After graduation he joined the Exxon Compay USA and continued with that compnay for 48 years as a staff analyst until his retirement. His work took him first to Elizabeth, N. J., for a few years, then to Baton Rouge, Louisianna, where he remained until his death on April 26, 1988, at the age of 72. He was a member of the Baton Rouge Symphony and Downtown Kiwanis Club. He married (first) Elizabeth Abernathy, native of Erin, Tennessee, on August 10, 1939. Children:

Princeton

When I was in my early teens, our family occasionally visited the John Warfield family on Kenwood Avenue, Chicago. In adult conversation there I often heard the name *Princeton*. I assumed, with some awe, that they had an affiliation with that pretigious university in New Jersey. But being young I paid little attention to their conversation and showed less interest. The name *Princeton* stuck in my mind, however, and it was not until some 60 years later while I was digging into family history that the *Princeton* they reminisced was actually the small town of Princeton, Illinois, the place of their earlier lives.

When William and Anne Howell came from Wales they settled first in Fayette County, PA, then moved to Belmont County, OH, and finally made their way to Bureau County, IL. What prompted William to seek out these places for his family is uncertain. It is known, however, that William was a coal miner in Wales, and that he came to regions rich in mining of both coal and iron. They had 9 children; 6 of whom are discovered in the records. The oldest son David Evans Howell remained in Bridgeport where he and his wife Susan (Mardis) Howell raised thirteen children. Parents William and Anne Howell made their way to the coal mining region of Bureau County, Illinois, and settled in or near the town of Princeton in about 1860. Whether he persued mining there is not known, but he eventually lived on a farm of 105 acres with a timber lot. Their two sons, Benjamin and Jacob came with them to Bureau County. Benjamin was a successful farmer and prominent citizen in Princeton; Jacob's occupation is not known, but he too was probably a farmer. He died quite young just ten days before the birth of his only son. William, Anne, Benjamin and Jacob lived out their lives and died in Bureau County. John Warfield arrived in Bureau County, simultaneously with the Howells, having previously made close business and social ties with them in Bridgeport, Ohio. John Warfield served as executor of William Howell's estate in Princeton, as he did also for the estate of William's son Jacob Howell. David Evans Howell made a visit from Bridgeport, OH, to Princeton just before his father William died. One of David's sons, John W. Howell, married Annie Treat in Princeton in 1873. John Warfield's son William Smith Warfield married William Howell's granddaughter Melvina Howell (oldest daughter of David Evans Howell and Susan Mardis Howell).

Their son John David Warfield is the person whose home my family visited in Chicago, the home where I heard the impressive conversation about Princeton. Now I know that their Princeton is not that New Jersey University, but the small Illionois town that played such an important part in my family's history. My mother was a first cousin of John David Warfield.

The town of Princeton, the Bureau County seat, is located about half way between Chicago and Moline. It is now grazed by the new Interstate 80, but is still a prosperous farming community, and with its beautiful old homes, retains much of its original charm.

Mardis Ancestry

Tracing the Mardis ancestry has been difficult for a number of reasons. The name is found frequently in early Virginia records spelled variously as Mardis, Mardus, and Marders, with given names of Rowley, Rolla, Rolly, Rolley, and Rowland. To complicate things further, a person of one name is sometimes listed as having married different wives. Further complicating the search are the political upheavals of the War of Independence from England and the Civil War, and finally the recognition in 1792 of Kentucky as an independent state, separating it from its former status as a part of the original territory known as the "Old Dominion" of Virginia. After independence from England there was a massive migration westward from Virginia which found family names recorded as being born in Virginia, but later turning up in Kentucky. Was this because of migration or because the territory assumed a new name?

The most likely sources lead to the impression that Rowley Mardis, Sr., was the early progenitor. Even here, the given name is variously listed as Rolla, Rolly, and Rowland. Ancestral File of the Latter Day Saints, lists a person of this name as being born in King George V County, located in eastern Virginia on the Patomac River. A Rowley Mardis is listed as marrying a Frances "Fanney" Durrett, but this does not track with the family records of the Mardis family in Natchez which show that Rowley married Elizabeth _____ (maiden name unknown). There are many other Mardis entries in the Virginia and Kentucky records with a variety of spellings of the given names, including Rowley.

With these puzzling factors aside, the following genealogy is more firmly founded, much of it provided by Mardis descendants in Natchez, Mississippi.

On her death bed, Sally Mardis requested that her brother Thomas Stewart and his wife, then living in Louisville, KY, take Susan into their family and raise her as their own child. Abner and Lucy were placed in jurisdiction of the Orphans Court under the protection of their older half sister Amanda. Rolley's brother Abner wrote to Thomas telling him of the tragedy and forwarding Sally's plea. If Sally's deathbed request was honored, Susan was adopted into the Stewart family. Louisville census for 1830 records only age groups, not names, but the female in the 5<10 age group listed as member of the Thomas Stewart household could have been Susan (born in 1822) If she was not adopted by the Stewarts, she was probably raised by her older half sister Amanda in Natchez. When she was in her late teens she met a young Welshman named David Evans Howell. How this meeting came about is not known. It is not known whether the Stewart family with Susan moved north or the young Welshman joined the Ohio River traffic and met Susan in Louisville or Natchez. But Belmont County. OH, census of 1840 lists David and Susan living with a child under 5 years of age. This would be their first born Melvina who was born in 1839.

David Howell and his sister Margaret were born in Wales and brought by their parents to the United States in 1816. The family settled in Fayette County, near Uniontown, PA, and in 1831 moved to Bridgeport, OH. Somewhere - Natchez, Louisville, Fayette County, or Bridgeport - David Evans Howell met Susan. She was still in her teens, he in his early twenties, when they married. They set up housekeeping in Bridgeport where they spent the rest of their lives, producing a family of thirteen children. Their oldest child Melvina was born in December, 1839. Their eleventh child was David Edmond Howell, born in November 1858.

This is an exact, word for word, copy of the letter written by Abner Mardis, October 18, 1823. Mr. Stewart, to whom the letter is addressed, was the brother of Sally (Stewart) Mardis, wife of Rolley Mardis. Rolley died Sept 17; Sally died Sept. 22, 1823, both victims of Yellow Fever.

Mr. Thomas Stewart

Louisville, Kentucky

Sir:

It becomes my sorrowful and painful duty to inform you of the death of your sister Sally and her seven months child, who died a few days after brother Rolley, a victim of Yellow Fever.

On her death bed she requested and implored that you would take her daughter Susan and you and your wife would rear it up under your protection. Susan is here on the plantation with her sister Lucy. Should you send for the child, address a few lines to me and I will attend faithfully to the contents thereof, and will see about the clothing of her mother which I have had laid aside and reserved for the child. Amanda's husband (Mr. Glasscock) intends to administer on the estate but on account of the prevailing epidemic will not be able to get letters of administration before the month of December.

Should you think it proper to decend (misspelling as in document)) the river to see to the adminstration or administer yourself, you had better come in time. There will be enough to pay the debts due by the estate and something left to the children. Under envelope is a letter to your father informing him of the death of your brother John, who died twenty-five miles from my plantation.

I had procured for him the berth of mail-rider. It appears that he got the infection in Natchez or this neighborhood and after having traveled as far as thirty miles, became unable to return. He died on the 19th

Yellow Fever


At different periods in the earth's history, both the old world and the new have been scourged by epidemics of yellow fever, which were never arrested by any of the means employed for the purpose. On every occasion the disease ran its course unhindered, the only fact clearly determined being that its abatement was always preceded by cooler weather. It was the prevailing opinion that the disease was introduced into America by sailing ships from the West Indies. The southern ports were principally affected, but severe epidemics occurred also in the northern port cities of Philadelphia, Boston, and New York. The little river town of Natchez, MS, was not spared.

Theories on the transmission of yellow fever were as numerous and varied as were the methods of its treatment. It was not until about 1900 that significant progress was made in the control of the disease when it was determined that the mosquito Aedes Aegypt was the vector responsible for its spread. In 1900 the U.S. Army Commission on Yellow Fever went to Havana, Cuba, made a house-to-house attack on the breeding places of mosquitos, and eradicated the disease in two years.


The story of the Panama Canal is well known. The French, who earlier built the Suez Canal, abandoned their attempt to build the Panama Canal principally because of the disastrous yellow fever mortality of their workers. Again the U.S. Army's Yellow Fever Commission took charge, eradicated the mosquito and the disease, and enabled the completion of the canal by American workers.

Among other southern ports, New Orleans suffered heavily from yellow fever. Epidemics raged in that city 39 times between 1793 and 1905. In the epidemic of 1854 there were 30,000 cases with 7,000 deaths. Natchez, a short distance up the Mississippi from New Orleans, was a bustling river port, plying barges and steamboats with cargo and passengers to and from New Orleans. It was all too simple for mosquitos to hitch rides on the river boats and make their way to Natchez.

It was not until 1900 that yellow fever was eradicated from America. But, alas, Susan Mardis was born in Natchez in 1822. Her father Rolley Mardis and her mother Sally (Stewart) Mardis contracted yellow fever; both died within a week of each other in September, 1823. They left four children, one of whom was Susan, orphaned at less than two years of age.



<u>Sally Stewart</u> had two brothers: <u>John</u>, a mail-rider on the Natchez Trace who died on the Trace at the same time and of the same Yellow Fever that took Rowley and Sally, and <u>Thomas</u>. The Stewart family lived in Louisville, KY. I have no knowledge of the parents, who would be my g.g.g.grandparents.

 They settled on the south side of the Salmon River. A monument in the Onslow Cemetery was erected to the memory of Thomas and Elizabeth by their son Daniel. It is not beyond reason to suspect that our Daniel Eason Lynds, then in America, erected the monument to his parents. He had achieved considerable success in America and was financially well able to afford such a tribute. But there is that other mysterious Daniel (#42).

There is a discrepancy in dates here. Olive married in 1845, had two babies who died in infancy, the second one born in 1849 ----but Olive died in Nov. 1848.

47 (VIII) DANIEL LYNDS, born in Truro, Nova Scotia on July 31, 1830, the youngest child of Thomas and Elizabeth (Clark) Lynds, also natives of Nova Scotia. He migrated to the United States, the date and port of entry we do not know. He came to Quincy, Illinois, in the sixties, and on June 7, 1860, married Isabella Young, then 17 (with consent of her mother.) Her parents, John B. and Mary Young were natives of Missouri, but had lived for years in Quincy. Daniel was a painter by trade and established himself at 527 Main Street dealing in wall paper, window shades, paints, oils, glass, and brushes. He was a good business man and shortly after his arrival established the business later conducted by Young Bros. At about 1875 he embarked on the wholesale drug business with Aldo Sommer at 50 N. 3rd St. From 1875 to 1888 he served as vice-president or president of the Sommer, Lynds wholesale drug company, and resided at 401 Elm Street. His son Thomas E. Lynds of the same residence was a clerk in the company in 1884-5. In 1887 Daniel went to St. Joseph, MO. and entered into partnership there with T. F. Van Natta also in the wholesale drug business, but returned to Quincy in 1890 to the Sommer, Lynds firm. He was granted U.S. citizenship in 1895. Daniel's health had been failing for several years prior to his death, and became gradually worse after the Sommer-Lynds fire in 1895. In May of 1899 he went with his wife to Cedar Rapids, Iowa, to visit his ailing daughter, Margaret Lynds Howell. He died at his daughter's home on June 7, 1899. Cause of death given in his obituaries was "paresis," and by the Cedar Rapids mortuary as "nephritis.". His body was returned to Quincy for funeral services at the Unitarian Church. His daughter Margaret Howell was too ill in Cedar Rapids to attend the services. Daniel's body lies in Woodland Cemetery in Quincy. His tombstone, inscribed DANIEL EATON LYNDS, stands just behind the mausoleum in which are sealed the bodies of his wife Isabella and his daughter Margaret Howell, both of whom died some years later. Three children:

48 1. OLIVE, b 1861. Married _____Blount, and lived with her husband at rue d'Orleans, Neuilly sur Seine, France. Olive had visited her parents in Quincy, Illinois, a few weeks before her father died. Olive died in 1911, and is buried next to her father in Quincy, IL. She and her children benefited from her father's will. Children:

49|2. MARGARET, born April 2, 1864, in Quincy, Illinois. She was 20 when she married 26 year old David Edmond Howell in Quincy, Illinois, on December 6, 1884. They had only one child, Isabel, born on July 5. 1888. Margaret became ill late in the 1890's while living in Cedar Rapids, Iowa, with her husband. Her father and mother came to Cedar Rapids to visit her and her father died there. Margaret was too ill to attend her father's funeral services in Quincy, IL, in 1899. Cedar Rapids city directories of 1907-08 show her living there with her husband, but 1920 Cook County, IL, census shows her living in Chicago at 2326 Cleveland Avenue, a comfortable small apartment with an attendant nurse. Exactly when she moved to Chicago is not known, nor is the exact form of the illness which had its onset in her early thirties, and persisted throughout the last 35-40 years of her life. It was apparently a form of dementia incompatible with life in open society. Supported by her husband, she lived there with the nurse attendant until she died in September 17, 1940, at age 76. Her death certificate records the cause of death as breast cancer with bone metastases and aplastic anemia. She was buried with her mother in a mausoleum in Woodland Cemetery in Quincy, IL. Child:




permission of her mother to be married. She and Daniel had three children: Olive, Margaret, and Thomas E. Lynds (see genealogy of Daniel E. Lynds.) At her husband's death in 1899, she became executrix of his estate. She remained attentive to the needs of her daughter Margaret who came under private nursing care in an apartment in Chicago. Isabella moved from Quincy to Chicago and occupied an apartment at 452 Belden Avenue, about a block away from the apartment occcupied by daughter Margaret. She died there on

February 15, 1921, and was interred in a private "LYNDS" mausoleum situated high on a hill overlooking the Mississippi River in Woodland Cemetery in Quincy, Illinois. Her daughter died in 1940 and was placed in the same mausoleum with her mother. Margaret's husband, David Edmond Howell, lived with their daughter's family in Cedar Rapids until his death in


1935, and was buried in Cedar Rapids, Iowa. Some years later their daughter Isabel and her husband William J. Brown were buried in the same cemetery

next to his grave site in Cedar Rapids. (see Brown genealogy)






Susan Mardis Howell 1822 - 1911 Hair and dress styles: 1886-1890 Susan would have been 64-68






J. W. Howell's 90th birthday March 1940





An unnamed family photograph mounted on a cardboard frame embossed "Bernard ... Quincy. Ill." Facial features bear a strong resemblance to Isabel Howell, suggesting that the pictured person is Margaret Lynds Howell, Isabel's mother. Dress and hair styles are those of 1895 when Margaret would have been about 30, an age consistent with her appearance in the photo. She was a native of Quincy, Ill . Absolute identity is impossible, but evidence is persuasive. Some years later she became ill, moved to Chicago (perhaps for medical treatment) where she lived in an apartment with a nurse attendant. Her whole life is shrouded in mystery. She died in her Chicago apartment in 1940.







Burial site of







