

Daniel Jaudon, born c. 1685 on the Isle de Re, France, son of Elie (Elias) Jaudon and Sara Bortoneau, accompanied his mother and her second husband, Pierre Michant, to South Carolina in 1696, being among those French refugees who petitioned for naturalization in 1696. He witnessed the Dec. 1705 will of Daniel LeDuc (THSSC 11 p. 11) of Craven County and the 18 Mar. 1720 will of James Innes, Esq. of Berkeley County (WVA 1720-1721 c. 2 p. 26). ^{Daniel Jaudon had a warranty for 50 acres of land in Craven County, 5 June 1710.} On 25 Jan. 1731 both he and his oldest son, Daniel

Jaudon, witnessed the will of Francis Pagett, Berkeley County planter. Daniel Jaudon married c. 1708 Elizabeth, surname not now known, who made her will 12 April 1743, being "of the Parish of Prince George, County of Craven, resident" in which she directs her executor to "sell all my land I possess", dividing the proceeds among her three youngest children: Paul, David and Eliza Jaudon. On 19 Feb. 1731 Daniel Jaudon sold for £700 to Stephen Miller, Charles Town shopkeeper, 500 acres bounding west on Cooper River and south on Murrells Creek. The births of the first eight children of Daniel and Elizabeth Jaudon are recorded in the Register of the Parish of St. Thomas & St. Denis; the three youngest children are mentioned in their mother's will, suggesting that the family may have moved back to Craven County after 1724.

Daniel Jaudon, Jr. (Daniel) - 2 -
 born 19 Jan. 1710 in the Parish of St. Thomas & St. Denis, son of Daniel and Elizabeth Jaudon. With his father he witnessed the 25 January 1731 will of Francis Pagett, Berkeley County planter. On 18 July 1738 Daniel Jaudon ^{planter of St. James Santee in Craven County} and his wife Mary Ann Jaudon sold 400 acres in Princez Frederick Parish, Wingah to George Chicken of Berkeley County. On 30 November 1744 Daniel Jaudon witnessed the will of Noah Serris, Esq. of St. James Santee who mentioned John Jaudon and Noah Michau among his god children and his "brother Abraham Michau". David Caw, Esq. of Charles Town in his will of 21 September 1758 left a bequest to "each of the children of Daniel Jaudon, late of Santee, planter, deceased". Among the children of Daniel and Mary Ann Jaudon were:

Elias Jandon (Daniel'), born 21 August 1715/ son of Daniel and Elizabeth Jandon, member of the Council, Captain, Santos Co., S.C. militia; married c. 1736 Elizabeth Robert (c. 1715 - 4 Sep. 1758), daughter of Pierre Robert, Jr. (1675-1731) and his second wife, Judith de Bourdeaux. Elias Jandon of Craven County made his will 23 Jan. 1748, proved 26 April 1751 (W Bk 1747-1752 p406) naming his wife Elizabeth, mentioning but not naming their children. Executors were his wife, Isaac Le Grand and Philip Norman; witnesses were his brother-in-law Jacques de Bourdeaux Robert and Isaac Gonce. On 2 July 1739 Elias Jandon sold 200 acres to Isaac Chovin. (ms. BRL-L p.328). The children of Elias and Elizabeth (Robert) Jandon were:

Sarah Jandon (Daniel'), born 24 September 1719 in the Parish of St. Thomas & St. Denis, daughter of Daniel & Elizabeth Jandon, married 26 August 1735 Jacques de Bourdeaux Robert, born 3 April 1711 at French Santos, died November 1774 in Prince William's Parish, Granville County and was buried in an unmarked grave in Stony Creek Churchyard. Sarah Jandon Robert died 6 April 1779 in Rebertville, St. Peter's Parish.

4. Elias Robert, born c. 1747 at French Santee, married 1775 Nancy Rue, born S. C. 1758, died at Savannah, Ga. 18 May 1815. Elias Robert, planter and surveyor, had grants for 150 acres on Davis Branch, Saltkatchie Swamp, ^{Orange} Co., 14 June 1771, for 500 acres on Black Swamp, St. Peter's Parish 2 April 1773 and for 150 acres on Cypress Creek 10 Feb. 1775. He apparently donated property for Black Swamp Baptist Church some 2 1/2 miles northeast of present Robertville when it was organized in February 1786 and was its first messenger to the Charleston Association. He was dismissed to the Savannah church in 1800 and died in Scriven Co., Ga. in 1820. Family records say he was a charming and beautifully educated but rather "ineffectual" man; the 1790 census shows him planting with only three slaves in Robertville where his five children were born. Paul Jaudon (Daniel), born 21 September 1724 in the Parish of St. Thomas and St. Denis, son of Daniel and Elizabeth Jaudon, married 24 Dec. 1743 in Prince Frederick's Parish, Wingate, Margaret Lieubray, daughter of Peter Lieubray, planter of ^{Crown Co.} Prince Georges Parish. He will of 12 July 1742, passed 11 Jan. 1745, bequeathed his estate to be sold for the benefit of his two daughters, Margaret and Mary, when they are 18 years old or married.

Paul Jandon "of Prince George Parish" made his will 19 March 1769, records 5.
24 January 1774 with his son Paul Jandon, his son-in-law James Bernard
and his brother Elisha Jandon as Executors; he left "my beloved wife
Margaret a negro girl, my riding chair, horse, bed and furniture". His
lands were to be divided equally between his two sons and his personal
estate was to be sold and divided into seven equal parts for his wife
and six children. He died on 20 January 1774 and his son Paul
Jandon qualified as Executor of the estate. The surviving children of
Paul and Margaret (Lieubray) Jandon were:

Daniel Ananias Jaudon (Daniel¹, Daniel²), born c. 1733, son of Daniel, Jr. and Mary Ann Jaudon, married 31 May 1759 Anne Dubosque (DuBose), daughter of Daniel (c. 1697 - c. 1755) and Anne (Rembert) DuBose. He was a ferryman, carpenter, overseer and ultimately a planter of St. James Parish, a member of the 2nd S.C. Regiment. In 1776 Daniel Jaudon, planter of St. James Parish and Ann his wife, sold 125 acres he had bought from Andrew Query to Peter Deschamps for £40. The nine children of Daniel and Anne (DuBose) Jaudon were:

JOHN JAUDON (Daniel¹, Daniel²), born c. 1735, son of Daniel, Jr. and Mary Ann Jaudon, married (1) 19 April 1770 as bachelor of Prince Frederick Parish, Mary

Quillard, widow, at her Prince Frederick Parish dwelling house. The Rev. Warren of St. James officiating, with Paul Jandon, Jr. and Peter Micham as witnesses. She was possibly the daughter of Thomas Boone of St. James Parish who in his 10 Sept. 1783 witnessed by John Jandon, mentioned his daughter Susannah Gaillard and grandson Alcimus Gaillard. The death of Mary Jandon, wife of John Jandon, Passapatan, is recorded in St. James Parish Register on 12 Feb. 1772. John Jandon married (2) 4 July 1773 at the plantation of Thomas Lynch Esq. of St. James Parish, Anne Steel, the Rev. Warren again officiating. On 15 Aug. 1773 John Jandon witnessed the marriage of Peter Steel and Anne Warner, on 1 Nov. 1777 the will of John Leaton of St. James Parish. On 14 Feb. 1778 John Jandon and his wife Ann sold to Philip Downs 600 acres originally granted in 1711 to John Gaillard who left it to his widow Mary Esther who married James Kinloch, after whose death his son Francis Kinloch deeded same to Robert and James Roberts who conveyed it to Elias Robert who had deeded it to Archibald Affitt. By 1783 John Jandon was a planter of St. James Parish, Craven County. The three children of John and Anne (Steel) Jandon were:

Samuel Timothy Elias Jandon, Jr. (Dennis', Elias³), born 17 May 1739, son of Elias and Elizabeth (Robert) Jandon. As a young man he joined his cousins, John and Elias Robert in acquiring lands in rapidly developing Prince William and St. Peter's Parishes, Granville County. On 13 June 1769 Elias Jandon "of Prince William Parish" sold 558 acres on Block Creek, Salt-hatchie Swamp to David Hengerson of St. Bartholomew's Parish. On 14 Feb. 1770 as Elias Jandon, Jr. "of Prince Williams", he married Mary Hume Smith Dixon (21 Sep. 1753 - 27 June 1797), second daughter of Captain Thomas Dixon (1720 - 1769) planter of James Island, deceased, and his first wife, Elizabeth Smith (1722 - 1756), daughter of II Landgrave Thomas Smith (1670 - 1738). On 10 May 1791 Elias Jandon of Granville Co. and his wife Mary sold to Peter Jandon of Craven Co. 70 acres of a 2000-acre tract on Salt-hatchie waters in Prince William's Parish.

which Elias had bought from Aaron Wragg of Charles Town; Peter Robert and Elias Robert witnessed the deed. Elias Jaudon, planter of Prince William's Parish, and his wife Mary on 3 Jan. 1772 sold to Michael Clifton 200 acres of 400 acres on Whippy Swamp granted him earlier. On 5 May 1778 Elias and his wife Mary were "of St. Peter's Parish." when they sold 300 acres on Beaver Dam Creek of Casanawatchie River, land he had bought 4 Dec. 1771 from Lord Charles Grenville Montague, to William Atkins for £500. And on 1 May 1783 Elias Jaudon of St. Peter's Parish bought 50 acres on Jackson's Branch, Salkesatchie River from Jacob Hester, son of Andrew Hester who had the original 11 Oct. 1757 grant. This 50 acres with an adjoining 242 acres which had been granted him 1 June 1775, Elias Jaudon deeded to his eldest son, Elias Gabriel Jaudon on 1 July 1795. The 1790 census shows Elias and Mary Jaudon with 9 children and 14 slaves; Elias died 18 July 1809 at his plantation on Black Swamp. The eleven children of Elias and Mary (Dixon) Jaudon were:
