First thing the next morning the young man who helped me most, proudly proclaimed that this is an obsolete word, used only in Rutland and Leicestershire-and now-N'Hants. It came from an old English word meaning plank, and was used to refer to lumber for certain specific purposes, as a wheelwright might use, for example. The net(nest) barn was the big cow barn. This letter is to Rebecca Graves... they meet once a month at the Bridge between the quarterly meetings... on next page, some handwriting "Windward Bridge Meeting" This is signed by a number of women-real signatures-the first name is Kath: Norton the first letter had Jane Fitch Spring Meeting had Mary Waite Charpten Ground meeting had among signers Margaret Jackson, Alice Collins, Susanna Waite, Susanna Perryman (These names all early S.S. names) Same book #30 Barbadoes  
- 30th of 2 me 1676 signed by Katherine Norton and others

- 1688 "Sufferings of Friends" vol. 2 p. 317 Jonathan Fitch for defaults of appearing in Arms, 1145 lb and for not paying Church dues, so called, 79 1/2 lb in all 1224 1/2 lb. Barbadoes 1678 1678  
- p. 39 J. Ladsen John Ladsen for Defaults of appearing in Arms 400 lb p. 39 me 54 Barbadoes 1689 William Waite for defaults of appearing in arms 9 £11 d p. 382 72 1685 William Waite for defaults of appearing in Arms 615 lb and for Priest's maintenance 400 lb.  
- 200 John Waite for not sending to the militia 1500 lb and for not paying church dues, so called, 350 lb. The marshall who made the Seizure, behaved exceedingly rudely.

In St. Peter's Church, Northampton, across from the railroad station are several wall memorials to Sir Thomas Fresham and his family. When this name occurred in the Fitch wills, Mr. Tenque said it was a very renowned one in Northampton. He became a lot more interested in the Fitches after we found this will.

On the door of this church, a most beautiful one, by the way, wonderful carved pillars and most ancient fittings, is this most appropriate verse

"Pause ere thou enter, Traveller, and bethink thee  
 How holy, yet how homelike this place.  
 Time that thou spendest humbly here shall link thee  
 With men unknown who once were of thy race.  
 This is thy Father's House; to Him address thee  
 Whom here His children worship face to face;  
 He at thy coming in with peace will bless thee,  
 Thy going out make joyful with His grace."
