As your Petitioner, while very young, was left an orphan in consequence of losing his Father in service of his Country, and as he is now very old and infirm, your Petitioner prays that you may for the few years remaining of his life, allow him a small pension and your Petitioner will ever pray

HANGING ROCK - The Battlefield Site of Hanging Rock is located in in Kershaw County, about 24 miles north of Camden - At this site one sees hugh bolders of rock, some of them hewn out and were used as trenches in the Revolutionary War - here the battle of Hanging Rock was fought - here, also, John Miles, along with others was hung by the British somewhere around 1780, following is an account given in "Bouth Carolina in the Revolution" by McCrady, page 711.

"At Camden, under the very eyes of Cornwalls, himself, Samuel Andrews, Richard Tucker, John Miles, Josiah Gayle, Eleazor Smith, with others whose names were unknown, were taken out of jail and hanged without any ceremony whatsbever; others were indulged with a hearing before a court martial instituted by his Lordship for the trial of prisoners; but the evidences against them were not examined on oath and slaves were both permitted and encouraged to accuse their masters, not only at Camden but in other parts of South Carolina and at Augusta, Ga. the same bloody tragedies were enseted and many of the inhabitants rell sacrifices to this new mode of warfare".

RECULATORS - From McCrady's history, p. 594 In the absence of courts of justice within their reach, the inhabitants of this section found it necessary to form an association, which was called Regulation, and the persons composing it called Regulators". John Miles was a Regulator - other leading Regulators were Moses Kirkland, Thomas Woodward and Barnaby Pope, along with others.
