## Praise For The Judge

In their presentments through the years, Charleston County grand juries have so habitually lauded judges and other court officials that significance of the commendations has worn thin. That's unfortunate, because if we have been reading rightly the reports from General Sessions Court, the current grand jurors' praise of Judge Rodney A. Peeples of Barnwell has been earned, and should be recognized in that light.

Presiding at a five-week term designed to help clear a massive backlog of cases, Judge Peeples has demonstrated why he has a reputation as a firm and stern jurist. The sentences he has imposed — life terms for lives taken, and 20 or more years in prison for armed robbery — reflect awareness of public concern over the high crime rate. They reflect, too, a full understanding of the cold fact that the surest way to protect society is

to remove from its ranks those who resort to violence.

Judge Peeples has done more, however, than assure that some convicted criminals don't return immediately to the streets. He's prodded officers of the court to move faster. He has expressed impatience with lawyers' pleas for continuances ("an inconvenience and a logistics problem"). He has promised to light fires under magistrates for failure or delinquency to conduct the preliminary hearings that are basic to prosecution of cases.

In his first weeks on the bench here, Judge Peeples has come through as one who takes to heart the essential role jurists have in the system of justice which proclaims the right — of defendants and victims of crimes — to fair and speedy trials.
