My friend Christopher Dobson has an ancestress who was an East Indian Princess. He suggests, our Partrena may have been a Moorish Princess — and doesn't understand "what all the fuss is about".

The "proof" for my 9 generation descent from the Rev. Nathaniel Walker (senior) is all

assembled — including more Bible Records than we ever thought existed ; I sent some to be Xeroxed and the Applications to be typed, at the same place — only to learn : they no longer offer typing !

Brand Pendarvis' Will was submitted to the

Lexington Court of Equity — in Gideon Jennings lawsuit ; but it, also, has "disappeared". This could have been destroyed during the Civil War.

My friend Christopher is astonished at the amt. of S. C. Genealogical materials that survive. We can thank A. E. Salley, Jr. and the WPA !

You are fortunate indeed to have so close and loving a family. I send my smiling congratulations with love to your dear Mother and sister Ruth.
