Milton Rubincam

The Family of Bartholomaus Platz:

Bartholomaus (nickname: Barthle)(or Blatz, called commonly "Gessenbarthle") (note by M.Rubincam: I don't know what "Gessen" Means— can't find any—thing comparable to it in my German dictionaries) was an inhabitant and day—laborer at Hochdorf. He was born on 22 August 1635 as son of Ludwig Platz, member of the local law—court at hochdorf. Ludwig Platz was twice married, firstly in 1628 to Maria(died at Hochdorf, 6 Feb. 1654, aged 50. And secondly, on 31 Oct. 1654, at Hochdorf, to Agnes, widow of Gallus Rees of Schietingen. Bartholomaus was son of the first wife.

The records show that on 17 March 1716, Old Barthle Blatz commonly called "Gessenbarthle," after he had gone over land with rakes on kt the previous Monday and "come back in a brandy-drunkenness", as he used to do, fell into a water ditch in the Grindtal (a valley). He was able to dwaw himself out. He was found dead the following Wednesday and was buried the same day. (All this information is contained in his death record.)

Bartholomaus or Barthle Platz married (1) at Hochdorf, 3 May 1655, to Christina, daughter of the deceased Hans Weber of Schietingen. She died 7 August 1669, aged 38. On January 31, 1670, he married (2) at Mochdorf, Barbara, daughter of the deceased Caspar Bitt, a citizen of "Kurtzheimb. earner landlins" (this name seems to be garbled) in Switzerland. Barbara died on April 15, 1704 at Hochdorf.

Hans (or (Johann) Jacob Platz, son of Bartholomaus by his second wife, Barbara Bitt, was born at Hochdorf, 24 November 1673, and died there December 13, 1708. He was a rakemaker by occupation at Hochdorf and Schietingen. He married at a date and place not yet found, to Anna Barbara Freyermuth, who was born at Treschklingen near Heilbronn, 24 May 1669, and died at Hochdorf, 29 Dec. 1726. She was a Tabackweib (tobacco woman- probably ran a tobacco shop at Hochdorf).


Platz Plat - Description

South Carolina

Pursuant to a Precept from George Hunter Esqr. S Gen dated the 23d day of March 1753 I have admeasured and laid out unto Jacob Plats (Platz, Platts) a tract of four rundred acres of land in Granville County butting and bounding to the east on vacant lands, to the south on vacant lands, to the West and North on vacant Lands and hath such form and marks as are represented by the below delineated platt thereof Certified this 30th. day of March AD 1753. James McPherson DS Reference: Colonial Plats Vol. 5, S.C. Archives.

Note: that the Platz survey was made early in the day, and shows vacant land on all sides. Dated on the same day were two adjoining plats for (1) Christian Pour 400 acres, and (2) Henry Ulrer 350 acres. The original of these rlats can be found in the S.C. State Archives. U.S. Geological Survey map shows Pretty Creek on south side of Saltcatcher, about 5 miles SE of Ulmer, S.C.

This is just a rough sketch and copy of Plat found in Hiers Genealogy.



Johann Jacob Platz, son of Hans Jacob and Barbara (Freyermuth) Platz, was born of 26 Jan. 1705, in Schietingen. On 7 Oct. 1732, he married at Emmingen, Christina Rentz, b 27 Feb. 1710, at Emmingen, daughter of Jacob Rentz, citizen and fisherman of Emmingen, by his wife, Christina Roller. With their children the emigrated to America in 1751. Their issue:

Note: The ages of these children do not agree exactly with the ages given in his request for land as outlined in the Council Journal of South Carolina, Jan. 8, 1752. It will also be noted that his two youngest children were apparently too young for a grant.

JOHN JACOB PLATZ, IMMIGRANT

John Jacob Platts, German immigrant to South Carolina, was born Jan. 26, 1705 at Schietingen, Germany, and married at Emmingen on Oct. 7, 1732 to Christina Rentz, born at Emmingen Feb 27, 1710, and immigrated to South Carolina with their eight children in 1751. No attempt has been made to trace his descendents in South Carolina, except for his fourth child, John Platz, whose willfoldwas:

Will of John Platts

In the name of God Amen I John Platts being weak in body but/perfect understanding and memory do constitute this my last Will and testament and desire that it may be received as such. First I Bequeath my soul to God my Maker humble beseeching his most gracious acceptance of it. Secondly I give my body to the earth from whence it was taken as as

for burial I hope it may be done decently and in order whenever it may please the lord to call me hence at the discrition of my Dear Wife and executors hereafter Named, as to my worldly estate I give unto my son a tract of lands the youngest excepted, containing five hundred acres which land to be equally divided between them as they come of age I give unto my dear loving wife the plantation where I now live during her widowhood containing two hundred acres and after her decease or widowhood to fall to my youngest son as for the rest of my property such as Negroes horses cattle hogssheep and Household furniture together with my working tools to be divided between my wife sons, daughters, in the following manner that is to say I Will that my wife shall have during her natural life an equal part and during her widowhood her choice of one negro and I will that daughters shall have two sharesand my son one of the above mentioned property land except and for my wife to continue on the plantation where I now live and the care and benefit of the property with the concent derection of my executor to raer and support my children an during her widowhood or until my youngest child comes of age and whenever an during either, then for a devesion to be made or should any of my sons and daughters may marry then for them to take their share or part and should any of my sons or daughters decease without lawful Issue then for their part to devdor amongst the rest of my children or their heirs and should any of my sons incline to despose of their lands I will that they shall sell to their surveving Brothers and should any of my Daughters incline to live single and chuse to live on the place where I now live that they shall have it for their home and place of abode during their life and after my wife decease then for their part to be equally divided between my sons and daughters or their lawful heir and lastly I do constitute and appoint my wife Sophia and my Trusty friend John Hire and Jacob Harter executors hoping they will faithfully comply with this My last Will and Testament given under my hand this sixth day of November 1799 Signed Sealed in presance of P.S. should my wife marry then I will that my executors take unto their care and charge the rest of my children and their Property.

Know all men by these present that we John Platts, David Platts, John All, and Elizabeth his wife; Henry Brant and Caterenah his wife, Man John Coone & George Harter & Margaret his wife, all of Barnwell District, S.C., Michael Kinard and Miley his wife of Lexington District, S.C., Abraham Hiers and Nancy his wife of the Colleton District, S.C., George Howard & Christenah his wife of the state of Georgey for \$720. paid by George Platts of Barnwell District S.C. all that plantation or tract of land containing 300 acres situated in the state and district aforesaid, one tract of two hundred acours lying on hog Branch including the old plantation, and one hundred acours lying on Pretty Creek, both waters of Great Saltcatcher, being originally granted to John Platts decdased and descending to us the said John Platts, Daniel Platts, Christenah Harter and Caterenah Brant as the leaguel heirs of the said John Platts, deceased. Dec. 26, 1816
