HARRIETT AND DAVID WERE MARRIED IN COLLETON DISTRICT. FIVE CHILDREN BORN OF THIS MARRIAGE. DAVID SECOND MARRIED MARY ELIZABETH "POLLY" IN BEAUFORT DISTRICT. POLLY HAD SIX CHILDREN BY DAVID.

Traditionally during this time period, mothers gave their daughters three Christian names to honor her own lineage.

HOWEVER HAS A TOMBSTONE ERECTED IN BRUNSON.
  2. GLADYS MITCHUM. MARRIED. BURIED IN BRUNSON, SC.
3. CLARA GRAY MARRIED MR. WILLIAMS, AND MOVED TO  
FLORIDA. SHE HAD A SON, WHO WHILE VISITING HIS  
GRANDMOTHER WAS THROWN FROM A PONY AND CRIPPLED FOR  
LIFE. AS A RESULT, CLARA BLAMED HER MOTHER AND  
NEVER ALLOWED THE CHILD TO VISIT AGAIN.

The Immortality of Harriett Platts and David Farnum Moore, Sr

Harriett Platts is the daughter of John Platts who wed 3/7/1811 Susannah Mole B:8/21/1791 D:4/25/1844. Further parentage of the Mole line unknown at this time. Harriett's family Bible is now called the "Gray Bible," owned by B. F. Rouse PO Box 250, Brunson, SC. He was the first husband of Gladys Mitchum. (She must have been a descent of Rachel?)

David Farnum Moore, Sr. B:1/22/1825 is the son of Humphrey Moore B:4/25/1801 and his wife Mary Boatwright B:3/12/1801 and married in Colleton District on 14 March 1824.

DAVID FARNUM MOORE, SR. (1825-1902) WAS MARRIED SECOND TO MARY ELIZABETH GIBSON (POLLY) OF BARNWELL COUNTY. SHE IS THE DAUGHTER OF SAMUEL GIBSON AND DORA DODD. MARY DIED AT THE AGE OF 90 OF HEART FAILURE. (DEATH CERTIFICATE #842, INFORMANT MISS HATTIE GOODING) POLLY WAS FIRST MARRIED TO LEWIS J. MANKER WHO DIED 12/18/1855 AND WAS BURIED AT HOGARTH CEMETERY NEAR BRUNSON. THREE CHILDREN ARE LISTED FOR POLLY AND LEWIS MANKER; MARY R. MANKER (RICHARDSON?) B:ca 1852, LAURA JULIE MANKER B:ca.1854, EMMA C. MANKER B:early in 1858. (THE THREE CHILDREN OF LEWIS MANKER & POLLY POSSESSING \$1700 EACH IN REAL PROPERTY AS STATED ON 1860 CENSUS OF PRINCE WILLIAM PARISH, PROBABLE INHERITANCE FROM THEIR NATURAL FATHER.)

CLASS B TYPE HAEMOPHILIA, CHRISTMAS DISEASE, IS AN INHERITANCE OF THE FEMALE LINE. HARRIETT PLATTS RECEIVED IT FROM HER MOTHER, SHE PASSED IT ON TO CLEMONTINE, SHE PASSED IT DOWN TO ANNA, ETC, ETC. AND IS STILL HAUNTING US TODAY. MALE CHILDREN ARE POSSIBLE VICTIMS OF THE FACTOR 9 DEFICIENCY. THE WOMEN DO NOT HAVE IT, THEY JUST PASS THE DEFICIENCY TO THEIR SONS.

David Farnum Moore, Sr. listed as household #32 in Prince William Parish, Beaufort County, SC in 1850. He claimed his real estate valued at \$1230, was a planter and born in South Carolina. David listed as household #83 in 1860, real estate valued at \$16,000 with personal property of \$31,500 same location.

I have not been able to locate a final resting place for Harriett. According to the death certificate (#18100) for Clemontine A. Catherine Moore Gray, Harriett Platts is her mother. (The informant being Rachel Mitchum, daughter of Clem.)

DAVID FARNUM MOORE, SR. AND MARY (POLLY) GIBSON ARE BURIED AT A CEMETERY 2/12 MILES WEST OF HICKORY GROVE CHURCH ON PROPERTY ONCE OWNED BY HENRY AND HATTIE MOORE MEW WILLIAMS.
