#### Dear Cousins:

The response to the 1990 Newsletter subscription renewal has been quite good, although we are still about 25 subscriptions short of 1989. Unfortunately, I cannot mail a copy of this month's newsletter to those who have not re-subscribed, so I hope when he or she does not receive this month's issue I will be contacted.

There are a few items of interest to you, state by state, genealogically speaking, in this month's Newsletter. In Kansas, for example, the Kansas State Historical Society is asking the Kansas legislature to give them permission to access books and printed materials from the archives to the public. Write the Kansas Council of Genealogical Societies, P.O.Box 8030, Topeka, KS 66608-0038, for information. In addition, the state legislature has opened vital records previously closed to the public. Copies of birth and death certificates after 1911, marriages after May 1, 1913, and divorces granted after July 1951, are now available from the State Dept. of Health & Environment, Bureau of Vital Statistics, Topeka, KS 66620.

Any reports you may have received that the Pennsylvania State Archives have been closed are not true. However, there are new hours. Contact Western Pennsylvania Genealogical Society, 4338 Bigelow Blvd., Pittsburgh, PA 15213-2695.

The Ohio Historical Society no longer charges a different fee for death certificates to members and non-members. The fee is \$7 for either category. Write to the Ohio Historical Society, 1982 Velma Ave., Columbus, OH 43211-2497. If you can go to the Society in person, you can do the work yourself and make a 25¢ copy from the microfilm.

The 1920 Federal population census will be opened to the public on March 1, 1992. At that time microfilmed copies will be available for research at the National Archives in Washington, DC, and the eleven regional archives across the nation. The 1920 census consists of 2,076 rolls (35mm) of population schedules, and 8,590 rolls (16mm) of Soundex indexes for all states, totaling 10,666 rolls. Ordering information will become available closer to the 1992 release date.

Once again it is your contributions to the newsletter that makes it worth reading. Lots of information in this month's issue, particularly a continuation of the RICHARD RAWLINGS of Maryland descendancy by Bob Bockmiller together with Beverly Allan. RICHARD may or may not have come from England, we only know he died in Anne Arundel County, MD in 1696. He was married to Jane \_\_\_, and so far as we know had 5 children: RICHARD JR., JOHN, MARY, OLIVE and ELIZABETH. In the December 1989 issue of the newsletter, P.12, is a brief resume of the children and grandchildren of RICHARD and Jane. RICHARD's son JOHN married Eleanor Ridgely, and they had 7 children. It is JOHN's son JOHN about whom we will hear this month, Pp 7 to 10.



Here is some information which might be of interest to someone, as it does not pertain to my ROLLINS line who emigrated to Southern Illinois.

In 1818, store accounts and some early land records at Old Brownsville, Illinois, which was the county seat for Jackson County, but whose name later changed to Murphysboro, after a fire destroyed the Courthouse at Old Brownsville. The names mentioned in these records were: RAYEDELL ROLLINS and JOHN ROLLINS. This JOHN is too early for the JOHN connected to my family. I've found nothing else to help identify these two, and I presume they are both men. Someone may be looking for them. The fire mentioned above was in 1843 and destroyed most records for that area. There is a possibility they could be related to mine as siblings of my great-great-grandfather JONATHAN ROLLINS, who moved from Maryland to Ohio. His children were the ones who migrated to Southern Illinois. At this date I do not know the siblings of JONATHAN. It sometimes is GUESS...GUESS...GUESS, isn't it?

I descend from a combination of ancestors which include the Broyles, Taylors, Woodings, Hoover/Hubers and RAWLINGS. My knowledge of the RAWLINGS family begins about 1788. WILLIAM RAWLINGS was born in Virginia around that year and was living in Rutherford County, Tennessee, by ca 1805 when he married Sarah R. Hoover. Their son, LEWIS J. RAWLINGS married his cousin Elizabeth Hoover in 1838. LEWIS J. served with General Zachary Taylor at Vera Cruz during the Mexican War. After the Civil War, LEWIS and his family moved to Independence County, Arkansas, where he spent the rest of his life. LEWIS had a son, JOHN KNOX POLK RAWLINGS, and he also married a Hoover! That's three in a row! ELBERT FRANKLIN RAWLINGS was the son of JOHN KNOX POLK RAWLINGS and he broke the chain by marrying a Harris.

Our family still cannot locate the parents of the aforementioned WILLIAM RAWLINGS, b. Virginia around 1788, and any information on this line would certainly help unravel

this particular genealogical puzzle.

ELBERT FRANKLIN and Sarah Elizabeth (Harris) RAWLINGS were my grandparents on my mother's side. Their daughter, MILDRED HELEN RAWLINGS married my father Raymond Andrew Bourassa in 1933.

Further to the comment made by Charles "Stan" Rawlings of Missouri on P. 18 of the March 1990 Newsletter concerning the 3 MOSES RAWLINGS who served in the Revolutionary War, here is his breakdown of 3 (and maybe 4) MOSES (southern states). "I have counted 13 MOSES RAWLIN(G)S/ROLLIN(G)S in the THOMAS, ANTHONY, AARON and other southern lines, most of them sortable. My main concern is the three we have often spoken about. (1) MOSES who served in the Revolutionary War from Virginia, in the Virginia militia, and who went to Kentucky to take up settlement there, only to be killed by indians in the spring of 1787...leaving a family of 7 sons and several daughters. (2) Col. MOSES RAWLINGS of Maryland who led Stephenson's Regiment at Ft. Washington in New York, captured by the British, was paroled, and served on Gen. Washington's staff in the procurement department. He leaves a very clear trail. (3) a MOSES RAWLINGS who enlisted in October 1780 in Culpeper Co., VA under aCapt. Smith, attached to a regiment commanded by Col. Buford. He was wounded in the Battle of Guilford Courthouse and later lost both legs below the knees. Married Nancy Cave in Ritchie Co., VA in 1814, and had 5 children, HENRY, JEREMIAH, SALLY, EDWARD and REBECCA. He died there Feb. 4, 1856. He was supposed to have been aged 16 when he

for one hundred acres. In sending for copies of these warrants and other information concerning one or all of these MOSES from the National Archives I received copies which might indicate there was a 4th MOSES who served during the Revolutionary War. Since we know something about these three, who is the fourth? I hate to mention this but in George Rogers Clark's expedition to Ohio, a MOSES RAWLINGS is listed as a deserter. (One hastens to point out that he could have been killed by indians, or there could be another explanation.)

In any case, there is a Viriginia Land Office Military Warrant #3648 issued to a MOSES RAWLINS of 200 acres of land in Kentucky for his services in the Virginia Continental Line. This was found in the Kentucky State Historical Society in Frankfort. It was never surveyed and never taken up or used in Kentucky. However, our MOSES who was killed by indians in 1787 had a son MOSES JR. who did take up the warrant for land in Ohio, which was also a Virginia Military District for purposes of issuing such warrants. It was surveyed in Ohio for 200 acres 14 July 1801...on Pea Creek in Ross County, then sold to Eleazer P. Kendrick 18 October 1842. The bill of sale is signed by MOSES RAWLINS, witnessed by WILLIAM RAWLINS and Rebecca Richards.

Is this MOSES RAWLINS the son of MOSES killed by indians...or a fourth MOSES?"



The Montgomery County Rawlins (Rawlings) and Their Descent From Richard Rawlins of Anne Arundel County

John Rawlins (c1690-1727), son of Richard Rawlins of Anne Arundel County, Maryland married Eleanor Ridgely, daughter of William Ridgely. John Rawlins, son of John and Eleanor Rawlins was born in Anne Arundel County in 1718. John married Anna Sophia (surname unknown) and had at least 4 children; John, William, Elizabeth and Mary. About 1748, John Rawlins and his family moved to Frederick County in the vicinity of Dawsonville which is now located in Montgomery County. Here, John was one of the original justices of Frederick County. John Rawlins died in 1756.

William Rawlins, son of John, probably died young, moved from the area or gave up his inheritance. No records were found on William after 1756.


The Rawlins family of Montgomery County had a close association with the Hays family. There were numerous marriages between these two families over several generations.

John Rawlins, son of John, married Mary Hays, daughter of Jeremiah Hays and had 7 children. Thomas, the oldest son married Elizabeth Fulks. They had 6 children, 3 sons and 3 daughters.


John Rawlins, brother of Thomas, married his first cousin Ann Hays, daughter of Charles Hays and Elizabeth Rawlins. They had 7 children.

1718 - John Rawlins baptized June 13, 1718 at All Hollows Church Anne Arundel County, Maryland, son of John Rawlins and Eleanor Ridgely.

1743 - Land Patent #199, Prince Georges County, Md. 50 acres to John Rawlins, "Lost Hatchet" (this area of Prince Georges County became Frederick County in 1748 and Montgomery County in 1776).

1748 - Frederick County Judgments. First court established
December 12, 1748 when Frederick County was formed. John
Rawlins was one of the original justices. Note: The
Maryland Archives has many records of court appearances
by John Rawlins in both Frederick and Anne Arundel counties.

1756 - Will of John Rawlins, Frederick County, Md., wife Sophia and children John, William, Elizabeth and Mary. John received land "Beginning" at mother's decease, William received lands "Lost Hatchet" and Hopsons Choice" at mother's decease. Prerogative Court 10 Sept. 1756, p.147.

- 1761 Anna Sophia Rawlins sold to son John Rawlins "Lost Hatchet" 60 acres, The Beginning" 100 acres, "Hopsons Choice" 50 acres, Frederick County land records 17 Oct. 1761, L. G, F. 261. Note: William was to receive "Lost Hatchet" and "Hopsons Choice" at mother's death, however, she sold the two lands to her other son John. William apparently died or gave up his rights to the lands. No information found on William after 1756.
- 1777 Revolutionary War Soldiers. John Rollins and Thomas Rollins served with the Middle Battalion, First Company, Montgomery County, Md. Clements and Wright, "The Maryland Militia in the Revolutionary War".
- 1778 Oath of Fedelity, Montgomery County, Md. John Rawlins and Thomas Rawlins.
- 1783 Tax List, Montgomery County; John Rawlins resurvey on "Beginning" 479 acres original grant mentioned in will of John Rawlins who died in 1756, Thomas Rawlins 50 acres of "Hopsons Choice", 50 acres of "Lost Hatchet" and 8 acres of "Addition to Lost Hatchet".
- 1783 Will of Jeremiah Hays, Montgomery County, Md. My lands
  "Jeremiah Park" and part of "Hopson's Choice" to be sold
  at auction. Sons Richard, Thomas, William, Jeremiah and
  Leven. Daughters Sarah Stokes, Elizabeth Clagett, Margaret
  Hoskinson, Mary Rollins, wife of Jn Rollins, and Priscilla
  Hays, wife of George Hays. Sons Thomas and Richard Hays
  Exec. 15 Sept. 1783 L B, F 229
- 1784 Will of John Rawlins, wife Mary, sons Thomas and John (under 18), daughters Ann, Priscilla, Elizabeth, Sarah and Mary. Execs. wife Mary and son Thomas. 15 Aug. 1784, L. B F. 163.

- P.32 Washington Co., Tennessee Will of Rebecca Vanderpool, the oldest will in Washington County. Dated May 12, 1779, placed on record at the August session of the County Court, to be found on Page 1 of Will Book 1.

  Among the descendants of Rebecca Vanderpool is a Lewis Family that settled in Dallas County, Texas, in an early day, from Carter County, who intermarried with the ASAHEL RAWLINGS family. The writer once attended a reunion of this family in which these facts were discussed by the RAWLINGS family historian.
- P. 71 Information relating to the First Families of Greene County, Tennessee. In the year 1783, a part of the Washington County was sliced off and the lower part of it called Greene County. At the first court of Pleas and quarter session, the following magistrates were present: J. Hardin, John Newman, George Doherty, James Houston, Amos Bird and ASAHEL RAWLINGS.
- P. 207 W.C. Murphy married LUCY RAWLINGS and had 3 or 4 children.
- P. 467 WILL RAWLINS was one of the executors of the will of Edward Wade of Halifax County, VA, in 1776.
- P. 471 Hamilton County, Tennessee. Chattanooga built on the site of Ross Landing.
  Ross Landing was in Cherokee Country. Among other white settlers not intermarried with the Cherokees were the following who came to Hamilton County ASAHEL RAWLINGS, from Washington County.

- P. 709 Courts of Hardin County. In 1825 Thomas Shannon was granted liberty to keep a ferry on the river where Saltillo afterwards stood, and he gave as his bondsmen JOHN A. RAWLINGS and J.W.Judkins.
- P. 717 Shelby County, Tennessee, established in 1818. Among the "prime movers" in the establishment of Memphis were the following: Judge John Overton, James Winchester, Andrew Jackson, Marcus B. Winchester, John C. McLemore, ISAAC RAWLINGS (first mayor), John M. Balch, Enoch Banks and Jacob Davis.
- P. 718 ISAAC RAWLINGS and Marcus Winchester the first Memphis merchants.
- P. 734 Brick houses began to appear in Jackson. Butler and RAWLINGS also built a brick store about 1825. This building, with a third story added, was still standing and in use a few years ago.

Page 120 - 12 March 1657. Indenture between James Murray, planter, of Surry Co., and Elizabeth Harris, binds her son, John, as an apprentice, etc. Witnessed by JONATHAN & GREGORY RAWLINGS.

Page 120 - July 1658. Richard Tias appoints his friend JON THAN RAWLINGS his attorney.

Page 179 - 2 Jan. 1661. Thomas Pittman sells to Maj.Wm.Marriott all his rights, etc., in a water mill jointly belonging to said Pittman and JOHN RAWLINGS. Witnessed.

Boulding 31 July 1662. Witnessed. This same patent is assigned by Wm. Boulding unto John Tatem 20 Jan. 1662. These two assignments acknowledged in Surry County by JOHN RAWLINGS and Wm. Boulding. Page 229 - March 1, 1663. JOHN RAWLINGS of Surry County, he moving, sells to Wm. Scarbrow of the same county a parcel of land situated upon the east side of Burchen Swamp on Chippoakes Creek, with negroes, etc., bounding upon Mr. Simons on one side and Burchen Swamp the other.

Petitioner has wife and three small children, and to relieve him of ye estate of orphants, and make Capt. Cockerham as overseer of Harris, his estate, for five years rent.





"In the name of God Amen, I, HENRY ROLLINS of the state and county aforesaid, do make and publish this as my last will and testament in manner and form following to wit:

- Item 1st I give to my daughter MARY Jolly one bed and furniture, together with the other property which I have heretofore but her husband, Asa Jolly, to her and her heirs forever.
- Item 2nd I give and bequeath to my son JESS ROLLINS one dollar together with all claims which I now hold against him as his full share and only legacy in my estate.
- Item 3rd I give and bequeath to my beloved wife Priscilla (Blount) after the payment of my just debts, all the balance of my property both real and personal (except that which is before devised in the first and second clauses of my will as above) during her natural life or widowhood, with the provision that she is to raise and support comfortably my two youngest children, REBECCA and GEORGE W. ROLLINS, and my daughter MARGARET, and at her death to be equally divided between my living children or their lawful issue if any, except the part which I intend to give to the heirs of my daughter JANE, wife of Richard Pierce, which I wish to be paid by my Executor to a guardian who may be appointed by the court to take charge of the same for their use and benefit.

Lastly, I leave my beloved wife Priscilla my whole and sole executor to this my last will and testament in witness whereof I have hereunto set my hand and seal this 29th day of September A.D. 1849.
