"At a Court held for St.Jones's upon the Third Tuesday 25th of December 1680 upon the several petitions of the hereafter persons the Court has granted each" JOHN RAWLINES(sic), Jr. - 600 acres ANTHONY RALINES (sic) - 400 acres JOHN RALINES (sic) - 800 acres



If your nearest genealogical library has a copy of the EDWARD PLEASANTS VALENTINE PAPERS, you will find in it several references to various members of a particular RAWLINGS family.

P.556, Vol I - refers to land purchased by John Tatus from JOHN RAWLINGS. Surry County Deed Book 1, P.213


P.212, Vol. 1 - JOHN RAWLINGS of Surry County, VA, leased a mill and other property from John Brasseare of Nansemond Co. (Surry Co. Deed Book 1, P.319)

P.691, Vol.II - Will of Ann Jordan, dated 22 Feb. 1697: Left to JOHN RAWLINGS Sr. "my servant boy named. William Little". To ELIZA RAWLINGS "my best sute of cloathes". MARY M. RAWLINGS, Witness. Surry Co. Deed Book 4, P. 146.

JOHN ROLLINS/RAWLINS was the contractor on improvements at Mt. Vernon, hired by George Washington. The large banquetroom at the north end of Mt. Vernon was placed in his hands since he was a craftsman in decorative plaster-work. He was from Baltimore.



Mr. Peck further explains that JOHN and ANTHONY RAWLINGS (RALINES) are the sons of ANTHONY RAWLINGS (1615-1651) whose wife was named Jane. After ANTHONY died, Jane moved to Dorchester County, Md, and remarried. Kent Co, in Delaware includes the headwaters of rivers which feed the Chesapeake Bay, so it was reasonably accessible to residents of Dorchester County.

The following bits of information concern a particular descendant of the Spotsylvania, VA family, descendants of the progenitor in North America of JAMES RAWLINS of England who came to America in either the last decade of the 1600's or the early decade of the 1700's. This particular descendant is THOMAS C. RAWLINGS, son of JOHN W. or H. RAWLINS, son of JAMES RAWLINS Jr., son of the original JAMES mentioned above.

THOMAS C. RAWLINS, spelled RAWLINGS in many instances, was the eldest son of JOHN W. or H. RAWLINS and his first wife, Nancy Holladay, dtr. of Benjamin Holladay. THOMAS was born April 1, 1747, in Spotsylvania Co., VA, and died in 1820 in Howard Co., Missouri. He came with his parents and siblings to Clark Co., KY. His brothers and sisters were: MARY, BENJAMIN HOLLADAY, LEVI, JOHN C., SUSANNAH, ROBERT and OWEN, all children of Nancy. It was in Clark Co. that Nancy, his mother died in 1800. We know that one son of JOHN Sr. was born in Kentucky, and that was OWEN. For some reason all these siblings remained with their father except LEVI who was sent or remained in Virginia with relatives.

JOHN md. a second time to a widow, Jane (Bush) Embree, and fathered one more son and 5 daughters - JAMES DAWSON, WILMA, ELVINA, JULIA, JANE and NANCY. Later the family moved on to Howard Co., Missouri

THOMAS married Esther (Bush) Landrow, a widow, in 1803 in Clark Co., Kentucky. They followed his father to Howard Co., MO, raised their family there, died and were buried there in the RAWLINS Cemetery located on the old farm. The children were: COMMODORE PERRY, JOHN, AMBROSE D., THOMAS JR., EMMA KATE/EMMICOTTE, MELVERIA, NANCY H., LUCY B. and MARY "MOLLY" who died young. (another source has said that MARY "MOLLY" married a Mr. Calvert.) One of our subscribers is a descendant of THOMAS thru his son COMMODORE PERRY who is her grandfather. The farm is still owned by a RAWLINGS, and is located in Howrd Co., MO, Township 49, Range 15, section 34.

THOMAS C. died 1845/46, and Esther died May 26, 1851. Other information states that COMMODORE PERRY md. Pauline Adams, he was born in 1824 and died in 1869. THOMAS Jr. was born ca 1829 and md. a Julia \_\_\_\_\_\_. EMMA KATE was born Dec.2,1812 and died M-arch 15, 1873. She md. John Calvert April 20, 1832. MARY "MOLLY" was born Dec. 17, 1817 and died Jan. 19, 1886. She married a Martin Calvert Dec. 17, 1836. (researchers should check on this information concerning MARY "MOLLY"

An update on this information discloses that : MELVIRA B. b. 1810 md. a Mr. Farris... NANCY H. md. Mr. Mullins...LUCY B. md. Mr Head. COMMODORE PERRY was born in 1824 and died in 1869. He and his wife Pauline according to the 1860 census in Howard Co. had 4 children at that time...ANNA M., THOMAS, ALPHA and DUDLEY. A brother of his, OWEN, is also found in 1850 census, with wife FRANCES and children ANN J., MARTHA J., NICHOLAS B. and CELIA S.

Will of THOMAS C. RAWLINS, Howard Co., MO, from the Missouri State Archives, P.257.

I, THOMAS RAWLINGS Senior of the County of Howard and state of Missouri, being of sound mind and memory, doth make, constitute and ordain this instrument of writing as my last will and testament in the manner and form following:

First it is my will that all my funeral expenses and all my just debts be fully paid.

Second I give, devise and bequeath to my beloved wife Ester RAWLINGS all of my estate of any description whatsoever during her natural life or widowhood.

Third I give to my son COMMODORE P. RAWLINGS the West half of the Northeast quarter of Section 34 in Township 49, Range 15. Also the East half ot the Northwest quarter of Section 34 in Township 49, Range 15, it being a part of the farm I now live on... at my wife's death.

Fourth I give all the balance of my estate at my wife's death to the rest of my children, namely: JOHN RAWLINGS, AMBROSE D. RAWLINGS, THOMAS RAWLINGS Jr., EMMICOTHE (EMMA KATE), MELVIRA B. Farris, NANCY Mullins, LUCY B. Head, to be equally divided between them.

Fifth I have given my eight last-named children in advance the following sums, to with: to my son THOMAS Jr., \$100; to my son JOHN \$100; to my son AMBROSE D. \$100; to my daughter MARY S. Calvert, \$100; to my daughter EMMOCOTE Calvert \$100; to my daughter MALVERIA B. Farris \$100; to my daughter NANCY B. Mullins \$130; to my daughter LUCY B. Head \$180.

Sixth it is my will that each of these last-named children should give an account of the moneys that were advanced to them at the division of my estate so as each might receive equal parts.

Written with my own hand this 28th day of July in the year of our Lord, eighteen hundred and forty-five A.D. I do appoint my sons THOMAS RAWLINGS Jr. and JOHN RAWLINGS, Executors of this my last will and testament.

Another small item is that there is a possibility THOMAS C. RAWLIN(G)S served in the Kentucky Militia during the War of 1812.

This information has been gleaned primarily from Laura Crane, 1906 Dartmouth, Columbia, MO 65203.

Another correspondent whose name I have lost, unfortunately, informed us that LEVI, the son who remained in Virginia or was returned to Virginia, was born Feb. 27, 1788 in Virginia, md. Eliza Hansbrough and they had 4 daughters. He died Oct. 29, 1824 in Virginia. He was THOMAS C.'s brother. Another brother was JOHN C. RAWLINGS, b. 1789 in VA, died 1818 in Missouri. He married Mildred Embree and they had 10 children: OSCAR F., ROBERT G., WILLIAM O., WASHINGTON, NANCY J., MELVINA, SUSAN, FIELDING, JEFFERSON and JOSEPH. Maybe one of our subscribers can furnish. more information on these siblings of THOMAS, whose parents were JOHN RAWLINGS and Nancy Holladay RAWLINGS.



THOMAS RAWLINGS (1703-1767), English musician, was a member of Handel's orchestra, performed at both operas and oratorios, and from 1753 was the organist at Chelsea Hospital, London.

FRANCIS RAWLINS, son of JOHN and Eleanor (Ridgely) RAWLINS, was the owner of the Inn where many members of the underground Militia held secret rendezvous during the American Revolution...and was commended by Congress for his active support of the patriot cause after the war.

The following is information sent us regarding his ancestry from GEORGE B. RAWLINGS Sr. of Brunswick Co., VA...to the present day, as the line travelled thru Tennessee and then Texas.

GEORGE B. SR., b. March 6, 1817, in Brunswick Co., VA

Md. Nancy Howell.

Also md Caroline R. Harding in N.C. July 17, 1839. Had three children, ROSE E.,

RICHARD and GEORGE B. Jr.

GEORGE B. RAWLINGS Sr. sold the farm in Brunswick Co. and moved to LaGrange, TN in 1851. He died May 9, 1857, and was buried in La Grange. (Our correspondent has not been able to locate his grave there.) CAROLINE, ROSE E. and GEORGE B. Jr. can be found on the 1860 census in Fayette Co., TN. George B. Jr. joined the Union Army May 27, 1864 to June 26, 1865. He became a doctor after the War and moved to Illinois. He md. (1) Damaris Baldwin Feb. 24, 1867 to 9/19/1882. Their children were JAMES F., LORENA C., ROSE M. GEORGE BENJAMIN III and HALLIE B. He md. (2) Ella J. Sisk on Oct. 30, 1883. Their children were HAROLD E. who died young. GEORGE B. Jr. died June 7, 1924 and is buried at Wolf Creek Cemetery, Eldorado, Illinois, where he practiced medicine. There are many RAWLINGS in the Wolf Creek Cemetery.

GEORGE BENJAMIN III (Mar.4,1875-July 1, 1939) md. Cora Icie Wade on Oct. 16, 1907. They had one child, GEORGE WADE RAWLINGS, b. Aug. 28, 1908. He md. Delia Clayton on May 29, 1929. They had 2 children, GEORGE CLAYTON, b. Nov. 7, 1930...and TWILA ANN, b. June 10, 1934.

GEORGE CLAYTON md. Ann Sanders on Dec. 20, 1953 and they have four sons - GEORGE S., LARRY FOY, NORMAN WADE and KEVIN WAYNE. (GEORGE S. is our correspondent.)

Note: our correspondent tells the story that his grandfathengEORGE BENJAMIN Jr. did not like the name BENJAMIN. He always told his son GEORGE III that his middle name was BUCK. However when the Union Army pension record turned up he listed his name as BENJAMIN and his son got a good laugh out of that.

Further to the ongoing research into the descendants of HARRY LEE and HENRY RAWLINS. Carole Kennedy has recently discovered that HENRY's parents were JOSEPH RAWLINS and Isabella Francis. JOSEPH WAS A FARMER and also may have owned the pub "George-in-the-Tree". She also has discovered that HENRY had brothers and sisters and will send on further information on them. The family lived in the Midland, Balsall, Leominster, Kenelworth area in Warwick, England.

She also enclosed a snip from a newspaper in Picyune, New Orleans, dated Jan.8,1900. In it we find that HARRY LEE RAWLINS played "Adolph", ISABEL RAWLINS played "Divonne" as well in The Flower Girl.

In 1980 she moved back to Seattle and later married Herman Schumacher and grew roses and won many prizes. Herman predeceased her two years ago.

#### From R/RFHA Files:

CHARLES RAWLINS, b. ca 1749 in London, England, a Methodist Episcopal. He along with his family, came to America and settled in Sussex Co., Delaware. He died in 1812. The name of his wife is unknown. His father was WALTER RAWLINS of London. CHARLES was an instructor of music, navigation and surveying. He had 5 children. JOHN died March 29, 1851, in Scott Co., KY.

JOHN, b. Feb. 6, 1861, in England; md. Feb. 6, 1806, in Sussex Co., Del., (1) Nellie Smith...and in 1810 md. (2) Patsy Morris in 1810 in Sussex County...and (3) in 1849 Catherine Hutchinson, a widow.

By his first wife Nellie, JOHN had 1 child, NANCY D., who md. Thomas Griffith in Scott Co., KY

By his second wife Patsy, JOHN had 3 children, SALLY ANN who md George Power...ALAZENA who never married and died in 1845...and ELIZABETH who md. Thomas Offut, probably in Kentucky.

By his third wife Catherine, JOHN had four boys - JOHN P. Jr. who married Mary Warring...WILLIAM K. who md Mary Hinton...JAMES B. (no more known)...and FRANKLIN J.C., who md. Mary Weaver in Indiana.

WILLIAM K. had a son SOLOMON who was a physician in Ohio...JAMES B. had a son SAMUEL who was a physician in Kentucky...and a faird son FRANKLIN also became a physician practicing in Indiana.

WINDSOR was born in 1785 in England, md. in 1816 in Georgetown, KY it is believed, and died December 18, 1862. He md. Catherine Hinton his sister-in-law. He emigrated to Kentucky from Delaware in 1811. He and Catherine had 9 children, 1 infant dying young. His remaining children were: MARY who md. Samuel Cody (?) in Georgetown, KY...PATSY md. Samuel Hastings in Georgetown, KY...NANCY md Hawkins Fitzgerald...SOLOMON W. II md. Nancy Allen...ELIZABETH never married... GABRIELLA md. James Young...PENELOPE md. John Estill and they emigrated to Missouri...and SARAH md. Leaner Steidman.

LOT was born in 1787 in England, and he remained in Delaware until his death in February of 1862. He md. (1) Eliza Twiford...(2) Ann Brown..and (3) a widow Mrs. Mary A. James. Lot was a soldier in the War of 1812. Since we don't have the dates of his three marriages we cannot know the mothers of his 7 children. They were MARY ANN L. who md (1) in 1837 Obediah Baker; and (2) Stephen M. Morgan. WILLIAM, b. 1815, md. Susan Osborne. JOHN MORGAN md. in 1845 Leah Anderson. JAMES b. 1821, md. in 1857 (1) Sarah Hopkins, and (2) Mary Hopkins, date unknown. CHARLES A.T., Lot's 5th child md. Sabra Hall in 1849. THOMAS L. b. in 1826, md. in 1854 Sina Kinder. PHILIP HENRY, b. 1834, md. Rhoda A. WRight. He became a minister.

JAMES, the remaining child about whom we know something, was born Feb. 12,1800 in England, md. Feb. 4, 1828 in Delaware to Gabriella Jones, dtr. of Wm. Jones of Bucks Co., Pennsylvania. They had 3 daughters: SARAH ELIZABETH who md. Edward C. Barlow...CHARLES ANN who md. Urias Hambrick...and so far as we know MARY BELL who never married, at least had not been married by 1869. JAMES went to Kentucky in 1813 and obtained his medical degree from Transylvania University in Lexington, Kentucky.

Family Records in the descent from AARON RAWLINGS III (ca 1757-caJune 1810) and his wife HETTIE "T" (ca 1760-1840) (Hettie md. twice after AARON's death: (1) James Dunbar; and (2) Josiah King). This data will be a shortened version of what Steve and Carol have compiled, which is extensive for any of you who may be descended in this line. This is RAWLINGS surnamed, spelled with a "G".

AARON RAWLINGS, "whose father came from England" according to an 1870 RAWLINGS family Bible, "lived on Eastern Shore of Maryland 50 miles from Baltimore, removed to Henry Co. Kentucky at the place where New Castle is now located, where he died. His wife HETTIE died in Jefferson Co., Indiana in 1840.

Mote: Some other sources say that AARON and his family removed to Henry Co., KY not in 1788 but in 1794. He first appears in Shelby Co., KY (later Henry Co.) tax lists in 1794: ROLLINS, AARON, 1 horse, 11 cattle, Shelby Co., Plumb Creek."

He is mentioned also in the Pennsylvania Archives as being in the PA Militia in 1782; also in the "History of Washington Co. PA" by Boyd Crumrine, p.130. In the book "The 1783 Tax Lists and the 1790 Census for Washington Co., PA, AARON appears along with other RAWLIN(G)S?ROLLIN(G)S...MARY, NATHAN and DANIEL, who may or may not be related. AARON ROLLINGS Jr. and Sr. estate are listed in Cumberland Township tax records in 1784, no details given. Only one AARON ROLLINS is listed in 1792.Note that Cumberland Twp. was in 1784 part of Washington Co., but now is

LEVI RAWLINGS in Henry Co., KY Tax Lists between 1800 and 1827.

AARON RAWLINGS and Hettie, his wife, had 7 children, so far as we know.

EFFY, b. ca 1778/79, md. John Denning Jan. 7, 1796, no more known.

SOPHIA or SOPHIRA, b. ca 1780, md. Samuel Young Aug. 3, 1798.

REBECCA, b. ca 1783, md. three times (1) William Carter Feb. 24, 1804;

These three girls md. in Shelby Co., KY.

ELEAZER, b. June 9, 1786 at Fort Pitt, now Pittsburgh, PA, per family bible. He died in July of 1854 in Indiana. He md. (1) Sally Hoak/Hoke Nov. 13, 1805, and by her had 5 children: VINCENT, NANCY, EMILY, HENRY and HARVEY. After her death he md. Louisiana Eastin in Scott Co. Indiana, and by her had 4 children: MELVINA b. ca 1825 in Indiana...LEROY Feb. 5, 1829 inJeffersonville....MOSES b. ca 1837 in Jefferson Co., Indiana...and CELESTINA b, ca 1841, in Dupont,IN.

JOSIAH, b. ca 1790, not much more known except he md. Nelly Speer Mar.19,1810. MOSES MARSHALL, b. 1793 in KY; died Jan. 11, 1863 in Pulaski Co., III.

He md 3 times...(1) Sarah Jane "Sally" Seaton, Aug.6,1809... (2) Henrietta Buck Calmes in 1829...and (3) Ann H. Simms in 1840. Between his 3 wives he had 9 or 10 children, all of whom preceded him in death.
