The WILKES family of Brunswick Co., Virginia in the late 1700's married often into the RAWLINGS family of that same county. For example Joseph Wilkes Jr's daughter Julia Gillion, b. 1804, married HARTWELL RAWLINGS in 1820 in that county. They had 5 children: JULIA, MARY, JOSEPH, EDWIN and IDA. The family later moved to Fayette Co., Tennessee. HEARTWELL RAWLINGS (the name) appeared in several generations of the WILLIAM RAWLINGS line of that county.

Even earlier MINAH WILKES (b.1778), married BENJAMIN RAWLINGS Jan. 24, 1799, in Brunswick County - surety Herbert Hill; witnesses Thomas Wilkes and John Fowlkes. They were married by Rev. Aaron Brown, Methodist. Issue were:
HENRIETTA b. ca 1801, Brunswick Co.; married Gray Finch, had 7 children, moved to Fayette County, Tennessee.

FRANCES, married Edgcomb Suggett in Brunswick County, had 6 children.

ROBERT, born ca 1807; m. Mary D. Peebles in 1827 in Brunswick Co. Their children were JOSEPH W. who served in the Civil War, BASSETT, ANNE E., JAMES, ROBERT, MARY J., CHARLES, HENRY C. and GEORGIA M.

JOSEPH W. m. Martha A.G.Harris in 1837, and their children were: AMANDA JANE, HENRIETTA VIRGINIA, WILLIAM MORTIMER, ROBERT SARKIN, JOHN JOSEPH, MAY LOUISA and PHILIP HENRY.

GEORGE B., b.ca 1817, m. Nancy F. Howell, daughter of Spencer Howell, in 1837 in Brunswick County.

WILLIAM, m. Nancy C. _____, and had children: WILLIAM A., CARY, PHILLIP H., ROSA A., JANE S., JOHN, CHRISTIANA A., JOHN L., RICHARD and HORACE H.

From the Maryland Gazette newspaper, 1727-1761 (excerpts collected by Green)

Wed. July 27, 1748 #170 - A mare strayed from the plantation of William Hunt, formerly owned by AARON RAWLINGS in Anne Arundel County). Deliver to Capt. John Carpenter in Annapolis. (P.50)

Wednesday, Dec. 14, 1748 #190 - Gov. Ogle has appointed the following Justices of the Peace in Frederick County: N.Wickham Jr....Wm. Griffith...JOHN RAWLINGS...Thomas Owens... Thomas Cresap...Thomas Batty...Joseph Chaplain...Henry Munday...Thomas Prather...George Gordon...and Joseph Ogle. John Darnall is appointed Clerk of the County; John Thomas is High Sheriff, and Isaac Brook, surveyor. (P.55)

Wednesday, Dec. 28, 1748 #192 - Vachel Denton, living on the North side of Severn, has for sale the plantation belonging to William Hung, Esq., merchant in London. It is "RAWLINGS' Plantation" in Anne Arundel County between South River and Kilkenny Warehouses. (P.78)

Wednesday, Oct. 10, 1750 #285 - William Cuming, Annapolis, has land for sale in Frederick County on Senecar Creek near JUSTICE RAWLINGS' plantation. (P.78)

Thursday, June 24, 1756 #581 - Ship arrivals: Ship Severn, Capt. JEHOSEPHAT RAWLINGS from London.

Capt. JEHOSEPHAT RAWLINGS arrived in Severn River last Friday from London. He brings news of the death of the Hon. Edmund Jennings, Esq., late of this place. He died at Bath. He was a lawyer and for many years Maryland's Council of State.

(no date noted) FRANCIS RAWLINGS, living near the head of the South River, has goods for sale at Mr. Jacques Warehouse in Annapolis. They were imported in the ship Unity by Capt. Joseph Richardson.

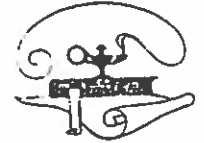


In the St. Louis Business Directory, 1860:

GEORGE SHEPARD RAWLINGS is found with Wilson, RAWLINGS & Company, a firm listed as U.S. Land Agents. GEORGE died in 1872 of meningitis.

When the children of GEORGE SHEPARD and SARAH (Pavey) RAWLINGS married, they lived in the area called Forest Park. The World's Fair of 1904 was held in Forest Park in St. Louis. As of this date Wilma has located 23 living descendants of GEORGE SHEPARD and SARAH RAWLINGS. They are the Hefferns and Neuhoffs from the marriage of SARAH LOUISE RAWLINGS, oldest daughter of GEORGE and SARAH. Samuel E. Heffern and George Neuhoff operated the Heffern-Neuhoff Jewelers for over 50 years in downtown St. Louis. Samuel died in 1951 and George died about 1960.

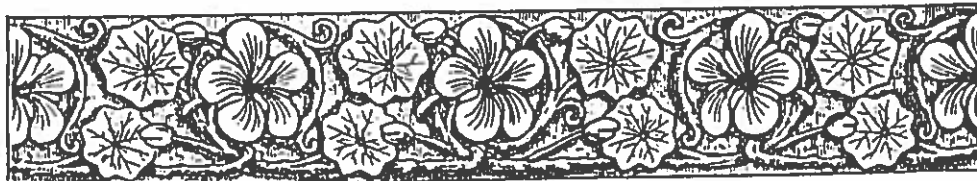
From records of Frederick County, Maryland.

In the name of God Amen, I, JOHN RAWLINS, of Frederick County, being weak and sick of body but of perfect mind and memory, thanks be to God, therefore considering the frailty of human nature, and knowing what is appointed for all, do make, constitute and ordain this my last will and testament as followeth: Principally and first of all I give and bequeath my soul to the hands of Almighty God who gave it, hoping to receive the same again at the Resurrection of Jesus Christ, and I give and bequeath my body to the earth to be buried in a Christian-like and decent manner as my Executors hereinafter named shall deem proper and as touching such worldly estate wherewith it has pleased God to oblige me. I give and advise to dispose of the same as follows: Imprimis, I give and bequeath to SOPHIA RAWLINS two negroes, the one named James and the other Mall, and also an equal part of my personal estate with my three children, JOHN, WILLIAM and ELIZABETH, except such articles as shall be hereinafter mentioned to my children. Item: I give and bequeath to my son JOHN a tract of land called "Beginning" after his mother's decease; also a negro boy named Harvey to be (placed) with him at the age of eighteen, also a mulatto named Friday during his servitude. Item: I give and bequeath to my son WILLIAM a tract of land called "Lost Hatchet", and another called "Hobson's Choice" to be possessed of both at his mother's decease, also a negro girl named Clare and a mulatto named Robinson Crusoe during his servitude. Item: I give and bequeath to my daughter of Mary Hamilton a negroe girl called Rose, also a breeding mare called Phoenix. Item: I give and bequeath to my daughter ELIZABETH one negroe boy named Pompey, also a negroe girl named Cloe, a feather bed and furniture, cows and calves, a young natural pacin mare come of Phoenix, and five pounds cash; and I do hereby nominate and appoint my beloved wife SOPHIA sole Executrix of this my Last Will and testament, and do hereby revoke and make void all former or other testaments or wills heretofore named, willed or bequeathed, ratifying and ordaining this and no other to be my last Will and testament. Signed & sealed in the presence of Alexander Reid: James Neatch and Jon. McCartland. ept.10,1756, presented to the court for probate.

Feb. 10, 1802 - Bill of sale from AARON RAWLINGS to TRUMAN RAWLINGS.

Know all men by these presents that I, AARON RAWLINGS of Frederick County and state of Maryland, for and in consideration of the sum of 250 pounds current money to me in hand paid by TRUEMAN RAWLINGS of the county and state aforementioned, the receipt whereof I do hereby acknowledge...have granted, bargained and sold, and by these presents, doth grant, bargain and sell unto the said TRUEMAN RAWLINGS, his executors, administrators and assigns, all the stock, household stuff, goods and chattles herein particularly mentioned; that is to say, one black mare 13 yrs old, 1 brown horse 5 yrs old, 1 small black mare 8 years old, 1 bay horse 4 years old, 2 yearling fillies, 2 cows, one wagon-cloth or sheet, harnesses & gears for 5 horses, 1 jack screw, 20 barrels of indian corn, 1 plough, 300-wt. of pork, 200 ft. of walnut plank, 1 clock & clock case, 1 walnut desk, 3 feather beds & clothing thereto belonging, 3 bed-heads, 5 chairs, 1 walnut chest, 1 large walnut table, 1 small walnut table, and 1 large iron pot.

(this is followed by all the legalese concerning TRUEMAN's heirs-, assigns, etc... having no impediment to this purchase...and AARON's heirs, assigns, etc...having no claim on these properties. This bill of sale was accepted for the record by the County Court.

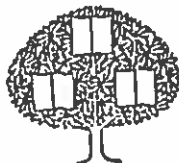

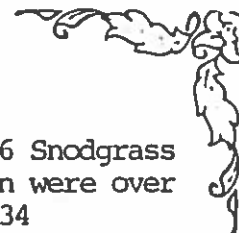
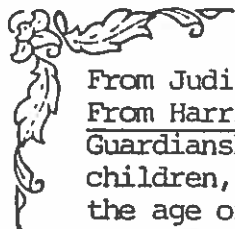

There are 10 RAWLINGS mentioned, but only a couple seem related. We will start with them, and do others in later issues.

JAMES RAWLINGS, a prominent and successful farmer of Morgan County, residing on his pleasant home farm in Section 32, Twshp. 14, Range 9, was born near Scarborough, Yorkshire, England, August 12, 1822, the son of WILLIAM and Mary (Wilson) RAWLINGS, who moved from their native land to America in 1834. WILLIAM and Mary RAWLINGS had 9 children, 5 sons and 4 daughters, part of whom came with their parents to America in 1834, the rest following in 1840. WILLIAM RAWLINGS bought land in the township where his descendants now reside, and being a man of means, first secured 500 acres to which he later added some two or three hundred acres more. He lived about 20 years in his adopted country, and his wife survived him about ten years.

JAMES RAWLINGS was the 3rd child of this family, was educated in England and assisted on his father's farm until he had reached his 24th year, when he began farming on his own account. On Feb. 26, 1848, he was married to Frances Hembrough, dtr. of John and Hannah (Turvey) Hembrough, all natives of Yorkshire, England. The Hembroughs came to America in 1839. They had a family of 12 children of whom Frances was 8th. JAMES RAWLINGS and his wife became the parents of 8 children, 5 of whom survive, 2 dying in infancy, and a daughter, Hannah T., dying after her marriage. Mr. RAWLINGS has made farming and stock-raising his life occupation, but since 1888 has left the management of his estate to his children. He has been very successful as a business man, and before dividing much of his landed property among his children, he owned 1200 acres. Mr. RAWLINGS and wife and their family belong to the Methodist Church. He served his district on the School Board.

JAMES E. RAWLINGS, whose residence is on Section 19, Twshp. 14, Range 9, is a leading farmer and stockman of Morgan County, and is the owner of 500 acres of excellent farming land. This home is surrounded by improvements of the highest character, his estate consisting of 2 farms - one of 253 acres, and the other of 240 acres. Of the latter he leases 200 acres to tenants, and carries on farming on the home place itself. He was born in Morgan County March 13, 1861, the son of JAMES and Frances (Hembrough) RAWLINGS. He has been identified with farming all his life, but lived 9 years (1895-1904) in the city of Jacksonville. On October 4, 1887, Mr. RAWLINGS was married to Serilda L. Seymour, dtr. of Robert Seymour, and they had 2 children, both of whom died in infancy. The wife and mother died December 28, 1903. Mr. RAWLINGS is a member of the Methodist Episcopal Church and of the Order of Elks, and in politics, is a Republican.
