Dear Cdusins...

Since I am not only researching my husband's RAWLINGS and RUARK line on his father's side, but also his maternal lines of Turner and McFelea, and others. This is true of all of us, of course. And I think I am correct in assuming many of you wish to photograph the grave markers of these ancestors. That means going far afield, stumbling through old established cemeteries as well as graveyards found on private land which may still or was once property of those ancestors. Some are heart-breaking to visit. Stones are missing, or perhaps the markers were of wood and no longer exist. If these places were established in the early 1800's or even throughout the 1700's, you might not have full records but family history, and that means a personal search.

In the recent editions of the National Geagraphical Society newsletter writers and researchers have submitted articles to help those who hunt gravestones or markers. First, they advise you have the official burial certificate, church record, funeral or cemetery record which will tell you where the grave is situated. Many old gravestones in traditional church or town cemeteries were made of limestone and therefore, after many decades, have been ravaged by time and weather and are impossible to read. Having the record which indicates the precise spot, you can purchase a small marker and place it next to the old gravestone with the person's name, birth date and death date. The local funeral parlor or cemetery will have them. In a private plot, if you cannot find a marker and you know the person was cremated or buried at sea, you can add "buried at sea" on the marker so that ancestor is remembered.

If one of these ancestors with a disintegrating marker was a veteran, a person with military service you may obtain markers from a local funeral parlor or local Dept. of Veterans Affairs. Ask for VA Form 40-1330 and follow the instructions. Tell them he was a veterah of the Revolutionary War, War of 1812, War Between the States or a more recent conflict. Be certain any marker is made of granite. It will last forever.




# WHAT'S IN A NAME?

Did you realize that when you are searching in England for your PAWLIN(G)S/ ROLLIN(G)S you can only go as far back 1066 AD (or CE)? That's because before that date no one had surnames. after WILLIAM THE CONOUEROR ascended to the throne of England he caused many changes, the most important for our puposes being that citizens (meaning men) must bear more than one name to indicate either relationship or where they lived. Some took their father's name and added "son" to it, like Peterson or Thomson and added that to their baptismal name. Others were given location names, usually geographical, like RIVER, STONE, FORD, LANE, TOWN, LAKE, SHORE, etc. Others were given the names of their occupations, such as FARMER, TAILOR, TURNER, TILLER, FISHER, ROPER, COOK, etc. Hair color was often used to differentiate men such as REDMAN, BROWN, WHITE, BLACK, and GREY.

There is a very interesting book I purchased in 1983 that deals with this. It's entitled "The Origin of English Surnames" by P.H.Reaney, published in the U.K. The American publisher is Routledge & Kegan, 9 Park St., Boston, Mass 02108. I bought it in Barnes & Noble, I believe.

On P. 151 of my paperback copy in a paragraph describing diminutive suffixes such as -in, -un, -or, -et we find RAWL-IN from Old French Raoul, and RADULF from old German. As we know from previous issues there were 26 Raouls who came with William the Conqueror in 1066 from Normandy, so that seems to be where we come from, too. The Old German RADULF seems to me to be the precursor of RALPH, ROLFE or RUDOLPH.



JOHN D. RAWLINGS, b. ca 1804; d. 1859; md Bettie Rector, dtr. of Thomas Rector. Children: JAMES WESLEY (who had 2 sons, at least); VIRGINIA who md John L. Carter and had 4 children; "Mit" who md Joseph Hampton, went to Indiana, had 3 children; LEE, unmarried; BRODY; and JOHN WILL, b. 1854, md Elvira Keene in 1871 in Loudoun Co., VA; had at least 2 children.



Further to information on P. 32 from the marriage records of Henry Co., KY, particularly NATHAN RAWLINGS to Priscilla/Drucilla Ray, from the research of Joan Rawlings Scott re her family:

NATHAN RAWLINGS, A Methodist Minister, was born in Maryland ca 1776. On Sept. 24, 1800 he married (what was later verified as)Drucilla Ray in Henry Co., Kentucky. He died in Lexington Twnshp, Scott Co., Indiana, July 1859. He was also a farmer. Drucilla was born ca 1778 in Virginia and probably came to Kentucky with her parents, names unknown. She was alive in 1860, living with her son AARON in Scott Co., Indiana.

Children of NATHAN and Drucilla:

JAMES, b. ca 1799 in Kentucky; md Ann Lamaster/Lemaster March 27, 1823, Marion Co., Indiana.

PAGE, b. May 31, 1825, Scott Co., IN; md (1) Rebecca Morgan; (2) Rachel Daggy. ELISHA, birthdate unknown; died April 17, 1825, Scott Co., IN; md Eliza beth Davis. RACHEL, md William Ogden March 28, 1826, Scott Co., IN. No more known.

THOMAS, md. Rebecca Wilson, Jan.14,1827. He was b. Mar.13,1807. He died 1890, Brown Co. Ind.

AARON, b. Oct. 18,1809; md Sarah Jane Sparks Mar.24,1841, Sspt.9, 1896. He was born in Henry Co., KY as were all of the above. Two out of the next four children we know were born in Indiana.

ELIZABETH, md. Wm. Doolittle Jan. 27, 1831 in Scott Co., IN. No more known. POLLY, b. ca 1811 in Indiana, no more known.

LUCY, b. Jan. 26, 1822 in Scott Co., IN; md. Feb. 13, 1840 Frederick Haymaker in Scott Co., and she died there Sept. 9, 1846.

ISAAC, b. ca 1821, Scott Co.; md Elizabeth Brazelton Aug. 5, 1849 in Jefferson Co., IN No more known.

Note: It seems that ELISHA was a gggrandfather of JOAN RAWLINGS SCOTT.


ELISHA RAWLINGS was born in Henry Co., KY, date unknown. He was married April 17, 1825 in Scott Co., IN, to Elizabeth Davis, no more known. They later moved to MARION Co., IN. The only child on record for Elizabeth and ELISHA was ELISHA PAGE RAWLINGS, B. June 11, 1829 in Scott Co. IN; md (1) Elizabeth Ann Settle in Jefferson Co., IN Sept. 5, 1850. He died April 24, 1904 in Tippecanoe Co., IND ELISHA PAGE was JOAN RAWLINGS SCOTT's great-grandfather.

ELISHA PAGE RAWLINGS was born June 11, 1829, in Scott Co., IN. He married Sept.5, 1850 (1) Elizabeth Ann Settles in Jefferson Co., IN. His 2nd marriage was to a widow, Sarah Jane Wilson.. His first wife died January 27, 1862, and by her he had WILBUR LYLE RAWLINGS and LOU BELLE RAWLINGS. He had 4 children by his 2nd wife - LILLIE MAE, ELMER, MINNIE and OTIS PAGE RAWLINGS. We are interested in his son by his first wife WILBUR LYLE RAWLINGS. He was JOAN RAWLINGS SCOTT's grandfather.

WILBUR LYLE RAWLINGS was born Jan. 12, 1858 in Charlestown, Clark Co., Ind. He md Libby Jane James June 12, 1883 in Michigan City, LaPorte Co., IN. He died of Bright's disease Feb. 28, 1934 in Michigan City. Libbie Jane was born April 3,1862 in DeKalb Co., Ill, and died Dec. 29, 1931 in Michigan City. For the first time on record we find that this Rawlings no longer was a Methodist which his ancestors before him had been. There were three generations of Methodist ministers in the family.

Libby and WILBUR had 8 children; GERTRUDE BELL who was born and died the same day...MILDRED BLANCHE, b.1886 and died in 1958 in Michigan City, LaPorte Co., IN. Whe md Webster Beachler in 1916.

WILBUR EDWIN, no further dates, but he and his family lived in Michigan City until his death. His first wife was Emma, last name unknown; his 2nd wife was Pearl, last name unknown.

LYLE VERNE, b. Dec. 19, 1892; died June 19, 1963. in Indiana
BERNICE AILEEN, b. Oct. 10, 1894; died March 17, 1980 in Michigan City, IND. She
md Walter Lindenmeyer Sept. 20, 1919 in Michigan City.

HERBERT MEISEL was b. June 11, 1898; died Nov. 20, 1863. He md Jan. 5, 1919 Bertha E. Pelke.

ESTHER ALICE, b. June 12, 1901; died Aug. 8, 1969/70. She md Herbert D. Hooks. JAMES SHERMAN, b. March 28, 1905 in Michigan City; died March 2, 1968 in Dayton, Montgomery Co., Ohio. He md Martha Agnes Studt, March 10, 1923 in Chicago, Cook Co., Ill.

#### 'SPECIAL' QUERY

I am searching for information about my great-grandfather RAWLINGS, first name unknown. He was the father of my great-grandfather SAMUEL ANDREW RAWLINGS and his wife Mary Catherine Owens RAWLINGS. SAMUEL passed away in Collin Co., TX July 31, 1931, and is buried in the Rowlett Cemetery near McKinney, TX. The mystery and reason for my search is that we have conflicting names for his father. One person says it was THOMAS RAWLINGS and his mother was Mary Worthington. However, we found him in the Warren Co., TN census of 1850 with a father named JAMES E. RAWLINGS. Can anyone solve this mystery?

Once more we'd like to help charter member Paul Gerrish in his long, long search for his ancestor MARY RAWLINGS b. April 24, 1792, place unknown, and who married Absolom Hunt July 11, 1813 in Fleming Co., KY. She died March 6, 1830. Two affidavits attesting that she was 21 years of age at her marriage makes him believe that perhaps she may have been an orphan bound to someone until aged 21. There were many Hunts in Fleming Co., KY at that time. The two affidavits were by Nancy Hendrick, and Henry Ritchie. Ritchey also was a co-signer of the marriage bond. In the county Marriage Book, Mary's surname was spelled ROWLING. Paul's Hunt ancestors migrated from Fleming County, Kentucky, to Randolph Co., Indiana, and there were a large number of them.

Absolom married again after Mary's death in Kentucky, and that is when he moved to Randolph County, Indiana. Randolph County is right next to Parke County. Back in 1987 your Editor attempted to help Paul by informing him that a family of Hunts with Old Testament names like Absolom could be found in the marvelous. research on the STEPHEN RAWLINGS line from Maryland to Indiana by Beverly Allan and Margaret Smith whofound Hunts marrying into the STEPHEN RAWLINGS family with names like AAPON and JABEZ. These Hunts also came from Kentucky to Indiana, settling in Parke County and others. STEPHEN RAWLINGS had a great-granddaughter who married JABEZ. Somewhere else I recall an ACQUILLA Hunt but at the moment I can't place where.

Paul Gerrish is of advanced years and has been looking for the parents of MARY who married Absolom Hunt in 1813 in Fleming Co., KY. Let's see if we can search our records for her. It would please him so much.

PS I just remembered that there were other Hunts with Old Testament names in Fleming Co., KY. who went on to Randolph Co., IN with other Hunts. One was MISHACK HUNT who represented ABSOLOM in the marriage paperwork...and a RUBIN/REUBEN HUNT who md. Hannah Garvic/Garvis Aug. 24th, 1813. By the way in the Fleming Co., KY record of his marriage, ABSOLOM was a Junior Hunt, meaning an ABSOLOM HUNT Sr. may also have lived in Kentucky, md. Esther Foster Mar.9,1793

In 1991 Paul sent me'a very complete dossier on all the surnames in his family whom he had traced all the way back to 1631 in England. One of them was a John Hunt who md an Elizabeth Fernandes in 1650.

JOHN WILL RAWLINGS, proprietor of RAWLINGSDALE, a fine old country estate in the Scott district of Fauquier County, near Rectortown. It has been in the family for several generations.

The RAWLINGS family was established in America in colonial times. There were three Scot brothers of the name who came to this country, all three of them serving in the Revolutionary War and two of them subsequently settling in Maryland, while the third brother came to Virginia and founded the family from which Mr. RAWLINGS of Rectortown descended.

JOHN D. RAWLINGS, father of JOHN WILL RAWLINGS (above), was born in Fauquier County and spent his life at RAWLINGSDALE. He acquired a practical education and after a career in industry died in 1859, aged fityty-five. He married Bettie Rector, dtr. of Thomas Rector of the family for whom the village of Rector was named. JOHN D. and Bettie has the following children:

JAMES WESLEY, who was a Conferate soldier and wounded five time during Pickett,s Charge at the Battle of Gettysburg. He died on his farm near Rectortown, leaving two sons, S. WILL and HARVEY S.

VIRGINIA, who married John L. Carter and died near Rectortown, leaving four children: William D., Pitt, Shelby and Mollie, who married Robert Kincheloe.

MIT (is that a name?), who married Joseph Hampton and died at Terre Haute, Indiana, leaving two sons and one daughter.

LEE, who became a United States soldier and was killed during the Boxer Rebellion in China.

BRADY, still living in Terra Haute.

JOHN WILL, the youngest in the family, was born at RAWLINGSDALE, Sept. 4, 1854, his education being in the country school, being abbreviated as the result of war times. He was five years old when his father died. When he was an adult he faced his responsibilities and managed the family affairs while his mother lived. After her death he became owner of the farm, 600 acres of prime land.

JOHN WILL married Miss Elvira Kenner at Leesburg in Loudoun County Oct. 5, 1871, dtr. of George A. and Susan (Pendleton) Kenner. (Because the page was torn at this point only two of the children of JOHN and Elvira can be accounted for, as follows:) ARTHUR A. who md Laura Pierce and they had 3 children. In "George Washington", vol.VII "First in Peace by John a. Carroll and Mary Wells Ashworth (1957 (Charles Scribner & Sons, NY) P.628 there is mention of GEORGE RAWLING; and on P. 496 ALBIN RAWLINS arriving at Mount Vernon from Hanover Courthouse, VA. P.626 notes that after Washington's death, ALBIN RAWLINS apparently stayed on at Mount Vernon until Martha Washington's death 2½ years later.

I'm returning to it because we have information further on JEREMIAH's son WILLIAM b. ca 1765 in Caroline Co., VA; died June 2, 1836 in Franklin Co., TN He md. Sarah Brame, daughter of Melchizideck Brame and Mary Chiles. They were married Nov. 27, 1788. (This WILLIAM was the RAWLINS who married Alexander Spottswood's daughter.)

Children: SAMUEL D., birthdate unknown, died Oct. 1838, Norfolk, VA. Md. Mary Epps. BETSY, b. Caroline Co., birthdate unknown, md Elisha Sims THOMAS, b. Caroline Co., VA, birthdate unknown, md. ALBIN, mentioned earlier, seems a mysteryman since the only place and time when and where he appears is in George Washington's employ. He never married and there is a will on record wr tten in 1807 in Caroline County, VA.

GEORGE RAWLINGS married and had 5 children, it is believed. Only four are mentioned in JEREMIAH; s will...HENRY, SALLY, JEREMIAH and MARTIN. There is supposed to be another, named TERRY...male or female we do not know.



Referring to P.18, June 2002 Newsletter, under Queries, the letter from JOHN S.B. RAWLINGS from England: Mr. RAWLINGS became a subscriber to our newsletter and sent a follow-up query concerning those members of his family (great-grandparents) who came to the U.S. in the mid-19th Century.

His great-grandparents were JOHN BRIGHTWELL RAWLINS and his wife Maria. They arrived in St. Louis, Missour in 1851 and eventually settled in the nearby town of Alton, along with their son EBER, his wife Ann (Skinner) and their children. JOHN visited with some members of this family's descendants in 1997. By that time most of them had settled in Provo, Utah. Two of the children of EBER and Ann have not been traced and he would like to discover where he can find them.

One is HENRY EBER RAWLINGS, born in Alton, MO in 1851; died in Salt Lake City, Utah in 1924. He married Sarah Ann McCauslin in Salt Lake City in 1872, and they had two children: CLARENCE HENRY, born Provo, Utah in 1877; died time and place unknown... and HAZEL M. RAWLINGS, also born in 1877 in Provo, Utah: death time and place unknown. It looks like they were twins.

The second child of JOHN BRIGHTWELL RAWLINS and his wife Maria who was born in the US was ZEDA EMMA, born in Alton, Missouri in 1854, death place and time unknown. She married Emil Sophus Lund in Salt Lake City in 1872, and they had four sons...CHARLES W., ARTHUR E., GEORGE S., and NELSON S. The boys' mother died in her forties so they were raised by their grandparents EBER and Ann.

MOSES RAWLINS came from Maryland as early as 1808 and took a fifteen years' lease on a part of Edward Williams' place, opposite the farm now owned by Philomene Gray. He raised 12 children, five of whom are still living. A son EZEKIEL, married twice. He settled in Scioto County and had 26 children, seven by his first wife and nineteen by his second, who survives him." (MOSES born in Md. came from Kentucky)

From Gravestone Inscriptions, Pickaway County, Ohio

ALBINA RAWLINGS, wife of EZEKIEL, died Dec. 7, 1844, aged 31 years. Butied in the cemetery on Paul Peters farm in Harrison Township.

Hambden Township. "The years 1802 and 1803 saw 8 or 9 families within the limits of Hambden. The names of these settlers are given as Shadrack Ruark, JAMES RAWLINS, Joseph Bond, James Bond Jr., Thomas Evans, Thomas Evans Jr., William Evans, Stephen Bond and Andrew Cooley. All had families except Stephen Bond. Some of these, including Ruark and RAWLINS, became dissatisfied with the locality and moved away not long after they arrived." (They eventually settled in Mentor, now in Lake County.)

From Vol. 2 "Pioneer Women of the Western Reserve 1796-1824" pp 879 & 880

"In 1803 several families arrived from the east; Shadrack Ruark...William, James and Thomas Evans...Joseph James and Stephen Bond...Andrew Cooley...and JAMES RAWLINS. Ruark, RAWLINS and Evans remained but a year, removing to some other town."

From "Pioneer Sketches" published by the Geauga County Historical Society, 1880.

"Hambden was form called Bondstown after Dr. Bond who first came in the summer of 1801. He was from Connecticut. He was once quoted as saying 'The area was little known except for the indians, and he did not see a white man once a week. He milked his cow in a bottle and baked his bread on a chip.'

In 1802 and 1803 Hambden began to be settled, and in those years some 8 or 9 families moved into the township. The names of these first settlers were Shadrack Ruark, JAMES RAWLINS, Joseph Bond, Joseph Bond Jr., Thomas Evans, Thomas Evans Jr., William Evans, Stephen Bond and Andrew Cooley. All these had families except Stephen Bond. Some of the early settlers did not like the township so very well and moved away - RAWLINS and Ruark to Mentor, and Evans to the southern part of the state, which left only five families in the township. In those days there were no roads except a girdled road which ran through the southwest corner of the township. The state built a road in 1804/05 so that people could get along with wagons."

From Van Cleaf's 1906 "History of Pickaway Co., Ohio"

- P. 153 from a list of Societies the New Holland Lodge #392 of the F. & A.M. (?) among the first officers elected, MOSES VANCE RAWLINGS W.M. (This is the son of SAMUEL RAWLINGS, and grandson of MOSES (1740-1787).
- P.224 Enlistees in Company H of the 30th Ohio Infantry, mustered into service in Pickaway County, August 29, 1861. Private DANIEL RAWLINS.

Mr. RAWLINGS commenced the study of the printing business here in 1832 in the office of the 'People's Paladium' under A. Crichfield. We are informed that the county up to 1836 had been Democratic, but that year, by the assertion of many truths and some lies, the Whigs elected the entire county ticket. We have not found a copy of the 'Hornet' but wish we could obtain one. It was, no doubt, a spicy political sheet."
