CANN HALL, MILL STREET, and property of the Canne family in Mill Street and elsewhere.

FILE [no title] - ref. 796/36 - date: 25 Oct. 1757

[from Scope and Content] 2. Nathaniel Rhodes of Bridgnorth gent. Cons: rents and covenants.

[from Scope and Content] Demise of a messuage called Canhall, stables, garden, grove and land (lately Mrs. Sarah Whitmore widow), and all buildings now or hereafter to be erected, commons etc. reserving trees in the grove with liberty to fell, to hold from 5 July last for term of 21 years. Rent £15. Covenant for reentry if rent unpaid 21 days or if Rhodes assign except to wife or children without licence in writing. Covenant to pay rent, all taxes and rates. Covenant that at his own cost within 3 months Rhodes will build on part of the premises with good stone and brick 2 pieces of building for a manufacture to be by him set up, one in length 77 ft and 161/2 ft wide, the other 62 ft in length and 14 ft wide; and also one other building 6' square, all to be roofed with good and substantial oak sawen timber and coverd with good and well burnt tyle; convenant to keep all the premises in good repair and give up quietly at the end of the term, except the necessary utensils made use of in the said buildings relating to the manufacture, which, though they may be fixed to the buildings to be erected, may be removed and converted to Rhodes own use provided that any damage done to the buildings by this removal is repaired and any building materials of wood, brick and stone used in putting them up, is left. Whitmore to have the right to view and give notice of repairs needed. Whitmore covenants to give Rhodes £100 towards building the manufacture. Covenant for quite possession.

THE BYLBTTS AND THE CORNER HOUSE. ST JOHN'S :THE LION, BRIDGE ST

FILE [no title] - ref. 796/93-4 - date: 2 and 3 April 1762

[from Scope and Content] Lease and release of a parcel arable meadow or pasture late in 2 parts divided above the bridge in the parish of St. Mary Magdalene (late Nathaniel Rhodes, now John Goolden) adjoining the river (W), sometime known as the Bylett or Gravelly Bylett above the Bridge. To be held of the chief lord etc. Covenant that the title is good, for quiet possession, warranty, further assurance (within 5 miles). Any fine or recovery already levied or suffered on the land to enure to use of Richard Colley his heirs and assigns.

FILE [no title] - ref. 796/95-6 - date: 24 and 25 March, 1768

[from Scope and Content] Lease and release of messuage (formerly Thomas Ryder, since Nathaniel Rhodes, now Francis Bembow) and malthouse or rooms, stable, buildings, backside and garden, on the west side of Mill Street in the Lower Town of Bridgnorth; and another messuage (formerly - Wheelwright, afterwards John Nicholls, now Francis Oakes) also in Mill street adj. the first mentioned messuage; a parcel of land lately divided into 2, above the bridge in the parish of St. Mary Magdalen (Formerly Nathaniel Rhodes, afterwards John Goolden now Francis Bembow) sometimes known as the Bylett or Gravelly Bylett above the bridge; 2 parcels land lately converted into and now used as a garden called St. Johns in the Low Town (William Cureton), by estimation 2 a 3 r, upon part of which garden lately stood erected a capital messuage (formerly Lancelott Taylor gent. decd. afterwards of Richard Cresswell esq. since taken down by the said Richard Colley); 2 pews at the bottom of the lower end of the parish church of St. Mary Magdalen near the south door having the wall of the church (S- and W), the font (N) and the passage or cross isle of the church (E), now untenanted.

FILE [no title] - ref. 796/98 - date: 3 Nov. 1775


Magdalen in Bridgnorth (- Fox schoolmaster) adjoining E. to the cross isle of the church and west to the wall, north to the font and south to another seat of Joseph Sparkes; another pew in the said church adj. E to the cross isle, W to the wall, N to a pew belonging to a house late in occupation of Captain Plaistow decd., now of - Taylor spinster, S. to the font; 3rd pew (Martha Pugh) in same church adj. E. to the cross isle, W to the wall, S to the said pew in occupation of - Taylor, N to a pew late in occupation of John Head and now belonging to the parishioners for a pew now divided into 2 seats in the same church (John Corser victualler, Benjamin Paget mason, and John Rhodes joiner) adj. S. to the great Isle of the church, N. to a pew in occupation of Mr. Joseph Boulton, E. to the seats appropriated for the use of the Common Burgesses' wives of the parish, W. to 2 seats in occupation of Mr. Bonham Caldwall and Mr. Thomas Corbet baker.

MESSUAGE (2 TENEMENTS) IN MILL STREET. WEST SIDE Next to "the Five Partriges"

FILE [no title] - ref. 796/127-128 - date: 2 and 3 February 1748/9

[from Scope and Content] Lease and release of messuage (formerly Thomas Rider, now Nathanial Rhodes) with malthouse or rooms, stable, outbuildings, backside and garden on the West side of Mill Street with the street (E), Severn (W) house formerly in possession of Jane Maddox widow (N), messuage formerly Mr. Richard Colley senior (S); as purchase by Richard Colley the elder decd., grandfather of Richard

Colley party from Humphry Grenowes and as given in his will to his son John father of Richard. John settled them on his marriage [...] and another messuage in the parish of St. Mary Magdalen in Bridgnorth (formerly - Wheelwright widow, now John Nicholls; a malthouse (formerly William Colley decd. uncle of Richard Colley party, now John Nicholls); which were given by William Colley's will to his nephew Richard: to the use of (1) as to the messuage settled 7 Oct. 1721, to use of Martha wife of William Yate for life, after to use of Rd. Colley and heirs until the marriage, after to use of Richard Colley and assigns for life, Elizabeth and assigns for life, and heirs of Elizabeth by Richard, or Richard his heirs and assigns.
