THEY ARE ALL GOOD MEN.

The Greenville News Pays Compliments to U. S. Court Officials.

The Greenville News printed the following about officers of the United States Court from Charleston:

This Court is the first time that the present clerk, Richard W. Hutson, has served in his capacity in Greenville. He succeeds his father, Col C. J. Hutson, whose death occurred several months ago. Mr Hutson is thoroughly familiar with the duties of his position and dispatches business with accuracy and rapidity. He is well liked by the older officials of the Court.

One of the most familiar figures of the corps of Court officials is absent—Col J. E. Hagood. For years and years Col Hagood has visited Greenville in his official capacity and the Court does not seem complete without him. It will be remembered, however, that because of his declining health Col Hagood resigned his position several months ago. He is succeeded by Cornelius Murphy, his former chief clerk, who will arrive in the city Thursday.

The present Court is the first held in Greenville since J. D. Adams has been appointed United States marshal. His successor is George I. Cunningham, deceased. Mr Adams is well known in Greenville, having been located here for several months as deputy collector of internal revenue previous to receiving his present appointment. Those who are in a position to know say that Mr Adams is making an excellent record as marshal. He ably assisted in the duties of his office by chief clerk, Dr V. P. Clayton.

POISONED BY PREPARED FLOUR.

Pensacola, Fla., April 23.—Roland L. Morgan, of Egin, Ill., died suddenly on Monday afternoon at his country home, six miles from this city. He received a package of prepared flour by mail and within fifteen minutes after eating was dead. His mother and wife miraculously escaped death, though they only tasted the contents of the package. The flour was in an original package, wrapped in white paper. The postmark is too indistinct to give the officers any clue as to the place from which it was mailed.

Good News from the Telephone. - The Re-
 pairs nearly completed. - The table of
 the Bell will be heard by Monday.

A short talk with Mr John M. Fogel, man-
 ager of the Telephone Company, brought out
 the encouraging news that by Monday all of
 the phones would be in working order except
 those that were in very remote sections of the
 city and suburbs. Mr Fogel said that all the
 telephones south of Calhoun street and west
 of East Bay were again in working order and
 that with this was the case of East Bay south
 of Market street. All the telephones on the
 wharves have also been put in working order.

The phones above Market street and on the
 water front above Calhoun street will shortly
 be all right. These crews of men, making in
 all a total of twenty-five, are at work on the
 wires and poles. District Foreman Owsen, of
 Atlanta, with his gang is working on East
 Bay and Middle street, and commenced yester-
 day to string the wires. By Monday all the
 up-town wires will be up. The work has been
 very extensive and the company found that
 their losses were twice as heavy as they at
 first reckoned. Next week the Charleston
 folks will hear the merry tinkle of the tele-
 phone, and the halo girth at the central office
 will be busier than ever.
