I was able to get this will of Thomas George from the Lichfield Record Office. This appears to be the will that Ruth saw when she was in England. Nathaniel Rhodes was a witness but there is no mention of his being a son in law. I believe that this reference to Nathaniel as son in law was in something else pertaining to this will that was not sent to me. It could be that the settlement of the estate after his death contains this reference.

I was able to find in the records on the internet four daughters of Thomas George and his wife Mary. Three of these, Anne, Prudence and Hannah, are mentioned in his will. Another daughter Susannah is not mentioned in the will.

to receive Pardon for all my Sins and to Enjoy it Everlasting Life and
my Body I Commit to the Earth to be decently Buried at the Discretion
of my Executors hereafter named And as for such Temporal
Estate as God hath been pleased to Bless me with my funeral
and Just debts being first fully discharged and paid I thus
Disposeth of It I give devise and bequeath unto my Daughter
Anne Smith widow the Sum of One Shilling to be paid her within Six Months
after my decease I Give devise and bequeath unto my Daughter
Prudence Late Prudence Smith widow the Sum of One Shilling to be
paid her within Six Months after my decease I Give all the Rest and
Residue of my Goods (both Chitties and other my personal Estate
whatsoever and wheresoever I give devise and bequeath unto
my Daughter Hannah Williams wife of William Williams to be
enjoyed and disposed of by my said Daughter Hannah Williams
for her own use and benefit And the same nor any part
thereof shall be Subject to the Debts (without or Disposal
of the said William Williams And I do hereby constitute and
appoint my said Daughter Hannah Williams Sole Executor
of this my Last will and Testament and do hereby revoke and
Annul all other wills or wills by me at any time heretofore made
and declare this only to be my Last will and Testament In witness
whereof I have hereunto set my hand and Seal this fiftenth
Day of January in the year of our Lord one Thousand Seven
Hundred and forty One.
