- 5 - I give and bequeath to the Newton Cemetery Association, the sum of Two Hundred Dollars, in trust, to invest the same and to keep the same invested and apply the interest thereof to the upkeep of my plot in said Cemetery.
- 6 - I give and bequeath the use and income and interest of all the rest and residue of my estate, both real and personal, to my wife, Cora Shimer Shay, during the term of her natural life and at her death, to my children, Henry D. Shay and Emma W. Shay, absolutely, in equal proportions, share and share alike.

I hereby appoint my wife, Cora Shimer Shay and my sister-in-law, Fannie E.S. Rundle to be the Executrices and Trustees of this my last will and Testament.
