

STANYARNE

THOMAS STANYARNE arrived at Charles Town, South Carolina from Barbados in May 1675 with his wife, MARY (~~thought to be a Fitch~~ ^{dau. of Phoebe Bagnes & Abraham Waight of Barbados}) and their children; his will (Ordinary Court Records Book 1672-1692, pp. 44-45, S. C. Hist. Commission) was proved 14 Feb. 1683; their children:

5. MARY STANYARNE (1667-8 Dec. 1707) m. before her father made his 5 May 1682 will in which he called her "my daughter Mary Ladson" to JOHN LADSON who arrived in S. C. from Barbados "in the Barq Plantacon for Carolina, Aser Sharpe, Com-mander, 13 Aug. 1679" (Register's Records, Col. Bk. 1675-1696, Columbia), a member of S.C. Assembly from Berkeley in 1683, member of Council 1691-1698, a Quaker, died on John's Is. intestate in 1698.

JONATHAN FITCH; arrived S. C. 1678 with wife, ELIZABETH, ^{thought to be a Stanyarne;} he died prior to 29 Oct. 1691; had 1,110 acres on Ashley River inherited by his son Jonathan who left it to his nephew James Stanyarne. Children of JONATHAN & JANE BETH FITCH:

FITCH

1. Jonathan Fitch, Jr., Supervisor for building St. Andrew's Parish Church 1706 with Thomas Rose; will dated 4 Nov. 1715, married Susannah and left 3 sons: Jonathan, Joseph and Tobias, all of whom married and left descendants; however, the male line is extinct.
2. Rachel Fitch m. James Stanyarne. (see above)
3. SARAH FITCH m. JOHN NORTON, son of George Norton of Barbados whose will was dated 3 May 1665. St. Michael's Parish, mentioning a brother, John Norton of Killingsworth, Warwickshire, Eng.; John Norton arrived S. C. 1670 and was involved in the first recorded lawsuit; he was under 21 in 1665, made his will 30 Sept. 1705.

Children of JOHN NORTON and his wife, SARAH FITCH:

1. William Norton, died intestate.
2. John Norton, in 1724 deeded lands inherited from his deceased mother, Sarah Fitch Norton, under 1705 will of his father, to his brother, George Norton; died Nov. 1732.
3. George Norton m. 27 Oct. 1720 Elizabeth Connaway; their dau., Sarah Norton, m. 7 July 1746 Samuel Ladsen, Jr.; their son, George Norton, was born 11 Feb. 1726.
4. JONATHAN NORTON (14 July 1705-28 April 1774), planter of 596-acre plantation on St. Helena's Island; Vestryman of St. Helena's Parish 8 April 1751, Overseer of the Poor for St. Helena's Parish 25 Apr. 1762; married 16 May 1732 MARY ANN CHAPLIN (22 July 1716-10 Jan. 1764, dau. of John Chaplin and his wife, Phoebe Ladsen. Jonathan & Mary Ann Norton in 1756 deeded two (2) acres of 960 acres granted to his father, John Norton, on St. Helena's Is. for a Chapel of Ease for St. Helena's Parish. Jonathan Norton made his will 14 Apr. 1774; issue.
5. Dorothy Norton m. John Cowen who was buried at St. Helena's 5 July 1752; their dau., Sarah Cowen m. (1) 27 Jan. 1728 William Hazzard (1709+9 Aug 1741, son of Col. Wm + Sarah Hazzard); m. (2) 9 Dec. 1742 John Cattle (f. 27 Dec. 1749)
6. Jane Norton m. (1) Thomas Haydon (will 23 Feb. 1730, proved 29 March 1730 (Will Bk. 1729-1731, CPG, p. 374) names son John Haydon, dau. Hannah Haydon; Executors: wife and brother-in-law Jonathan Norton); m. (2) Thomas Goreing.
7. Sarah Norton (buried 16 Jan. 1739) m. Randolph Evans; son: John Evans m. 30 Apr. 1741 Elizabeth Chaplin, dau. of John Chaplin and wife Phoebe Ladsen, their issue included: John Evans, born 24 Jan. 1748, married by Rev. Evans 27 Nov. 1766 Sarah Fripp, dau. of John Fripp, and their daughter, Elizabeth Evans, born 16 Sept. 1767 was married by Rev. Wm. Graham 4 July 1782 to Joseph Jenkins of Edisto (buried Oct. 1827), a son John Evans was born 23 Aug. 1768.

JOHN CHAPLIN arrived in South Carolina in April 1672; on 25 Jan. 1678 he and his wife, Ann, were granted 140 acres "on ye North side of St. Anne's river"; son, John Chaplin, was born 1682, died 5 Jan. 1752 (SCHM Vol. 23, p. 49) m. Phoebe Ladsen.

2. Phoebe Chaplin, born 25 Jan. 1718, bapt. 31 May 1735, m. 31 May 1735 Joseph Jenkins, bachelor; their dau. Sarah m. Ralph Bailey and their dau., Mary Elizabeth Bailey m. (1) William M. Clark and (2) John Hanahan (they were grandparents of Joseph Seabrook Hanahan, father of John Hanahan b. 21 Jan. 1897, m. 27 Oct. 1921 Hardin Davant b. 12 Jan. 1904.)
3. Martha Chaplin, born 3 Apr. 1720, bapt. 31 Oct. 1737, m. 31 Oct. 1737 John Barnwell, bachelor, son of Col. John & Anne (Berners) Barnwell, born 8 March 1711 on Port Royal Is., S.C.
4. Elizabeth Chaplin, bapt. 6 July 1741, m. 30 Apr. 1741 John Evans (buried 5 Jan. 1768), son of Randolph Evans and his wife, Sarah Norton, sister of Jonathan Norton. Issue.
5. William Chaplin, bapt. 6 July 1741, m. 30 Apr. 1741 Sarah Saxby, widow of James Reynolds of Pen Pen; William Chaplin was elected Church Warden of St. Helena's Parish 16 Apr. 1770.
6. Sarah Chaplin m. 1 Oct. 1751 by Rev. Peasley to William Field, born 22 Apr. 1729, son of John and Mary Field of St. Bartholomew's Parish; his will was dated 14 Jan. 1767.
7. Benjamin Chaplin m. 1 Oct. 1751 Sarah Ladsen; she died 1 Feb. 1755
8. John Chaplin m. 2 Nov. 1758 Elizabeth Perry, widow of B. Ladsen.
