INTRODUCTION



THE SCARCITY OF MARRIAGE RECORDS for South Carolina has been a real stumblingblock for genealogists. The current marriage license law did not go into effect until 1911. Marriage records prior to that year are difficult to locate. In the colonial period marriages could be performed by license, issued by the Ordinary of the Province, or by the publication of banns in the parish church. This system worked fairly well for the coastal parishes of South Carolina. Unfortunately, there was no systematic procedure for recording the licenses issued. For consistent documentation we must rely on the seven extant parish registers. The percentage of those extant is not great, considering that there were twenty-one parishes in South Carolina in the colonial period. Marriage bonds were also issued, but only two volumes of these have been found. One solitary record of marriage licenses issued is extant, and although it is very spotty it is included here.

For areas other than coastal South Carolina marriage records are practically non-existent. People in these areas were likely married by the local minister or a minor official. However, records of churches other than the Church of England have been located in a few instances, along with some ministers' journals. Marriage settlements, pre-marital or occasionally post-marital agreements, do exist from a very early date, but for the period before 1800 they are largely for the coastal area of South Carolina. Before an act was passed specifically requiring the recording of marriage settlements in a separate series, such records are found in the Miscellaneous Records of South Carolina. The scant sources we have for marriages in upper South Carolina consist of a few legal records in the counties and a small number of church records.

Newspapers have not been used for this compilation, as marriage notices recorded there are largely published and easily accessible. Marriage references found in deeds, wills, or court cases have not been included either. The records included here are those which indicate at least an approximate date or definite time period. For some marriages more than one record is extant, as in the case of a marriage settlement and a church record. The researcher should not be confused by conflicting dates, remembering that settlements were pre- or post-marital agreements.

The Church of England was *supposed* to record marriages as well as other vital data for all residents of the parish, whether they were members of that faith or not. While this was not done consistently, it was done often enough to make note of here. Also,
