Dear Friends:

Re: Wiggins Family

As some of you know, I made a trip up to Georgia and South Carolina in April, searching for records of the Wiggins, Alexander, Lisenby, Barwick, Stokes, Tiller, Phillips and other ancestral families. I found a good bit of information, but, though I spent two weeks on the trip, had not time enough to complete the search. In fact I never got to North Carolina, or to Kershaw County, South Carolina, from whence the Lisenbys came. Since my return I have been able to look at some of the census records at the State Department of Archives, Montgomery, Ala.

I enclose to each of you a copy of such notes as I made that I think will be of interest to you. I excuse myself for the delay on the ground that we have had a lot of visitors this season and it has been difficult to get down to any lengthy period of work. I have not met Mr. William T. Wiggins, but I have heard my grandmother Marilda Wiggins Alexander, the daughter of Joshua, and Garrett's first cousin, as well as a sister of Emmeline, William's mother, speak of him, as also I have heard my mother Mallie and my Uncle Coleman Alexander. I am sending Mr. William a copy with the thought it may refresh his recollection as to some matters.

One thing is clear - Daniel was the son of Mary. I have an idea Mary was the daughter of Edward Woodham, who died in 1820, because before his death Edward gave property to Mary Wiggins, her son Daniel and her daughter (in law) Susannah. Daniel was Edward's executor. Susannah, Daniel's wife, as per deeds, etc., was a Truitt I am satisfied, as that appeared in his family bible, handed down by his daughter Nancy Wiggins Barwick to her daughter and my grandmother, Susan Barwick Lisenby. There were lots of Truitts in the same neighborhood with the Wiggins, Woodhams, Barwicks, Alexanders, Tillers, Whiddons, Huggins, Stokes, etc. in the adjoining counties of Sumter, Darlington and Kershaw, S. C.

I am also convinced that Daniel came from the Neuse River Community of North Carolina. It appears the Woodham and Barwicks did, from either Dobbs (now Johnston), Lenoir or New Hanover County, North Carolina, when they settled in South Carolina about the time Daniel Wiggins did.

Deed Book 2 - page 193 of Sumter County, South Carolina by Deed dated 10 Aug. 1820, Edward Woodham made a gift to "Mary Wiggins, her son Daniel and Susanna Wiggins, her daughter, of "the plantation on which I now live, 12 being land I purchased from Richard Horn on 6 May, 1807" to Mary Wiggins for her natural life, and also a negro named Jacob for her life, and after her death to Daniel and Susanna Wiggins, their heirs and assigns. The plantation I left to their mother Mary. - Also by Deed of Gift recorded in Conveyance Book 2, page 427, under the same date, conveyed to the same parties 13 head of cattle, 17 hogs, mare named Fly and colt named Darby. Witnessed by Nathaniel Banks.

About the same date, Book 2, page 427, Mary Wiggins conveyed to Daniel Wiggins for \$200.00 a tract of 58 acres.

Book 2, page 594 under date of 3 Sept 1822, Daniel Wiggins, Levicy Wiggins (probably Levicy Caton, born Woodham, who later married one of the Wiggins), and Susanna Wiggins conveyed 187 acres to Susannah Woodward and Ann Woodward. Deed signed by Daniel and Levicy, but mark made by Susanna Wiggins.

In Derlington County, Deed Book G, page 24, under date of 28 Jan. 1817, Polly Wiggins and Daniel Wiggins conveyed property to Aris Woodham (the son of Edward Woodham). Signed by Daniel Wiggins, mark made by Polly Wiggins. Witnessed by Athanasius Woodham (Aris' son, and the father of that John Woodham who later married Stephen Wiggins, the son of Daniel), and Kinchon Cooley.

Sumter Co., SC, Will Book A, page 232 (Will itself and related papers in Bundle 100, package 5), will of Edward Woodham, dated 18 August 1820, named a negro named Kate to Mary Wiggins for life, negro to daughter Polly Alexander, negro to wife for life, daughter Levicy Caton negro for life, after negroes left to wife has two children one to go to grandson Athanasius Woodham. Will witnessed by Susanna Woodward and Abijah Wiggins (Daniel's son). Sole Executors Daniel Wiggins and Ann Woodward. Daniel and Ann resigned as Executors and John Alexander appointed Administrator with the Will annexed. He the father of James Alexander, my great-grandfather. Bond of Administrator in the sum of \$10,000.00

Estate of Mary Wiggins (Daniel's mother), Sumter County, SC, Bundle 95, package 6 - Ann Woodward Administrator. Bond as such in sum of \$15,000.00 filed by Ann Woodward, Andrew Caton and John Jackson. Appraisers Thomas Woodward, William Alexander, John Crosswell and Edward Barnett. In the course of administration realization made to sell perishable property and representation made that "part of the heirs live in the Western States". Sale held on 18th Nov. 1820. At sale Daniel purchased - according to administrators return - 1 pot rack for \$1.31 1/2, 1 case knives and forks for \$2.18-3/4, 2 bottles 25 cents, 1 shovel and tongs \$1.03, 1 feather bed for \$2.75.

P. 275 - Walter Dortch, David I Dortch and John I. Long, Bond dated 12 Jan. 1846 for \$2,000.00 covering Walter's liability as Administrator of John Dortch, deceased.

P. 311, Andrew J. Young and Wm. B. Harmon \$1,000 bond for Andrew as guardian of the person and property of Harilda Dortch, minor orphan child of John Dortch (she married Willis)

From "Piney Woods Echoes" - A History of Dale and Coffee Counties, Ala.

Old Richmond, first seat of Henry County, Alabama (Present seat Abbeville); was located at Wiggins Springs, now Wiggins Church (formerly Gawthon's Camps).

Dale County, Ala., (present seat Ozark), created by act of 12-22-24, from Barbour, Covington, Henry and Pike. Line went about a mile East of Old Richmond, but Dale Court continued in old County seat until about 12-8-30. Act directed sale of "Old Court House and Jail." This bought by Daniel Wiggins, reputed to have lived and died in it. But later evidence indicates he lived and died near Cureton's Bridge Community, near his son Abija and his daughter Nancy Wiggins Barwick.

Indian War of 1836-37, Stephen and Israel served in it. (p. 11-13)

Coffee County formed in 1841. (p. 17)

Early settlers in the Sylvan Grove Community (near Wiggins Church, and the earliest settlement in the county), included Benjamin Wiggins. (p. 52).

Amos Wiggins one of the Commissioners named to select the first seat of Coffee County, Alabama, in 1841. (p. 82)

at Ocala, Georgia - April 7, 1954.

Office of Clerk of Superior Court - Deed Records.

George W. Wiggins, Deed to Phillip Brown, dated 12-1-1835, of property in Dist. 1, No. 182, recorded Oct 16, 1837 - Deed Book 3, page 35.

George W. Wiggins, from George Wilcox, same property, Deed Book 3, pages 33 and 34, dated 9-23-1835, 490 acres, 1st Dist Irwin, Lot 182.

(Remember at one time Irwin County comprised about lower 1/3 of state.)

From Grant Book in office of Clerk of Superior Ordinary Court, at Ocala, Georgia, - the only such Grant Book I have been able to find in any Ordinary's office in Georgia. Data taken on April 7, 1954.  
(I give here only the data interesting to the Wiggins and Barwicks)

Pub. works every county records for South Carolina Historical Commission were not too careful about spelling - her name variations in old days. Was this Martha really Bartch - remember John and David Goble were in Washington County, Georgia in 1820 and 1830, and John's daughter Martha married John Goble, son of Daniel Goble like was John and David. "So Goble's have their land" and have sold out and gone to Georgia.)

Goble, James - will of 3 April 1810 in Laurens County, recorded in Book 2, page 31 (Summers, package 13), given October 2, 1890.

Goble, James - (called himself James Millinay, otherwise called James Goble), same county, Book 2, page 288, Subst 129, package 5 - everything to wife Martha.

Wiggins, James - recorded will - date 3 March 1829, property to wife for life and thereafter to daughters Elizabeth and Susan H.

Wiggins, Stephen - Northern County, Book 4, page 133, will recorded 13 Dec. 1836, will dated 26 Dec. 1825. Wife Bechy, daughters, Susan and Jeremiah Wiggins and wing Jane Adams.

Wiggins, Lewis, Marion County, will Book 1, page 66, recorded August 25, 1809, dated 10 July 1809. Wife Charity, sons Jesse, Lewis and Isaac.

Wiggins, Jesse, Marion County, will Book 1, page 191, will dated 16 Nov. 1820, recorded June 9, 1829. Wife Mary and her six children - Thomas, Jesse, John, Mary Jane and Sarah.

Wiggins, Robert, Marion County, will Book 1, page 190, dated 1 April 1829 - sons Mike D, Samuel F and John H, and daughter Sarah Lester and Mary A. Wiggins. Last land to son JOHN - "land where Theophilus Wiggins shot the buck."

299th separate household. Name on list preceded by censuses of  
Byrd - Cassady - Colman families and followed immediately by that  
of stills - Gerentine - Smith - Punnels - Willard and Boen families.  
On following day, 26 Sept. 1850, census taken of Abigail's son -  
law - Redden Barwick, who listed 310-323. He born in SC, age 41.  
This confirms what Gaylord Huroby, son of Elroy Wiggins, caught  
of Joshua, told me recently that Daniel lived about a mile west  
and about a mile east of Wiggins Cemetery, in a mile or so east  
of Guroton's bridge community. If he had then lived near Wiggins  
Church, some 18 miles north of Redden Barwick on a straight line  
the census taker couldn't have gotten one on one day and the  
other on the next. Furthermore, shortly afterwards, on and he  
was taken the census, at Center Church, Henry County, of James  
Alexander, he the son of Abner and grandson of John Alexander  
who became administrator of the estate of Edward Woodham upon  
the resignation of Daniel Wiggins and Ann Woodard as executors  
- all in Sumter Co., SC in 1820. Records show Daniel at that  
time owned land in that spot - a mile north his son Joshua -  
a mile farther north his son in law Redden Barwick, and a mile  
farther north-east his son Abigail. The latter had sold his  
original place to Redden Barwick on purchasing from Athanasius  
Woodham (father of Jane who married Lisenby and afterwards  
Stephen Wiggins, and grandson of Edward Woodham), when Athanasius  
Athanasius, then about 50 and grieving the death of his wife  
married in 1846 the 19 year old Nancy Spear and moved over to  
Dale County, just north of Echo, where his son Arius resided.  
question, was this Nancy Spear the daughter of Daniel Wiggins  
second wife, Ann Spear.
